MEMORANDUM FOR THE RECORD

SUBJECT: Comments on House Select Committee on Assassinations
Letter Dated 15 December 1977 (U)

(C) Subject letter cites various instances which the House Select Committee on Assassinations Chief Counsel and Director, G. Robert Blakey, considers as unreasonable delays in responding to Select Committee requests. These items and our comments follow:

ITEM: Notes of 30 November 1977 review of 1967 IG Report were not received by the Select Committee until 7 December 1977.

- Comment:
- A. No written request from the Select Committee received.
 - B. 30 November 1977 notes were reviewed by OS on 5 December 1977. Delay of 1 and 2 December 1977 due to OS/Snepp Task Force commitment. IG and DDO also reviewed notes.
 - C. Notes sent 6 December by regular courier and should have been delivered to Select Committee on 7 December.
 - D. Elapsed time: 5 working days.

ITEM: Tabs B and C of file on Roselli, of which Tab A was reviewed on 3 November 1977, still not available.

- Comment:
- A. Tab A (OS file) reviewed on 3 November.
 - B. Formal tasking for review (OLC, OIG, PA, SA/DO/O, OGC) - 21 November 1977.
 - C. Tab B (DDO file) sanitized for review - 13 December 1977.
 - D. Tab C (OGC, OLC, IG, PA file) sanitized for review - 22, 28 November 1977.
