WAS A GENTLEMAN 43 UNCLAS

WIKING THAT ALL THE FACTS AS REPORTED BY RAY WERE FULLY CORROBORATED.

ON THE BASIS OF THE INFORMATION GIVEN BY RAY, WICK DROVE THE

CONCLUSION THAT AT LEAST ONE IF NOT SEVERAL OF THE SIXTY SEVEN

...A CONSPIRACY TO ABUSE VISA.

...LEAVING FROM THE MICHIGAN STATE ... RAY WANTED TO

LEAVE THE UNITED STATES AND GO TO A COUNTRY WHICH BY ANY TREATY

TO RETURN CRIMINALS TO THE UNITED STATES. RAY THAT RAY HAD TO HAVE

MONEY, DOCUMENTS, AND A FOREIGN PASSPORT. IN AUGUST 1967 SIXTY-SEVEN

SIXTY-SEVEN RAY MANAGED TO MAKE HIS WAY TO CANADA, FROM WHENCE HE

INTENDED GOING ON TO ANOTHER COUNTRY.

RAY WENT ABOUT THE PORT EMPLOYMENT OFFICE IN MONTREAL, BUT

CONTINUALLY GOT THE REPLY: "THERE IS NO WORK." HE DEARLED SAILORS

WHO WERE A BIT TIGHT IN THE HOPE OF STEALING DOCUMENTS FROM THEM.

IN THE BACKSIDE "NEPTUNE" TAVERN HE TOLD HIS SOCIAL COMPANIONS THAT

IT IS SLIGHTLY UNPLEASANT FOR ME IN THE UNITED STATES: I HAVE TO

LEAVE WORK AND GET DOCUMENTS, AND FOR THAT I COULD DO ANY WORK WHERE

NO CRIMINALS ARE INVOLVED."

RAY HAD TAKEN A TRIP TO ALBANY, NEW YORK, IN 1962
IN WHICH, DURING THAT TRIP, HE HAD MET RAY. RAY HAD TOLD HIM

THAT, IN RETURN FOR MONEY AND DOCUMENTS, RAY WOULD "HELP IN

MAKING A REPLY IN WHICH

CARRYING OUT CERTAIN PLANS."

RAY HAD THE FOLLOWING CONDITIONS: SEVERAL DAYS LATER RAY WOULD
GO TO WINDSOR IN CANADA TO MEET RAOUL AND TAKE SEVERAL PACKAGES
OVER TO DETROIT (IN THE UNITED STATES); FROM DETROIT RAY WOULD GET
OFF FOR BIRMINGHAM (ALABAMA) AND THERE AWAIT FURTHER INSTRUCTIONS
FROM RAOUL.

RAOUL PROMISED RAY THAT AFTER SEVERAL WEEKS OR MONTHS OF
"ACTIVE ACTIVITIES" HE WOULD PAY HIM 10,000 DOLLARS.
RAY HAD A PASSPORT AND OTHER DOCUMENTS, AND HAD BEEN TO MEET

IN THE CITY OF NEW ORLEANS, LOUISIANA, DURING THE MONTH OF MAY, 1964.

"I WAS PLACED UNDER TO BEHOLD TO THE CHIEF OF POLICE," RAY SAID.

"I WAS IN NEW ORLEANS. I COULD NOT GET BACK TO MY HOME IN MISSISSIPPI. I

COULD NOT GET OUT ON ANY SHIP, I COULD NOT GET HOLD OF ANY DOCUMENTS,

AND SO THAT IS WHY I SAID TO RAY: 'O.K., I'LL MEET YOU IN MOBILE, ALA.'

FOR TAKING THE CONTRABAND PACKAGES OVER TO DETROIT, RAY GOT
SEVEN HUNDRED AND FIFTY DOLLARS FROM RAY AND THE TELEPHONE

NUMBER OF A SECRET ADDRESS IN NEW ORLEANS. SUBSEQUENTLY, RAY SET

OUT FOR BIRMINGHAM.

AFTER MEETING RAY IN BIRMINGHAM SEVERAL DAYS LATER, RAY

PAID OVER TO HIM \$2,000 THREE THOUSAND DOLLARS, PART OF WHICH WAS

PAID IN CASH AND THE REST

WAS ON CREDIT FOR BUYING A "MUSTANG," IN WHICH RAY LATER CARRIED OUT

THE ASSAULT ON THE UNITED STATES AND IN WHICH HE ALSO TOOK PART

IN THE ASSAULT ON THE UNITED STATES.

3,000 THIRTY THOUSAND DOLLARS JUST TO TAKE DRUGS ACROSS A BORDER.

THEY WILL MEET TO RAY AT THEIR NEXT MEETING.
