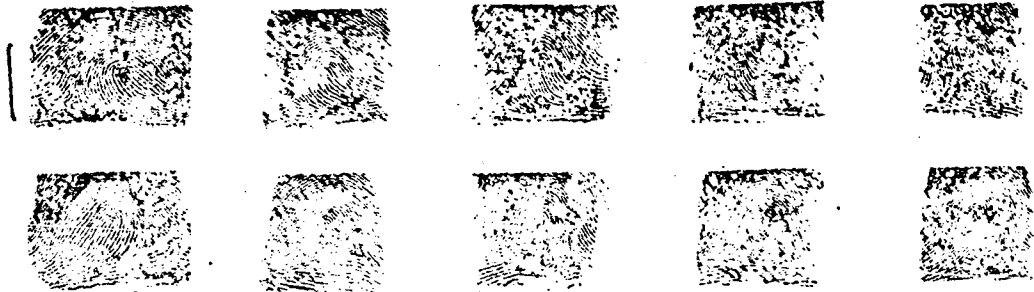

April 4, 1928, May 22, 1928, Alton, Illinois
HEIGHT 5' 11"
WEIGHT 155 to 174 pounds
HAIR Brown, possibly jet black
OCCUPATIONS Driver, color matcher, laborer
SCARS AND MARKS Small scar on center of forehead and small scar on back of right hand
REMARKS Subject's protruding left ear reportedly is a bone wall allegedly attended driver instruction school has reportedly completed course in bartending

CRIMINAL RECORD

Ray has been convicted of burglary, robbery, forging U. S. Postal Money Orders, armed robbery and operating motor vehicle without owner's consent

CAUTION

RAY IS SUSPECT IN CONNECTION WITH A MURDER WHEREIN THE VICTIM WAS SHOT CONSIDER ARMED AND EXTREMELY DANGEROUS

A Federal warrant was issued on April 17, 1968, at New Haven, Conn., charging Ray as Eric Starvo Galt with conspiring to interfere with a Constitutional right of a citizen (Title 18, U. S. Code, Section 238). A Federal warrant was also issued on April 23, 1968, at Jefferson City, Missouri, charging Ray with Interstate Flight to Avoid a Contempt for the crime at Robbery - Title 18, U. S. C. Section 1337.

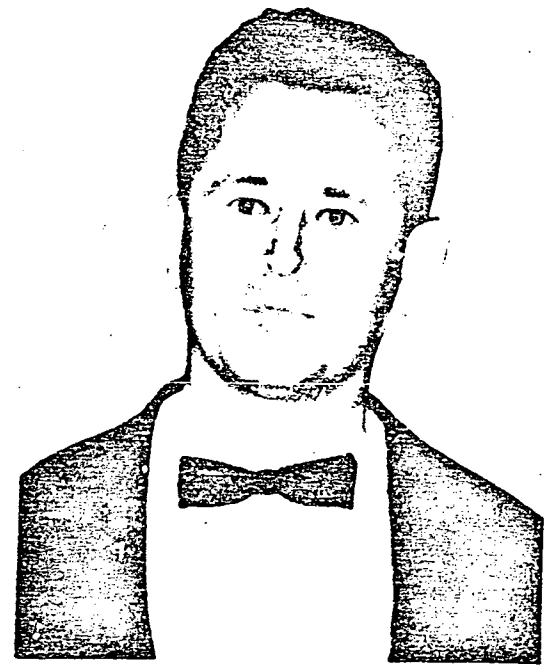
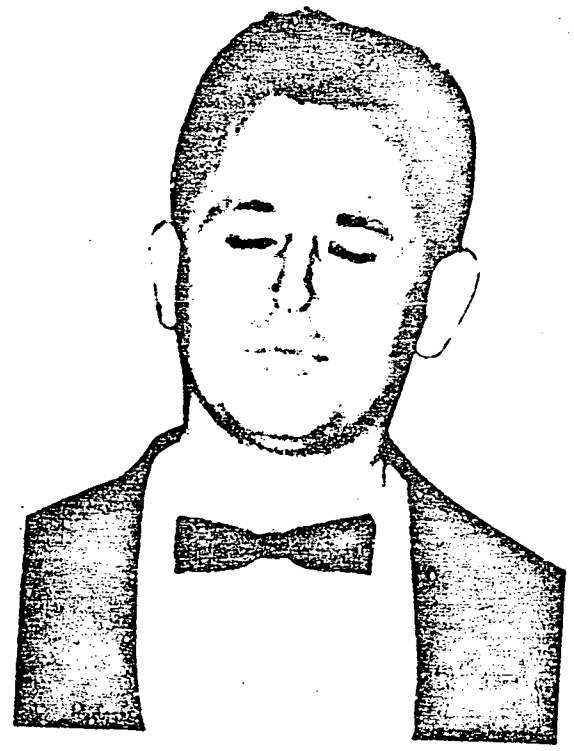
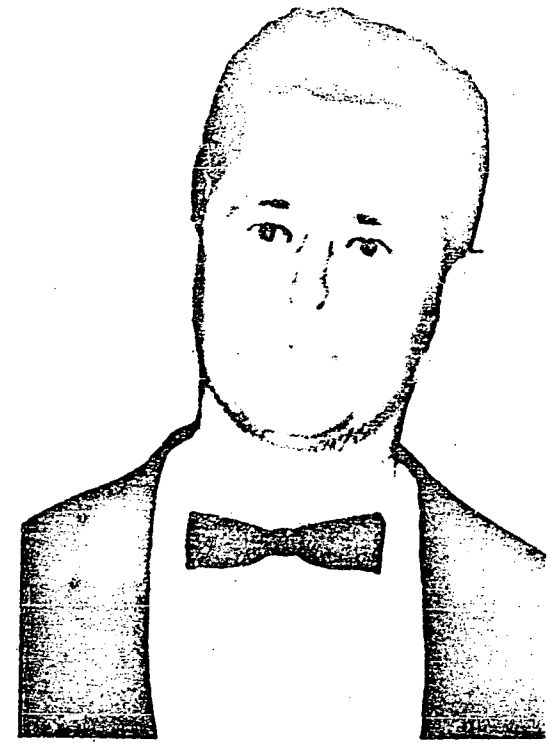
