 Request for Review of Files (U)



1. (U/AIUO) Action Requested: None; for information only.
2. (U/AIUO) Background: Reference is made to the attached House Select Committee on Assassinations (HSCA) requests dated 19, 23, and 26 January 1978 (OLC 78-0095/1, OLC 78-0070/3, and OLC 78-0070/9) for review of all files and index references regarding some 26 subjects of interest to the HSCA.

(C) With regard to the 19 January request, the Office of Security has material available for review pertaining to F. Lee Crisman, Charles Siragusa, James Earl Ray, and Arthur Hanes. No record was found for Jonas C. Spurl, Laverne "Larry" Crafard, Charles Joseph Stein, Lemar Wilson, or Louis P. Davis. The HSCA has asked whether any of the aforementioned individuals were employees, agents, or informants of the CIA. Charles Siragusa was of liaison interest to various components of this Agency from 1961-67, including the Behavioral Activities Branch of Technical Services Division. He was assigned to the Office of Strategic Services (OSS) from 1944-46. Arthur Hanes was a confidential correspondent of the Office of Security from 1952-59. He was of interest to the Office of General Counsel (OGC) and was placed on OGC's Cleared Attorneys Panel in August 1961. OGC's interest appears to have been canceled in 1971.

(S) With regard to the 25² January request, the Office of Security has material available for review on Valeriy Kostikov, Ruth Hyde Paine, John Lindsay Hoke, and Sylvia Ludlow Hyde Hoke. Only overt source material was found for Michael Ralph Paine. Without additional identifying

information, a meaningful search and identification cannot be effected regarding Pedro Gutierrez Valencia. As your Office is aware, discussions have already been initiated with certain staff members of the HSCA regarding Yuri Ivanovich Nosenko.

(C) Regarding the 26 January request, this Office has material available for review on all 10 subjects.

(C) The aforementioned material has been prepared for review by HSCA staff members under revised procedures pertaining to HSCA access to Agency files. 1. (U) Attached please find a copy of a request for information from the House Select Committee on Assassinations dated 27 February 1978.

3. (U) Committee staff will generate summary reports based upon their file review and notes. You will be asked to sanitize these reports to protect intelligence sources and methods prior to transmittal to the Committee. After sanitization, the reports will be transmitted to the Committee, classified, if necessary, at the highest level of classification appropriate.

4. (U) Advise me if you are unable to respond within a reasonable time or if you have any questions regarding our procedures for dealing with the Committee.
