The Historical Review Group of the Central Intelligence Agency has been tasked with the declassification of CIA's documents sequestered during the investigations by the House Select Committee on Assassinations in 1976-78. The Central Intelligence Agency has just delivered its record files responsive to the JFK Assassination Records Collection Act of 1992 to the National Archives. In the weeks since Mr. Glennon reviewed nearly 1400 pages of State-originated or State-interest documents in our offices (28-30 June 1993) and in our final inspection before sealing the boxes for delivery, we have identified an additional 32 documents (119 pages) which were originated in the Department of State or contain equities of the Department. We must now ask that you conduct one supplementary--and we hope final--review of these documents (enclosed, with a listing).

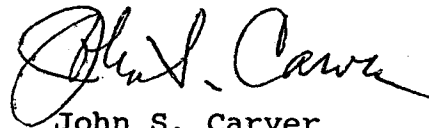

Thank you for your responses to our earlier queries. We find that we must send you a considerable additional batch of material under the President JFK Assassination Records Collection Act of 1992. I am sorry we must do so before we have been able to finish review of several batches of documents you have sent us.

At the direction of Mr. Woolsey, the Central Intelligence Agency has undertaken to print up and review a large file of microfilm holdings. Over 80,000 pages of material from this file will be added to what the Agency turned over to National Archives last August, and about 300 pages from this contain State equities, which we will be sending you in several batches.

The current batch, all from the years 1952 through 1960, amounts to 51 documents (103 pages). Please give us your recommendations on their release, sanitization, or denial, citing the appropriate grounds under Section 6 of the Act where necessary.

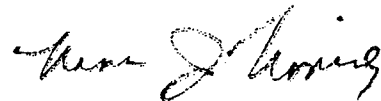

Dear John,

Please find enclosed the results of State review of the three packages of documents sent by CIA to State for review on June 15 under the JFK Assassination Records Act. A copy of CIA's letters and document lists is enclosed with each segment.

Ten of the documents sent to us on June 15 in packages 2 and 3 are still under review by other components of the Department and are not being returned in this shipment. They are marked either DS (Diplomatic Security) or PPT (Passport) on the document lists for those two segments.

Of the documents being returned in this shipment, the Department of State has no objection to the release of all but one document (State telegram 1201 to Mexico City, November 28, 1963). Excisions have been made to conform to a previous review of the document by ARA/MEX. Also, as I mentioned over the telephone, our release of 2 documents, dated August 25, 1964 and September 16, 1965 in package 2 (see yellow tabs) is contingent on CIA's review of the document and clearance of the names involved.

SUBJECT: Return of Documents Referred Under JFK Assassination

The Department of State has reviewed the documents sent to us by CIA under cover of letters from John Carver of September 19, October 5, and October 7, 1994. Copies of the letters are attached. The Department of State clears these documents for release under the above referenced legislation with the following exceptions (both of which are marked with yellow tabs:

o 9/19/94: CSI-0570/94: Reel 28, 3/13/61 memorandum of  
P-28 conversation: We cannot review this document because it  
FC is illegible.

X-25 9/19/94: CSI-0571/94: Reel 25, 10/29/68, USBR  
F-1 Airgram-903: Postponed in full under Section 6(3), for  
reasons of privacy. Also, we are unable to see any  
connection between the individual involved and the Kennedy  
assassination and question whether the document is covered  
by the Act. Also parts of the document are illegible.

We also note that the September 19, 1994 transmittal contains a number of documents relating to James Earl Ray. While we have no objection to the release of these documents and have so indicated, we question whether they fall under the terms of the JFK legislation. We have also marked several instances where the results of CIA's review do not appear on the document.

Sorry for the delay in responding to your two requests. I am awaiting the return of our Cuba specialist so that he can review the documents that you sent to us on August 8. The Department is withholding very little on Cuba for this period and most likely we will be clearing what can be read in these documents, but several of them are illegible in whole or part (see attached list) and we cannot clear what we cannot read. If you could get better copies to us of the documents indicated on the attached list it would facilitate our response.

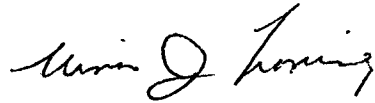
As for your original inquiry re the psychiatric report on Richard Case Nagell sent through State channels in October 1968 (attached), State now withdraws its objections to release of this document. This requires an explanation. When I first reviewed this document, the name Richard Case Nagell did not click with me and I explained in my covering letter when this document was returned to CIA that parts of the document were completely illegible and its relevance to the Kennedy inquiry was not evident.

This time around I recognized the name, which is a most notorious one in JFK Assassination literature. For years evidently Nagell has alluded to knowledge of all kind of plots relating to the assassination; and although he has not been taken seriously by most people who write about the JFK assassination, in 1992 he was the subject of an 800-page book entitled The Man Who Knew Too Much by Dick Russell. The book does not specifically mention this particular psychiatric report, but the subject matter is fully covered. The book even quotes from earlier psychiatric assessments of Nagell which are part of the court transcript of Nagell's appeal of his criminal conviction in the 1960's. Given this fact, I do not think that any part of this can be postponed under the JFK statute. The

Department of State now withdraws its earlier objections to the document's release. The document has been stamped accordingly.

I will get back to you on the other matter hopefully by next week.
