ON 28 JANUARY 1999, JERRY MASSIE, DOJ/CRIM, CAME OUT AND REVIEWED MAC'S PERSONNEL FILE, SECURITY FILE, AND POLY FILE FOR THE SECOND TIME. THE PURPOSE OF JERRY'S VISIT WAS TO IDENTIFY DOCUMENTS AND INDIVIDUALS IN THESE FILES THAT MAY BE HELPFUL TO THE REHABILITATION OF MAC'S POLY. JERRY IDENTIFIED 6 DOCUMENTS FROM MAC'S PERSONNEL FILE FOR WHICH HE HAS REQUESTED A COPY. JERRY, PAUL MORRIS, JOHN TURNICKY D/OS, AND I MET TO DISCUSS THE USE OF DOCUMENTS BY DOJ FROM MAC'S SECURITY FILE AND HIS POLY RECORDS. ONE DOCUMENT JERRY SELECTED WAS A FBI BACKGROUND INVESTIGATION REPORT. JERRY WAS GIVEN THE FBI NUMBER FOR THE DOCUMENT AND TOLD TO ASK THERE PERMISSION FOR ITS USE. JERRY ALSO REQUESTED A DOCUMENT PREPARED BY A CIA BACKGROUND INVESTIGATOR. JOHN ALSO INFORMED JERRY THAT CIA SHOULD BE GIVEN THE CHANCE TO INFORM MAC THAT DOJ HAS REVIEWED HIS FILES PRIOR TO THEM INTERVIEWING HIM AGAIN. JOHN FEARS MAC BECOMING A DISGRUNTLED EMPLOYEE (WITH GOOD REASON) BECAUSE OF THIS INVESTIGATION INTO HIS PRIVATE LIFE WITHOUT HIS KNOWLEDGE. JOHN INDICATED TO JERRY THAT HE CAN NOT HAVE THIS WITHOUT FIRST OBTAINING A PRIVACY ACT WAIVER FROM MAC. I AM GOING TO WORK WITH RICHARD PUHL, HRM/LGL, TO DETERMINE WHAT JERRY CAN HAVE FROM THE PERSONNEL FILE.
