- 1. On 6 May 1993, the undersigned met with Tambra Sabatini, Office of General Counsel (OGC), and Nicole Miller Healy, Trial Attorney for the Department of Justice (DoJ) at 6Y17 NHB. Ms. Healy conducted a follow up file review on the above listed individuals who were involved in unethical polygraph procedures where tests were knowingly manipulated. DoJ previously reviewed their Office of Security (OS) files on 30 January 1992. (C)
- 2. Ms. Healy wrote down two pages of notes that will be reviewed by OGC prior to them being sent via courier to DoJ. OS has no evidence that the subjects above profited in any form from their actions, or that they acted in collusion with any of the people for whom they conducted polygraph examinations. There were no copies, documents, or memoranda from the subject's OS file provided to Ms. Healy. (C)

3. James Archibald/ OS Legal Advisor was advised of this meeting and DoJ's request to conduct a follow up OS file review. (C)
