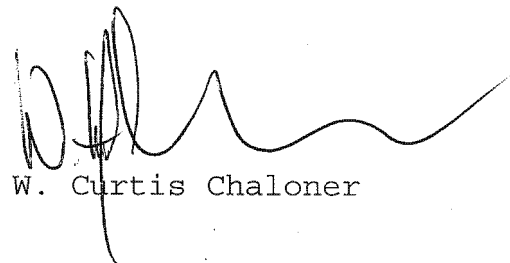

1. The review of notations taken by the DOJ attorney on 21 January 1999 of polygraph file #96405 and security file, AIN 0 660 788 have been reviewed and sanitized under FOIA/PA and AHB 70-9 procedures.

2. Personal information unrelated to the Major Crime issue during polygraph has been redacted. A specific cover mechanism has been redacted. The privacy of a CIA contractor background investigator has been protected.

3. For the record, the notation "Played a role in MLK Ass[assassination]", taken from a 15 May 1989 background investigation could be misconstrued. The statement in context reads: "He had served as a plainclothesman on the Memphis Tenn. Police Dept and played a role in the Martin Luther Kane assassination. He was the first one on the terrace as Rev. King was hit and was with him as he died."
