SUBJECT: MURKIN

At 11:04 a.m., 4/9/68, I was telephonically contacted by ASAC CHARLES DULINSKY of the Las Vegas Office who furnished the following information:

On the night of 4/8/68, REINHOLD C. ANDERSON, 1304 South Eudora, Denver, Colorado, was driving a rented Hertz card when it was smashed into an abutment at an underpass a half mile off the Strip in Las Vegas. The investigating officers said they thought ANDERSON bore a resemblance to the sketch of the assassin of Dr. MARTIN LUTHER KING, and consequently DULINSKY asked us to ascertain the location of ANDERSON on 4/4/68, the date of KING's murder.

The investigating officers indicated ANDERSON apparently deliberately struck the underpass in a possible suicide attempt and in addition to his name and address they ascertained from his driver's license that he was a WMA, DOB [redacted] 6'1", 180 pounds, blond hair, blue eyes, chauffeur's license CA 672, and that he was allegedly employed in the Denver Public Schools System.

With the above information SA NELAN ascertained that ANDERSON was a teacher at Horace Mann School and he further ascertained ANDERSON had physically signed in on that date at the school here in Denver.

I recontacted ASAC DULINSKY 4/9/68, and gave him the above information on ANDERSON.

No further action.

THIS DATE. TWO BUNKERS DESCRIBED BY DE PALMA LOCATED NEAR CREEK RUNNING THROUGH WALKER FARM. FIRST BUNKER GAVE NO INDICATION OF MODIFICATION. SECOND BUNKER SHOWED EXTENSIVE DIGGING AND BLASTING BUT WAS NOT COMPLETED. WAS APPROXIMATELY THIRTY FEET BY EIGHT FEET IN AREA AND SIX TO EIGHT FEET DEEP. ALSO HAD NEAR BY UPPER AREA. NO WEAPONS OR OTHER CONTRABAND LOCATED. THERE WAS NO INDICATION EITHER BUNKER HAD BEEN INHABITED. IN VIEW OF LOCATION OF ABOVE AREA DE PALMA APPEARS TO BE GIVING CREDITABLE INFORMATION.

WALKER AND WIFE ADMIT MEMBERSHIP IN PATRIOTIC PARTY BUT DENY EVERY MEETING DE PUGH OR PEYSON OR KNOWLEDGE OF MINUTEMEN ACTIVITIES. EXTENSIVE NEIGHBORHOOD INVESTIGATION GAVE NO INDICATION DE PUGH OR PEYSON PRESENTLY IN AREA.

At 11:27 PM, 4-11-68, ~~EDWARD MEADOWS~~ 1016 N. Custer, Colorado Springs, Colorado Tel # 632-5737, telephonically advised he met one DOCTOR ED GRANTHAM tonight who closely resembled the picture in the paper of KING'S assassin.

He stated he attending a meeting at the Palmer House in Colorado Springs about a speed reading course which was conducted by DOCTOR ED GRANTHAM who represented International Schools, Memphis, Tenn. He stated to his knowledge GRANTHAM has been in Colorado Springs 2 or three days and is staying at the Palmer House in ~~XXXX~~ rooms 100 and 101.

He described GRANTHAM as 6'1", 175 lbs., dark hair turning gray, combed straight back, several gold teeth, wore glasses for reading.

ASAC advised at 11:32 PM and SA BUGAS advised at 11:38 PM.

Alabaman's Car Tied to King Slaying

ATLANTA, April 11—(UPI)—The FBI Thursday impounded a Birmingham, Ala., man's 1966 white Mustang automobile which had been the object of a secret hunt since the assassination of the Rev. Dr. Martin Luther King Jr. last Thursday in Memphis.

The car was traced through license tags to Eric Starvo Galt, a 36-year-old, brown-haired man who gave his address as a South Birmingham rooming house.

The FBI refused comment on the development, but said no warrant had been issued in the case. However, it was learned that the FBI issued a pickup order for Galt in Florida Thursday, then canceled it Thursday night.

Reporters in Birmingham found the rooming house listed as Galt's address dark and locked. Although one rooming house resident said a man answering Galt's description had lived there three months earlier, the owner refused to talk to reporters and kept the door locked.

"I don't know him," the owner said through a closed window. "I'm sure he's never lived here. I'm not going to open the door."

Percy Strickland, a telephone repairman who lives in the rooming house, said, however, that "I have heard the name of Eric Galt plenty the last week. The FBI has talked to everybody in this rooming house." Strickland said boarders "come and go and it's hard to distinguish," but he remembered Galt as being "younger than the FBI description."

The car, which had been parked for several days in an Atlanta subdivision, was towed to FBI headquarters here and reporters were barred admittance to the building.

The car bore Alabama license tag 1-38993 and had two 1967 Mexican tourist stickers on its windows. The FBI earlier had asked authorities in Mazatlan, Mexico, to watch all points of entry and hotel employees there had been given artist's sketches of the suspected assassin—a neat, brown-haired man in his 30s.

The telephone repairman said Galt lived in the bottom floor of the 2-story, pale gray stucco building and was considered "one of the boys."
