HE STATED RAY CONTINUALLY CHANGED HIS HAIR STYLE.

FBI Puts Lid on Ray Manhunt News

WASHINGTON, April 22—(UPI)—The FBI clamped a lid Monday on any public progress reports in the hunt for James Earl Ray, the accused sniper slayer of Dr. Martin Luther King.

The strict "no comment" policy was expected to prevail until the escaped convict is captured or some dramatic new development occurs.

But the search for Ray, accused of masquerading under

the name of Eric Starvo Galt at the time Dr. King was assassinated in Memphis, was being pressed not only in the United States but in Mexico and Canada as well.

Various photos of Ray—as a convict who escaped from a

Missouri state prison and as an enrollee in a West Coast bartenders school — have been seen probably by millions since Friday when the FBI identified him from a comparison with latent fingerprints found in Memphis where Dr. King was killed April 4.

All three television networks have displayed photographs of the 40-year-old fugitive on news programs. Every major newspaper and news magazine has published them as well. In addition, Ray's picture was shown on the ABC network program, "The FBI," Sunday night. It claims an audience of some 25 million.

The FBI said it was checking out every lead produced by this massive exposure but refused to go beyond this non-committal statement.

Mr. and Mrs. M. L. HOLLAND, co-owners of the Holland House, Golden, Colorado, on April 22, 1968, advised SA THOMAS H. WISEMAN that they are both on duty at the Holland House from approximately 6:00 a.m. to approximately 10:00 p.m. each day and are familiar with most of the guests there. A photograph of JAMES EARL RAY was displayed to them and they advised they have seen no one resembling RAY at the Holland House. Mrs. HOLLAND advised that their records show only four people checked into the Holland House during the night of 4/18-19/68, and they are as follows:

On April 22, 1968, CALIXTO CANCHOLA, clerk, Holland House, Golden, advised that he was on duty from 10:00 p.m. to 7:00 a.m., 4/18-19/68, and that only four people registered in the motel during this period of time. He advised that PHILLIP A. COCHENHAM and JAMES CESARIO, each accompanied by his wife, registered at about midnight. He stated he has seen no one answering the description of JAMES EARL RAY at the motel. He advised that in the early hours of the morning of 4/19/68, he does recall a Yellow Cab driving to the employees' quarters of the Holland House;

On April 22, 1968, SA BILL E. PEMBERTON attempted to contact Mrs. DORIS BYERS, 1130 Logan Street, Denver, Colo. The manager of the apartment building located at 1130 Logan, advised that Mrs. BYERS works during the day and could be contacted after 6 o'clock.

The apartment manager was displayed photograph of ERIC STARVO GALT and questioned as to whether a tenant in the building, ROBERT CATHEY, resembled the photograph of GALT. The apartment manager stated in his opinion the FBI Wanted Flyer photograph of GALT did not resemble ROBERT CATHEY. The manager advised that CATHEY at present is not employed, and in fact, was visiting the apartment manager and his wife at the time of the interview.

ROBERT CATHEY was interviewed at 1130 Logan, Denver, and advised that he was in Denver seeking employment and making preparations to attend the Colorado School of Trade, Gunsmithing school, in the summer of 1968. CATHEY advised that his date of birth is [redacted] and he was employed by the Louisiana State Patrol from January 10, 1961, to April 21, 1968. He also stated that he has been in the area prior to April 21, 1968, but was on vacation from the Louisiana State Patrol; and his resignation was not effective until April 2, 1968. He further stated that his family resides in Arcadia, Louisiana and that as soon as he finds gainful employment, he plans to bring his family to Denver to reside with him.

Visual observation and interview of CATHEY by SA BILL E. PEMBERTON revealed CATHEY does not resemble ERIC STARVO GALT, nor does CATHEY have scar in center of his forehead or in palm of his right hand. The following description was obtained of ROBERT CATHEY by personal observation and interview:

On 4-8-68, CI stated Negro area has a lot of "rumors" concerning possible "trouble", but reiterated it is just talk, and no substance to the rumors. CI indicated that the average Negro does not give credence to this type of rumor, since the source of such gossip are the younger Negroes, who will make trouble regardless of the "cause" involved. CI said these youngsters are not community leaders, and have no voice in Negro matters, and anything these youngsters do, will be a spontaneous thing, and not representative of the thinking of the Negro community.

On 4/23/68, Mrs. JANE PENNA, Jefferson County DMV, advised writer that RY 5225 was listed to ALBERT H. JAMES, 10020 W. 13th Place, Lakewood, Colo.

ALBERT H. JAMES was interviewed by writer at his residence on 4/23/68. It was observed that he is 6'5" or taller, weighs about 290 lbs, and, while he has dark hair, does not closely resemble photographs of RAY/GALT or RIFE. JAMES said he uses the nick name of "JESSE" and produced his business card which carried the name. The card shows that he is in the business of buying, selling, reproducing and restoring guns and has Federal Firearms Dealer License No 84-3977. He indicated he has been in business in Denver for several years. He is married and his wife was at home at the time of the interview.

Galt Alert Issued in King Case

TALLAHASSEE, Fla.—(UPI)—The search for the slayer of the Rev. Dr. Martin Luther King Jr. has taken another mysterious twist and was turned toward Florida Tuesday.

The FBI Monday night issued a pickup order for prime suspect Eric Starvo Galt and asked that it be transmitted to all law enforcement agencies in Florida. The order said Galt was wanted for "civil rights conspiracy" and had used the aliases of Harvey Lowmyer and John Willard.

It made no mention of James Earl Ray, the 40-year-old escapee from the Missouri State Prison whom FBI Director J. Edgar Hoover said fingerprints had proved was the same person as Galt. "Ray and Galt are identical," Hoover said last week.

The FBI in Miami refused comment. Earlier Monday, the FBI in Washington clamped a lid on any public progress report on the manhunt. The policy was expected to prevail until a suspect is captured or some dramatic new development occurs.

Ray was placed on the list of the FBI's 10 most wanted criminals Saturday, and alerts have been issued in Canada and Mexico as well as the United States.

The Florida alert was the state's second in 12 days for Galt. On April 11, the day a white Mustang car registered to Galt was found abandoned in Atlanta, the FBI issued a "lo-

cate and observe" order for Galt in Florida. About five hours later, it was canceled and the FBI indicated later the order was a mistake.

A Miami police official was skeptical of the current alert's failure to mention Ray's name.

"Maybe in about another week the correction will catch up with the message," he said.

A federal warrant charging conspiracy has been issued against Galt, and police in Memphis, Tenn., where Ray was slayed by a sniper April 4, have charged Galt with murder.

The FBI alert advised, "Eric Starvo Galt is sought in connection with murder, wherein he was shot. Consider him extremely dangerous."

The alert described Galt as white, 30 years old, 5'8" to 5'10" in height, with blue or hazel eyes and brown hair. One distinguishing mark, the FBI said, is a noticeably protruding left ear.

The FBI alert said Galt "is reportedly a lone wolf and allegedly attended a dance instruction school, and has reportedly completed a course in bartending."

WOMAN SOUGHT

In Los Angeles, the FBI was reported trying to find a blonde woman who was dating James Earl Ray before Ray disappeared from Southern California.

The FBI office declined to comment on the report.

However, the woman was known to have been with Ray in a Hollywood bar one evening during the second week in March — one of the last times Ray was seen in the area before King's assassination.

'Ray Sought King 'Bounty,' Buddy Says

DALTON, Ga., April 23—(UPI)—A prison buddy of James Earl Ray said Tuesday when Ray heard there was a "million-dollar bounty" on Dr. Martin Luther King Jr., he smiled and said "I'll collect it."

Ray, a 40-year-old fugitive from the Missouri State Prison, is accused by the FBI of assassinating Dr. King in Memphis on April 4.

In Atlanta, it was learned Tuesday that the FBI had investigated reports that Ray, masquerading as Eric Starvo Galt, met two women in a hotel the weekend after the slaying.

The FBI impounded three water glasses from the Briarcliff Hotel the week Dr. King was buried and showed a desk clerk pictures of Galt. The clerk said he recognized the picture as the man who rented the room the Sunday after the slaying.

The next day an attractive young brunet arrived at the room and the following day another young woman, wearing steel-rimmed glasses and dressed like a hippie, joined the other two, the clerk said.

The FBI has interviewed two Atlanta cab drivers who said they drove a man resembling Galt around the hippie district about the same time.

In the Dalton jail, Raymond Curtis, 40, awaiting appeal on a murder sentence, said he

has known Ray in the Kansas City jail, in federal prison at Leavenworth, Kan., and in the state prison at Jefferson City, Mo.

He described Ray as likeable, addicted to "dope," a "loner" and a man concerned only with money.

On the day President Kennedy was assassinated—Nov. 23, 1963—Curtis said he, Ray, and about 150 other prisoners were in an exercise yard when they heard the news.

He said Ray remarked "Well, somebody made a pretty penny on that."

About a week later, Curtis said, he and Ray were in the yard when "a new man just in off the street" told them "the businessmen's association has a million dollar bounty out for Martin Luther King."

Ray smiled, Curtis recalled, and said "If there's a million dollars out for King, I believe if I ever get out I'll collect it."

Curtis said he never figured out what the "new man" meant by the "businessmen's association." He said he couldn't remember who the man was.

"I didn't think much about it at the time. In prison, you hear all sorts of hellacious ideas," said Curtis, a tall, rawboned man.

Authorities in Jefferson City confirmed that Curtis and Ray were in prison at the same time. Authorities in Dalton said the FBI had interviewed Curtis on Sunday and again Monday night. It refused comment on the matter.

Curtis said Ray told him "he always carried a gun. He was always interested in money," Curtis said, but never mentioned racial matters.

"He never made no statements of any kind in a group," Curtis said. "He was a loner."

Ray couldn't "make a long conversation unless he was planning something," said Curtis. "If he was planning something, you could bet they'd be thorough plans." Ray, he said, masterminded things "that would be small things outside, but were pretty big jobs in prison"—such as the theft of eggs and drugs and cigarettes.

He said Ray told him that if he ever wanted to kill someone, he would buy a gun under a false name, and have everything ready for an escape. "He used to talk a lot about escaping to New Zealand, Brazil and Argentina," Curtis said.

"I wouldn't consider him dangerous," Curtis said. "He didn't look for trouble."

"Of course, I'm not saying he wouldn't shoot you if you ran up on him now."

Curtis said he first met Ray in 1955, when he was serving time for bank robbery, and Ray for forging postal money orders, in the Kansas City jail. He said they were transferred to Leavenworth, where Ray "played a lot of miniature golf."

They met again when Curtis was sent to Jefferson City on a 10-year armed robbery conviction.

Tighten Gun Bill

THE difficulty of enforcing laws against the misuse of firearms is demonstrated by the apparent actions of James Earl Ray, 40, named last week by the FBI as a suspect in the slaying of Dr. Martin Luther King.

There is strong public sentiment in favor of tightening controls over the sale of guns, according to the latest Harris survey. Control legislation has been before Congress for more than a year, the survey reported, but opposition from the National Rifle Association and other groups has prevented a vote on it.

Whether or not Ray is found guilty of the killing, it appears from facts presented so far that he violated a 1938 gun law.

The Federal Firearms Act of 1938 provides penalties up to \$2,000 or five years in prison for violations of its provisions. The provisions make it unlawful for Ray, as a convict and fugitive from justice (Ray fled the Missouri Penitentiary last year), to buy a firearm and carry it across state lines. Evidence indicates Ray purchased a weapon in Alabama and transported it to Memphis, Tenn., where King was slain.

Ironically, while this old law has teeth in it, two proposed laws in the U.S. Senate would not have prevented Ray from obtaining the gun he is charged with misusing.

The two bills—one backed by Sen. Thomas Dodd, D-Conn., the other by Sen. Roman Hruska, R.-Neb.—are aimed more in the direction of halting promiscuous mail order sales of firearms.

BUT there is a provision in the Hruska bill requiring foolproof identification of a prospective mail order purchaser (the dealer can go to jail, too, if he accepts false information). It appears reasonable to suggest that this provision be extended to all gun purchases, mail order or over-the-counter.

This would be a form of registration, which gun groups oppose, but it seems a wise precaution to take.

Confusion in the Great Manhunt

A N ASSISTANT police chief in Memphis said this week he was confused about the search for the killer of Dr. Martin Luther King. Imagine, then, the confusion of the rest of the nation.

Two days after King's death, U.S. Atty. Gen. Ramsey Clark said in Memphis the police were "very close" to the killer. But almost three weeks have gone by since then without much indication of an early arrest.

Fortunately the Federal Bureau of Investigation is now satisfied it has identified a fugitive suspect: James Earl Ray, also known as Eric Starvo Galt. This may go a long way toward dispelling the public's bewilderment and concern about the greatest national manhunt of recent times.

Obviously when Ramsey Clark spoke so optimistically in the early hours of the investigation he was trying to reassure people that everything possible was being done. Unfortunately his promise of an early arrest came to have a hollow ring as day after day went by.

At the same time, private and public investigators were pouring out a great, indigestible mass of fact and fancy about the King case. The wanted man, they said, was in his 20s—or 1 to the 30s; he had black hair—or sandy hair; he was a nondrinker—or he liked vodka and beer; he was about 5 feet 8—or close to 6 feet tall.

Even the cautious and close-mouthed FBI had to stop and check its signals a few times.

On April 12, the FBI issued—then abruptly canceled—an order to find a man known as Eric Starvo Galt.

A few days later, after "Galt" was formally charged in court, the FBI said he apparently had been in California in 1964 and 1965. But it turned out the man identified as James Earl Ray had been in prison in Missouri in those years. So the California link of 1964-65

"Galt's" fingerprints match those of Ray in the FBI files, the agency says.

Whoever this man is, of course, he is not convicted of anything. But some of the confusion of this long investigation will be resolved if he can be found and questioned.

On 4/19/68, WILLIAM ELLIS, Manager, Antlers Plaza Hotel, Colorado Springs, Colorado, advised that a maid out his hotel, OPAL KANCHEL, had advised his executive housekeeper, BILLY KRAFT, that an individual that occupied room 1420 at the Antlers from 4/15/68 - 4/18/68, bore a strong resemblance to the photograph of ERIC STARVO GALT which she had seen in the local newspaper the morning of 4/19/68.

ELLIS stated that the individual to whom KANCHEL was referring had checked in on 4/15/68 at 10:31 AM, listing his name as JOSEPH A MURPHY, 47 Samoset St., Boston, Massachusetts, method of transportation as bus.

ELLIS continued that this individual had checked out on 4/18/68 at 10:20 AM, paying his bill of \$44.88 in cash. ELLIS pointed out that this consisted of 3 days room rent, 6 local telephone calls and tax.

ELLIS stated that no records or kept of local calls as they are dialed direct from the various rooms of the hotel.

On 4/19/68 ROGER TERRILL, night manager, Antlers Plaza Hotel, advised that he had checked the individual using the name MURPHY both in and out of room 1420. TERRILL explained that his initials appear on the registration card for both dates, 4/15/68 and 4/18/68.

TERRILL stated he could not recall anything about this individual other than that he was "ordinary looking" and had only a small "gym type" canvas bag.

On 4/19/68 BILLY KRAFT, executive housekeeper, Antlers Plaza Hotel, advised that on this morning she had been advised by one of her maids at the hotel, OPAL KANCHEL, that the individual who had checked out of room 1420 on 4/18/68 bore a strong resemblance to the photo of ERIC STARVO GALT which she had seen in the morning newspaper. KRAFT pointed out that KANCHEL had been employed by the hotel since its opening, approximately one year, and seemed to be quite reliable. KRAFT stated however that KANCHEL tended to be somewhat dramatic at times. KRAFT explained that she ment by this that KANCHEL had on occasion made situations appear more important than they really were.

On 4/19/68, OPAL KANCHEL, maid, Antlers Plaza Hotel, Colorado Springs, Colorado, advised that on this morning she had seen a picture of ERIC STARVO GALT in the morning paper and thought it looked a great deal like the individual who had occupied room 1420 at the Antlers from 4/15/68 - 4/18/68.

KANCHEL stated that this individual had been quite "secretive". She explained that he had appeared to purposely try to keep her from seeing his face when she had come to clean his room but she had seen him clearly on about two occasions.

KANCHEL described this individual as follows:

DE PUGH is the leader of the Minutemen Organization, Militant Right Wing Organization. It was stated that DE PUGH had issued orders to other Minutemen that if he went to jail, certain persons connected with this prosecution, and others, were to be assassinated, including Dr. KING.

DE PUGH and WALTER PATRICK PEYSON are appealing a 1966 conviction in Kansas City for national firearms violation. DE PUGH and PEYSON are wanted on a Federal Grand Jury indictment accusing them of conspiracy to rob banks in Seattle in January.

HUNT advised that the aforementioned information with respect to the Minutemen recalled an article done by "LIFE" in about October, 1961 with regard to hate groups. In this connection photographs were taken in October, 1961 in Shiloh, state unknown, and in Collinsville, Illinois of certain Minutemen, some identified and some unidentified. DE PUGH was one of the individuals identified by name, but under restrictions imposed upon the photographer, identity of others by name was withheld.

The reporter for the article was WILL JARVIS, last known address and telephone number, Bronxville, New York, PE 8-0715. The photographer was CARL IWASAKI, 1465 Monroe Street, Denver, Colorado, telephone #Dexter 3-1290.

HUNT made available three 11"x14" photographs, one of which is DE PUGH and the other two photographs of an unidentified individual who somewhat resembles ERIC STARVO GALT. Both shots of this second individual apparently were taken about the same time. In one of these photographs the unknown individual is sitting with his eyes shut like in the GALT picture released to the public.

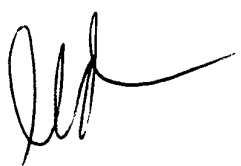
