

HOWARD, residence 2552 Meadowbrook Drive, Denver, telephone 428-6179, advised that he has been a day bartender at the Brown Palace Hotel, Ship Tavern, for 14 years, and that he works every day but Sunday and Monday from 8:00 AM 4:30 PM, He advised that approximately 3:30 PM on 4/18/68, he observed a person at the bar of the Brown Palace Hotel, who very closely resembled a photograph he had seen of ERIC STARVO GALT. HOWARD was exhibited the latests wanted flyer regarding GALT whose true name at that time had been found to be JAMES EARL RAY. HOWARD was also apprised of the known aliase of RAY. Upon exhibition of this wanted flyer, HOWARD stated he was 90 per cent sure that this is the man who appeared at his bar the day before, but that he had never seen him before yesterday.

HOWARD said he half way expected this man to return on 4/19/68 as he had remarked that he would be in that date. HOWARD stated, however, that he owed this individual no money, it being noted that this individual received correct change after having bought a drink. Consequently, HOWARD stated there was no reason for this individual to return.

Physical surveillance was maintained by SA G. HOWARD CARTER from approximately 12:00 noon, 4/19/68, until 5:00 o'clock PM, but the above described individual did not return.

LEONARD GRAHM, WILL GILLIAM, both employees, and HUGH ALLDREDGE, Record Clerk, of the Denver Rescue Mission, 1818 Larimer Street. ALLREDGE advised his establishment has no record dating back to 1954 and 1955, and also no current employees who were employed back then.

The Citizen's Mission, 1617 Larimer Street, where employee LESTER WILLIAMS, Men's Counselor ROBERT SULLIVAN, Executive Director ROY MOUNDY, were interviewed and exhibited wanted flyer regarding RAY, with negative results. 

On April 29, 1968 and April 30, 1968, Chew was interviewed by Special Agents of the FBI. He was asked if he recalled he made a telephone call to the office of Martin Luther King in Atlanta, Georgia on December 13, 1965. He reflected for a few moments and then said he was not about to lie about the situation, especially to the FBI. He said that he has no love for Martin Luther King and is glad he is dead. He stated King was not the non-violent civil rights leader he claimed to be. Wherever he went, violence followed and he was responsible for 37 deaths in the United States. He added that, as a personal matter, King was directly responsible for the destruction of the business career of one of his sons, Bill Chew of Saint Augustine, Florida. He estimated his son's financial loss at \$400,000.00.

Chew stated that his son was head of a hotel and motel association in Saint Augustine, Florida a few years ago when King and his followers came down to Florida and started efforts to integrate the industry. His son was also operating a motel in Saint Augustine at the time. Bill Chew was taken into Federal Court by these people for refusing to integrate his establishment and as the result of an unfavorable court decision, he ended up resigning his position with the association and selling his motel at a

He volunteered that at that time in his life he was a "bad drinker". He emphasized that he had no doubt that he made the call, if interviewing Agents said he did, but that he could not recall it. He stated that he was certain, whether or not he had been drinking, that he would not have made a threat over the telephone since he knows such a threat could lead to trouble for him. He said if he had had any intention of doing anything concerning King, he would not have used the telephone, he would have taken direct action.

Chew advised that he is certain that no one "put him up" to making the telephone call, and it was not an action involving anyone other than himself. He was shown photographs of James Earl Ray, the man being sought in connection with the assasination of Martin Luther King, but disclaimed any knowledge whatsoever of Ray.

He constantly referred to King, Carmichael and Brown using expletives in an effort to show his intense dislike for these men.

He stated that he was in Denver on April 4, 1968 and April 5, 1968 and left the city by Eastern Arilines for Augusta, Georga on April 6, 1963 where he is promoting business interests in the food industry, whereby he hopes to set up his son Bill in business. He was unwilling to further identify his business interests. He stated his son Bill is

presently running the Paradise Motel in Sylvania, Georgia and drove up from there to meet him in Augusta the first part of the week of April 7, 1968. Both he and his son then drove to Sylvania and on to St. Augustine, Florida where they were met on April 12, 1968 by Mrs. Chew and a younger son, who had just returned from military service in Korea. He said his wife and younger son flew from Denver. Thereafter, he and his family vacationed in Florida until he, his wife and younger son returned to Denver on April 29, 1968 in a new car he purchased in Florida.

On 4/30/68, telephone information received from SA BOXD D. ADSIT that SCOTTY JACK, Casper, Wyo., had some information relative to a legal fund for defense of the killer of MARTIN LUTHER KING.

It was determined on this same date that WILLIAM M. "Scotty" JACK was in Denver, Colo. 4/30/68, and was not expected to return to Casper, Wyoming until 5/2/68. His secretary advised that she would contact Mr. JACK and have him contact SA ADSIT at the Denver office.

On 4/30/68, information again received from Denver that manager of Ramada Inn, Casper, Wyo., was supposed to have a "slush fund", to be used for the legal fees for defense of the killer of MARTIN LUTHER KING, when he was apprehended.

On 4/30/68, PAUL DANIGAN, Chief of Police, Casper, Wyoming, was contacted concerning this information. DANIGAN advised that he had not heard this story, but he said he could determine whether it were true or not. He knows RALPH SCHAUSS, manager of the Ramada Inn, fairly well. SCHAUSS is a strong "conservative", and is very outspoken against the current activities of the U. S. Government in their destruction of the rights of individuals and private property. SCHAUSS has never made any secret of his views, and will expound them to anyone. DANIGAN said he would contact SCHAUSS, and in a confidential manner, ask him about such a fund.

Later on 4/30/68, Chief DANIGAN advised that he had spoken to RALPH SCHAUSS, concerning the story that he was collecting a fund for the defense of the killer of KING. SCHAUSS told him that he had heard the same story, but there is no truth in it. There is no such fund, as far as SCHAUSS knows, but SCHAUSS said he "thought it was a good idea", and laughed. SCHAUSS stated that he thought this story got started when SCHAUSS was holding a conversation with another man at the motel. They were talking about the KING murder. The man told SCHAUSS that they ought to take up a collection to help

# Marked Map Linked To Murder of King

Atlanta with the areas of the Galt — with conspiring to vie-Rev. Dr. Martin Luther King Jr.'s residence and church circled has been linked to the suspected assassin, James Earl Ray, by the FBI, it was learned Tuesday.

The Los Angeles Times learned from an unimpeachable source that the map is part of the FBI's evidence against Ray.

The map tends to support a theory by some investigators that Ray stalked King for some time before fatally shooting him on April 4 as the civil rights leader stood on a balcony outside his Memphis hotel room.

The areas circled included the Ebeneezer Baptist Church in Negro business area on the east ern edge of downtown Atlanta and the area of King's residence several miles southwest of downtewn Atlanta. King and his father, the Rev. Martin Luther King Sr., served as co-pastors of the church.


