On 5/3/68, BEN GUTIERREZ, Operations Supervisor, Frontier Airlines, Stapleton Airport, searched through voucher copies of tickets for 5/1-3/68 without locating tickets 829753 and 829754. He did locate the ticket numbers, credit card number and same dollar amounts on the Ticket Sales Report B for 5/1/68 which showed the tickets were issued by salesman JACK GROOM at the Frontier Airlines counter at Stapleton Airport.

JACK GROOM, 3364 S. Grape, Denver, telephone 757-0763, was interviewed at Frontier Airlines (FL), Stapleton Airport, on 5/3/68. He stated he had a faint recollection of the transaction due to a few unusual features and recalled that about 10:00am a fairly heavy set man, who was alone, age about 38, 5'9", 200-210 lbs, blondish-brown hair (crew cut), no glasses, wearing greyish-blue sport coat, white shirt open at neck, no tie, average or a little above in neatness of dress, approach his counter and asked for round trip tickets Las Vegas, NM, to St. Louis, Mo. GROOM thinks he asked the man if he had reservations and that the man said he did. GROOM then wrote up the tickets and told the man the price.

The man pulled out a temporary Frontier credit card which showed his name to be CARL RAY. He recalled that the card indicated the man was from Pecos, Tex., and thought that the card contained a route or box number. He also recalled that the card expired May 25, 1968. When asked if the card could have contained the words "Ray Land and Cattle Co.", GROOM stated that definitely those words were on the card. Because of the amount, GROOM turned to his supervisor, JOHN KNAPP, and obtained his OK on the transaction.

GROOM said the man explained buying the tickets by indicating he was immediately going to Las Vegas where he would catch the flight. GROOM thought he said he was catching the 11:00am, 5/1/68, United Airlines flight to Las Vegas. GROOM stated there was also some conversation about how full the flights to St. Louis from Las Vegas were likely to be.

The various pictures of JAMES EARL RAY were shown to GROOM. He reemphasized that he had only a faint recollection of the man's features. He felt that the man was a lot heavier than the 1966 prison picture and he doesn't particularly look like the picture, but it could be him. He had a crew cut like the 1955 pictures, but was heavier. His nose looked like the nose in the 1955 pictures, and he liked the 1955 pictures best. He did not notice eyes, ears or scars.

On 5/3/68, JOHN KNOPP, Supervisor, FL counter, Stapleton Airport, home address 9151 E. 14th, Apt. 103, telephone 343-4235, advised that he vaguely recalls being contacted by GROOM but he has absolutely no recollection of the man, CARL RAY.

BEN GUTIERREZ contacted BILL BATES, FL Reservations concerning any reservations made by CARL RAY. BATES said Reservations in Las Vegas would have to be contacted to determine if RAY had made reservations from Las Vegas to St. Louis. Contact should be made with Mr. LAVERNE MARTIN.

MR. MARVIN E. LARSON, Director of Revenue and Accounting, FL, 8075 E. 40th, provided the original and one copy of the charge document called a Transportation Receipt bearing signature of CARL RAY, and also ~~two~~ one copy each of the file copies of the two tickets, 829753 and 829754. He requested that the original of the Transportation Receipt be mailed to him at Frontier Airlines, 5900 E. 39th, Denver, 80207.

On 5/3/68, WILLIAM R. NOONEN, Supervisor of Accounts Receivable, FL, 5900 W. 39th, telephone 398-4743, had a search made for the credit application submitted by CARL RAY when he obtained temporary credit card [REDACTED]. Search was made by Mrs. Pat Benefiel, who stated she went through all records twice with negative results and figures that the application has not reached Denver from whatever FL office accepted it. She stated she would continue to look and would notify writer as soon as it was found.

NOONEN, through the assistance of Mr. BERT CLARK, FL, commenced calling around to likely FL Stations to determine where CARL RAY had obtained the temporary card. NOONEN also put out an all-stations teletype to accomplish this same end. This teletype was later cancelled since CLARK determined card was obtained in Albuquerque, NM.

BERT CLARK telephonically advised late 5/3/68, that he had determined that temporary credit card [REDACTED] had been issued at AQ 4/26/68 to CARL RAY, Ray Land and Cattle Co., Rte 4, Box 868, Pecos, Tex. That same day, RAY used the credit card to obtain ticket # 028-101-547-962 for Frontier Flight 581 leaving for Phoenix from AQ at 10:30pm, 4/26/68. It was a one-way ticket, first class, costing \$30.45. Later, RAY had the ticket re-issued for first class jet transportation aboard flight 785 leaving AQ 8:10am, 4/27/68 and arriving Phoenix around 9:42am. The new ticket number was 028-101-547-975.

CLARK said he talked by telephone with MICHAL STONE, the girl at the ticket counter in AQ who waited on CARL RAY during part of his transactions. She described CARL RAY as tanned, 6', dark brown hair, complete Western garb. He stated she would be on duty until Midnight.

At 5:50pm, 5/3/68, writer furnished above information to Supervisor William Nolan, Los Angeles Office. Thereafter, writer furnished same information to SA DON KUSULAS, AQ Office, and requested that appropriate investigation be conducted at FL ticket office, AQ.

During the early evening of 5/3/68, all hotels in the Denver area were contacted by SAs of the Denver Office for any CARL RAYs registered. Any such persons located were to be checked out.

While talking with Mr. NOONEN, mentioned above, he stated that a person of a different name had used the same MO as CARL RAY in obtaining FL tickets and in exchanging them. He said one HERMAN J. SCHUMACHER obtained temporary FL credit card (probably in Phoenix since the number is in sequence with other cards issued by Phoenix). The Station Mgr., FL, Phoenix called FL, Denver, on about 4/15/68 and advised that SCHUMACHER had purchased two round trip tickets Phoenix to St. Louis for a man and wife on 4/15/68, and on 4/16/68, Western Airlines, Phoenix, advised the Station Mgr., (name-Sam Calles) that these two tickets had been turned in to Western for tickets PX to Mexico City. According to Western, the tickets were not used. NOONEN said he put out an all-station teletype to be wary of transactions with SCHUMACHER on 4/17/68, and at about 1:00pm that day, MARTY MARTIN, Station Mgr., Las Vegas called saying that he had sold 2 round trip tickets Las Vegas to St. Louis for Mr. and Mrs. H. SCHUMACHER that day and as near as he could tell, SCHUMACHER took the trip.

To cover the possibility that SCHUMACHER AND CARL RAY are one and the same, NOONEN put out an all-station teletype in an effort to definitiely ascertain which station issued the credit card and to locate the credit application which could not be located in Denver. He stated records in Denver will continue to be searched for this application.

He then advised that this vehicle is currently being driven by DENNIS CHRISMER, son of the owner, and who is currently a cadet attending the U. S. Air Force Academy, Colorado Springs, Colorado.

MURPHY advised that DENNIS CHRISMER does bear some resemblance to subject RAY, having the same general physical features and short crew cut hair. He advised however that CHRISMER is only 20 or 21 years old and has been regularly corresponding with his parents from the USAF Academy and has never made any mention of loaning the car to another party.

On 4/22/68 an attempt was made to contact ALEXANDER SCHEIBEL, Empire Supply Company, 4441 Washington Street, Denver. concerning information he had provided on 4/20/68 to SA RIPPE that he had seen two white males, one of whom bore a resemblance to ERIC STARVO GALT, depart from a yellow cab across the street from Empire Supply Company, on 4/17/68 and crawl into a boxcar of a Burlington Freight Train, that was destined for Chicago. Mr. SCHEIBEL was out of town and not available for interview on 4/22/68.

On 4/22/68 Mr. ROBERT FREY, Personnel Manager, Yellow Cab Company, 3455 Ringsby Court, Denver, made available approximately four driver's records for 4/17/68, and these records were searched by SA LYNN K. ENYART for drop off locations in the vicinity of 4441 Washington Street. No record could be located, which indicated that a Yellow Cab driver had dropped off a passenger or passengers in the vicinity of 4441 Washington Street; however, a record was located indicating that one passenger had been picked up at 9:00 a.m. on 4/17/68 at 3117 West Custer Street and was dropped off at 51st Street and Washington Street at 9:20 a.m. This record indicated the driver to be BRUCE R. KING, Driver Number 10871.

On 4/22/68 BRUCE R. KING, who resides at 1015 South Newton, was interviewed concerning the passenger he had dropped off at 51st and Washington Streets on 4/17/68. He stated that he distinctly remembered the passenger to be a female Mexican, about 25 years old. He advised he did not drop off any passengers in the vicinity of 4441 Washington Street on 4/17/68.

On 4/23/68 Mr. ALEXANDER SCHEIBEL, Empire Supply Company, 4441 Washington Street, who resides at 562 South

Sherman Street, Denver, was contacted at his business. He stated that as he recalled he saw two white male individuals both about 5'10", tall and clean-cut, both 30-35 years of age, alight from a Yellow Cab across from Empire Supply Company and walk into the freight yards across the street. He stated they both crawled into a boxcar of the Burlington Railroad which was part of a freight train he believes was possibly destined for Chicago. Mr. SCHEIBEL stated that this incident occurred sometime during the week before Easter of this year and not on 4/17/68. He could not be specific, but advised the incident probably took place on April 8, 9, 10, 11, or 12. He stated the Yellow Cab driver was a white male, 35-40 years old and quite tall; however, he does not know the cab number. Mr. SCHEIBEL was shown photographs of JAMES EARL RAY and WALTER T. RIFE. He stated that the individuals he saw alight from the Yellow Cab bore some resemblance to these photographs, but stated he could not be certain. He stated it was his belief the individuals he observed were somewhat younger in appearance than the photos of RAY or RIFE.

In view of the vagueness and the age of this information and due to the fact that Mr. SCHEIBEL is not certain of the identity of the individuals he observed or when they observed them, it is recommended that no further action be taken at this time.

Mr. SCHEIBEL was out of town and not available for interview on 4/22/68.

On 4/22/68 Mr. ROBERT FREY, Personnel Manager, Yellow Cab Company, 3455 Ringsby Court, Denver, made available approximately four driver's records for 4/17/68, and these records were searched by SA LYNN K. ENYART for drop off locations in the vicinity of 4441 Washington Street. No record could be located, which indicated that a Yellow Cab driver had dropped off a passenger or passengers in the vicinity of 4441 Washington Street; however, a record was located indicating that one passenger had been picked up at 9:00 a.m. on 4/17/68 at 3117 West Custer Street and was dropped off at 51st Street and Washington Street at 9:20 a.m. This record indicated the driver to be BRUCE R. KING, Driver Number 10871.

On 4/22/68 BRUCE R. KING, who resides at 1015 South Newton, was interviewed concerning the passenger he had dropped off at 51st and Washington Streets on 4/17/68. He stated that he distinctly remembered the passenger to be a female Mexican, about 25 years old. He advised he did not drop off any passengers in the vicinity of 4441 Washington Street on 4/17/68.

On 4/23/68 Mr. ALEXANDER SCHEIBEL, Empire Supply Company, 4441 Washington Street, who resides at 562 South

Sherman Street, Denver, was contacted at his business. He stated that as he recalled he saw two white male individuals both about 5'10", tall and clean-cut, both 30-35 years of age, alight from a Yellow Cab across from Empire Supply Company and walk into the freight yards across the street. He stated they both crawled into a boxcar of the Burlington Railroad which was part of a freight train he believes was possibly destined for Chicago. Mr. SCHEIBEL stated that this incident occurred sometime during the week before Easter of this year and not on 4/17/68. He could not be specific, but advised the incident probably took place on April 8, 9, 10, 11, or 12. He stated the Yellow Cab driver was a white male, 35-40 years old and quite tall; however, he does not know the cab number. Mr. SCHEIBEL was shown photographs of JAMES EARL RAY and WALTER T. RIFE. He stated that the individuals he saw alight from the Yellow Cab bore some resemblance to these photographs, but stated he could not be certain. He stated it was his belief the individuals he observed were somewhat younger in appearance than the photos of RAY or RIFE.

In view of the vagueness and the age of this information and due to the fact that Mr. SCHEIBEL is not certain of the identity of the individuals he observed or when they observed them, it is recommended that no further action be taken at this time.

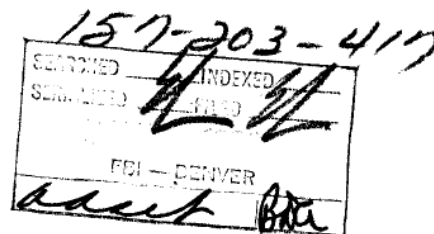
