PUBLICITY ON REWARDS OFFERED

Each Special Agent in Charge and Legal Attache is instructed to promptly remind their established cooperative news sources, in a discreet and tactful manner, of the existence of substantial reward money for information leading to the arrest and conviction of the killer of Dr. Martin Luther King. This money now totals at least \$100,000. The FBI should not, however, be publicized as the source of this reminder.

While the Bureau's continuing policy is to encourage the public to furnish information to law enforcement authorities as a matter of good citizenship, without expectation of financial reward, it is fully recognized that monetary rewards are often necessary to motivate some individuals. The knowledge of the existence of the substantial rewards available in the Murkin case could possibly prove of value in the solution of this major investigation.

WASHINGTON, May 21 — On a carefully marked city map found in a hippie-inhabited boarding house in Atlanta, FBI agents found a thumbprint that enabled them positively to identify the suspected slayer of the Rev. Dr. Martin Luther King Jr.

Although thousands of tips ter Dr. King was killed. have been tracked down by agents in the FBI's 6600-man force with no success since the map was found, federal officials do not subscribe to the theory that Ray may be dead-the victim of someone who hired him to kill Dr. King.

"We have no indication he is dead," said an official. "We figure he is alive-somewhere."

Map of Atlanta

On the city map of Atlanta which bore Ray's thumbprint, four key locations had been circled in pencil-Dr. King's Atlan-

the boarding house where the map was found, and the parking newspaper city and in white Mustang the morning af-

The FBI believes Ray drove the Mustang to Atlanta during the night after the murder, abandoned the car about dawn the next day, took two taxi rides to locations near Peachtree st .- and then vanished.

Agents found the abandoned car April 11. It bore license tags issued to Eric Starvo Galt-a name the FBI said Ray used to mask his true identity.

Two days later, agents combing Atlanta for the mysterious 'Galt" got a tip that he had previously rented a room at a boarding house known to be a popular hangout for hippies.

Flown to FBI Lab

They immediately staked out the rooming house and early the next day went to the room where they had been told "Galt" might be found.

There they found a TV set they later learned "Galt" had obtained in a trade with a girl friend in Los Angeles and the map bearing the thumbprint. Whether "Galt" had used the room after Dr. King's death is not known.

The map with the thumbprint was flown to FBI laboratories here. After a painstaking round-the-clock search of the fingerprints of 53,000 wanted criminals on file here, lab tech nicians hit paydirt on April 19.

By matching the thumbprint on the map to one in their files they determined that Eric Starvo Galt was really James Earl Ray, an habitual criminal who had escaped from the Missouri State Penitentiary on April 23 1967. Galt was only one of several aliases he had used.

After the thumbprint found in Atlanta was matched to Ray's thumbprint here, the FBI also was able to match up other par-tial prints Ray had left on the white mustang and on the rifle from which a single to bot was fired at Dr. King.





On 5/22/68, JOHN WESLEY MEWBOURNE, inmate #37548, Colorado State Penitentiary, Canon City, Colorado, was interviewed by SA WALLACE G. HAGUE at the request of MEWBOURNE.

MEWBOURNE, who has FBI #470625 A, stated he desired an interview inasmuch as he was acquainted with JAMES EARL RAY as an inmate of the U. S. Penitentiary, Leavenworth, Kansas, during 1955. He stated he is of the opinion RAY was hired by members of the Ku Klux Klan and was killed by Klan members after the shooting of MARTIN LUTHER KING.

MEWBOURNE advised he is from Birmingham, Alabama, and in view of the fact he has been a criminal most of his life is acquainted with most bootlegggers, criminals and Klan members in the Alabama, Georgia and Mississippi areas. He stated he will be transferred to the U. S. Penitentiary at Atlanta, Georgia, in approximately two months to serve the remainder of his sentence, and upon his release in about one year plans to locate the body of RAY, which he feels he can accomplish in approximately three weeks. He stated the only reason he is furnishing the above information is the fact he is certain RAY is dead and if not dead would furnish no information concerning RAY. He stated his only contact with RAY was at Leavenworth and he knows nothing concerning RAY's habits, associates, hangouts or possible whereabouts.

The above information is being furnished in the event the name of MEWBOURNE should come to the attention of the Bureau in the future.

Mrs. HOMER LANE BIGALOW, 4331 E. Mexico St., Denver, Colorado, furnished the following information instant date:

She stated that several months ago, exact date not recalled, shen met an individual by the name of BOB BYRNE. 1234 Clarkson St., Denver, Colorado, telephone 534-2074. She advised that she met him through a former neighbor, Kathryn RAHEL, who now resides at 624 Ogden St., Denver, Colo. She advised that she started seeing BYRNE regularly and became quite close to him. She stated that he told her that he was in some type of organized crime syndicate and admitted to her that he has killed several men in the past; however he no longer does this and is now an arranger of killings.

She stated that in the first of December, 1967, she and BYRNE went to Acapulco, Mexico. The purpose of this trip for BYRNE was to attend several meetings to plan a killing. BYRNE would not elaborate further on this and commented that this "job" would make every headline in the country. She stated that while in Mexico, they stayed in a house in Las Braisis, Mexico, and the trip ty HAL HALE. a wealthy oil investor from Los Angeles, who can be reached occassionally in Denver at a house in the 500 Block of Gilpin St. telephone 322-7080. She advised that some other individual stayed in this house most of the time and would know where to locate HALE. She stated that these meetings in Acapulco, Mexico were held on the Ultimer II, a large yacht which was ancored off shore at a U. S. Naval Base in Acapulco. She advised that this yacht is owned by CHARLES REVESEN, owner of the Revlon Cosmetic Company.

Mrs. BIGALOW advised that these meetings were attended by several individuals, names not recalled by her; however CHARLES REVESON and HAL HALE were in attendance at these meetings, and another individual by the name of RAY was also there.

She stated that these meetings lasted for about the first week in January of 1968 and then she and BYRNE spent several days there vacationing and then returned to Denver. She stated that after they returned to Denver, BYRNE advised her that these men are going to make him "pull a job" that he does not want to do. She stated that they were forcing him to do this by threatening her and her three children, ages 18, 16, and 13. She stated that BYRNE talked to her constantly about this job from that time until the 9th of March, when he left Denver and went to Lu bock, Texas, where he stayed with his sister-in-law, Genevise BYRNE, 94704 29th Street, telephone SW 21182. Shes tated that before he left, he told her that she would read about the job which he had to do in the papers in 2 or 3 weeks. She latated that the talked with him occassionally at telephone number SW 21182; however never saw him again until approximately two weeks ago when he returned to her residence and told her that the job had been done, and admitted to her that he had actually arranged and planned the killing of Dr. Martin Luther King. He told her that RAY was still alive and was now in Mexico.

Upon returning to Denver, he told Mrs. BIGALOW that he was planning to marry his sister-in-law in Texas. Mrs. BIGALOW advised that after learning of this, she decided to call the FBI.

She advised that approximately one hour after she called the FBI on 5-22-68, she received a call from JAMES HYER, 9226 E. Le Migh Street, Denver, Phone 771-2411, a Denver Attorney who is an associate of BYRNE through their syndicate operations.

She advised that at approximately 6:30 p. m. 5-22-68, EMENE telephonically contacted her and she gave him the message. She stated that he was paric stricken, immediately terminated the call and she has not seen or heard from since that time.

She stated that HYER probably found aut about her calling the FBI through a "bug" because one has been used in her apartment in the past and was removed by FYRNE.

Mrs. BEGALOW furnished the attached photograph of BYRNE which was taken on their recent trip to Mexico. She stated that several photographs were taken of the yacht with RAY and the others standing on the deck; however when the pictures were returned to her from being developed, these were missing.

She advised that BYRNE had no apparent source of income; however always seemed to have a small amount of money with him. She stated that she believes that he receives some money from Katuryn RAHEL. She stated that on several occassions, whe has offered him money, but he refused it.

She advised that BYRNE has a former wife here in Denver, LYNN (Mrs. James Robb) who lives in the Green Mt. area and is presently bringing legal proceedings against BYRNE as a result of their divorce.

She furthefadrial that Byrre sometimes storp with Bernice Paulsen, 1010 clarkson St. Denner.

Mrs. Bigelow advised that she was agreeable to a subsequent interview because of the limited time of this initial interview.


