HOMER LANE BIGELOW, FOUR THREE THREE ONE EAST MEXICO ST., DENVER, A FIVE TIMES MARRIED WIDOW AND MOTHER OF THREE TEENAGERS, TOLD A LENGTHY, RAMBLING AND APPARENTLY HIGHLY IMAGINATIVE STORY ABOUT MEETING A YEAR AGO, FALLING IN LOVE WITH, AND SLEEPING WITH ONE ROBERT EDWARD BYRNE, A DENVER OIL PROMOTER, WHO SHE SAYS BECAME INVOLVED IN A CONSPIRACY TO KILL KING. SHE DESCRIBED HIM AS A HEAVY AND CONSISTENT DRINKER WHO FREQUENTLY CONSORTED WITH OTHER WOMEN IN DENVER AND A MEMBER OF A HEAVY DRINKING GROUP WHICH INCLUDED FORMER AUSA JAMES W. HEYER, AND OTHER PERSONS, MOSTLY NEIGHBORS, WITH WHOM SHE BECAME ACQUAINTED WHEN ONE OF THE GROUP, MRS. KATHRYN RAHEL, A DIVORCEE, MOVED INTO THE APT. NEXT DOOR.

SHE MET BYRNE AT A PARTY GIVEN BY RAHEL IN MARCH OR APRIL LAST YEAR BUT DID NOT START DATING HIM "HOT AND HEAVY" UNTIL LAST SEPTEMBER. THROUGH

BYRNE SHE MET DENVER AND LOS ANGELES OILPROMOTER H. D. "HAL" HALE, A CLOSE FRIEND OF BYRNE'S AND A HEAVY DRINKER, ALSO.

IN ABOUT OCTOBER LAST YEAR, BYRNE BEGAN INTIMATING HE WAS IN SOME -TYPE OF ORGANIZED CRIME SYNDICATE, BUT NEVER BECAME SPECIFIC AS TO MEMBERS OR ACTIVITIES. ALSO TOLD WAR STORIES ABOUT HIS LIFE IN THE MARINE CORP DURING COMBAT. HE CLAIMED HE HAD KILLED MANY MEN. SHE WAS NEVER SURE WHETHER KILLINGS WERE WHILE IN MARINES OR IN CONNECTION WITH SYNDICATE, BUT LATER WAS TOLD HE WAS NEVER IN COMBAT. SHE SAID MAJORITY OF TALKING DONE AFTER BYRNE HAD BEEN DRINKING AND HE WAS CAPABLE OF DRINKING ONE TO TWO BOTTLES A DAY FOR FOUR OR FIVE DAYS. HE CLAIMED TO BE AN MARINE CORPS PILOT WHO ONCE CRASHED INTO A SCHOOL AND WHO LATER FLEW GUNS TO CASTRO IN CUBA BEFORE CAASTRO TOOK OVER, WHILE IN THE EMPLOY OF ONE RAY RYAN, WHO HE DESCRIBED AS "MR. BIG" AND WHO SPENT PART OF HIS TIME IN KENYA, AFRICA WHERE HE IS A MEMBER OF THE MT. KENYA SAFARI CLUB. RAY RYAN SUPPOSEDLY CANNOT RETURN TO U.S. AS BYRNE SAYS THERE IS CONTRACT OUT ON HIM AND WOULD BE KILLED THE MINUTE HE ENTERED. BYRNE ALSO REFERRED TO HAL HALE AS A "MR. BIG" AND INFERRED HALE WAS INVOLVED IN THE CRIMINAL ACTIVITY.

IN LATE NOVEMBER LAST, BYRNE TOLD HER HE HAD BEEN INVITED TO ACAPULCO, MEXICO, BY HALE AND HIS WIFE, DEE, AND SHE WAS INVITED, TOO. SAID IT WAS BUSINESS TRIP BUT NOT CONNECTED WITH OIL. SHE PAID FOR TRIP FOR THE TWO OF THEM. LEFT DENVER DECEMBER TWENTYEIGHT AND ARRIVED ACAPULCO SAME NIGHT. RETURNED TO DENVER JANUARY TWELVE LAST.

MET HALES THERE AT HOUSE, CASA JOSETTE, IN LAS BRISAS AREA OF TOWN. HALES ACCOMPANIED BY BILLYE AND LOUIS FAWCETT OF ASHDOWN, ARK, WHERE HALE HAS RELATIVES. HALES AND FAWCETTS LEFT ACAPULCO TWO OR THREE DAYS BEFORE SHE AND BYRNE DID.

MRS BIGELOW GAINED IMPRESSION THE THREE MEN ATTENDED MEETINGS DURING MORNINGS, THOUGH NO ONE SAID SO, AND THAT MEETINGS RELATED TO CRIMINAL PLANS. SHE DID NOT KNOW WHO ELSE MIGHT HAVE BEEN PRESENT AT THE MEETINGS, ALTHOUGH HALE ONCE SAID HE HAD SEEN RAY RYAN ON THE STREET. SHE SAID BYRNE RETURNED TO THE HOUSE ONE DAY UPSET. AFTER DINNER HE AND SHE WENT TO PLACE CALLED LE CLUB AND STARTED DRINKING. CLAIMED BYRNE WAS SOBER, THOUGH, WHEN SHE TRIED TO DRAW HIM OUT. ASKED HIM WHAT IT WAS ALL ABOUT AND CLAIMED TO KNOW HE WAS SUPPOSED TO MEET RAY RYAN. BYRNE SAID "THEY WANT ME TO DO A JOB. I DON'T WANT TO DO IT. AS YOU KNOW, I'VE BEEN TRYING TO GET OUT OF THIS FOR THREE YEARS, BUT THEY NEED A TECHNICIAN." BYRNE CLAIMED THAT "THEY" HAD THREATENED HARM TO MRS. BIGELOW'S CHILDREN: THAT "THIS IS ONLY WAY THEY COULD GET TO ME." BYRNE CLAIMED TO BE FRIGHTENED, SAID HE WAS NOT GOING TO DO "IT", AND FOR HER NOT TO WORRY. HE WAS NOT GOING TO LET "THEM" HURT HER OR CHILDREN.

SHORTLY AFTER GROUPS ARRIVAL IN ACAPULCO, YACHT, ULTIMA II, IN HARBOR. THEY LEARNED IT BELONGED TO CHARLES REVSON, HEAD OF REVLON COSMETIC COMPANY. SHE HAD IMPRESSION REVSON NOT ABOARD. AFTER LUNCH ONE DAY BYRNE WANTED TO TAKE SMALL SAIL BOAT OUT, SO HE AND SHE DID. CIRCLED THE YACHT AND TOOK PICTURES OF IT AND SOME CREWMEN AT RAIL. THEY

WAVED AND CREWMAN WAVED BACK. SHE HAD HEARD THAT RAY RYAN WAS ABOARD. THINKS HALE MENTIONED IT. FELT BYRNE WANTED TO CIRCLE IT BECAUSE OF THAT BYRNE LATER TOLD HER HE RENTED SAIL BOAT BECAUSE HE WAS SUPPOSED TO IDENTIFY A CREWMAN AND THE CREWMAN WAS SUPPOSED TO IDENTIFY HIM.

NEXT DAY ALL SIX TOOK SPEED BOAT TRIP AND ON TRIP AGAIN CIRCLED YACHT. TOOK MORE PICTURES OF YACHT AND CREWMEN. ON TRIP TO ACAPULCO MRS. BIGELOW TOOK SEVEN ROLL PICTURES TWENTY PICTURES TO ROLL. WHEN GOT BACK, HAD THEM DEVELOPED AT NEARBY DRUGSTORE IN DENVER. BYRNE PICKED THEM UP, PAYING ABOUT THIRTYFIVE DOLLARS. SHE SAW THEM AND BELIEVES ALL WERE THERE. BYRNE SAID WAS GOING TO KEEP AND WOULD HAVE PRINTS MADE FOR HER. RECALLS THEY SHOWED THEM TO JAMES HEYER.

IN MARCH WHILE AT BYRNE'S APR, BYRNE PASSED OUR DRUNK. SHE TOOK THE PICTURES AND NEGATIVES AND LEFT. THINKS HE MUST HAVE LOST THE NEGATIVES AND SOME AIRLINE TICKETS FOR HER AND HER CHILDREN OUT OF HER PURSE WHEN GOT OUT OF CAR AT HER APR. NEXT MORNING DISCOVERED LOSS AND LATER NOTICED THAT ALL PICTURES OF CREWMEN OF YACHT WERE MISSING.

AFTER RETURN TO DENVER, SHE TRIED TO DISCUSS BYRNES COMMENTS IN ACAPULCO WITH HIM. HE TOLD HER "FOR GOD'S SAKE DON'T BRING THAT UP." THEY EVENTUALLY HAD WORDS AND DID NOT SEE EACH OTHER FROM JANUARY TWENTYSIX TO FEBRUARY NINE.

SHE SAID DUE TO NEED TO TALK TO SOMEONE SHE WENT TO HER ATTORNEY TODD BAKER SHORTLY AFTER THEIR RETURN AND DISCUSSED THE MATTER BRIEFLY WITH HIM. SHE SAID HE LAUGHED AND SAID IT WAS IMPOSSIBLE, BUT IF SHE WAS WORRIED HE WOULD MAKE ONE TELEPHONE CALL AND WOULD FIND OUT WHAT IT WAS ALL ABOUT. SHE SAID BYRNE KNEW THAT SHE HAD SEEN HER ATTORNEY THE VERY NEXT DAY AND TOLD HER SHE WAS IN DEEP TROUBLE. THAT SAME DAY BYRNE PICKED UP THE PICTURES AND THEY TOOK THEM OVER TO HEYER'S

TO SHOW. THEY ALL DRANK A LOT BUT NO ONE WAS DRUNK. AFTER HEYER'S WIFE WENT TO BED, BOTH BYRNE AND HEYER STARTED IN ON HER ASKING WHY SHE WENT TO "TODD" AND TELLING HER SHE WAS GOING TO GET HERSELF, HER KIDS KILLED. HEYERS CLAIMED HER HOUSE WAS "BUGGED" AND THAT THEY KNOW OF ALL HER CONVERSIONS. HE SAID HE AND BYRNE HAD TO MAKE A CALL TO DALLAS AND GET BYRNE OUT OF TROUBLE. THEY ASKED HER TO GO TO THE CAR AND WAIT WHICH SHE DID FOR AWHILE. WHEN SHE CAME BACK IN THEY BOTH LECTURED HER SOME MORE AND GOT HER TO PROMISE SHE WOULD NOT TALK FURTHER. AFTERWARDS HEYER AGAIN CALLED DALLAS AND GAVE THE TELEPHONE TO BYRNE WHO TOOK IT INTO THE NEXT ROOM OUT OF EARSHOT AND TALKED FOR ABOUT FIVE MINUTES. BYRNE LATER TOOK HER HOME STILL LECTURING HER.

MRS. BIGELOW SAID AFTER THEIR FIGHT ON JANUARY TWENTYSIX SHE NEXT SAW BYRNE ON FEBRUARY NINE LAST AT A PARTY GIVEN BY KATHY RAHEL. SHE AND BYRNE MADE UP AND NO MENTION WAS MADE OF PAST EVENTS UNTIL AFTER BYRNE RETURNED FROM LUBBOCK, TEXAS, IN EARLY MARCH WHERE HE HAD GONE TO BE WITH HIS MOTHER WHO WAS HAVING AN OPERATION. HE WAS TENSE WHEN HE RETURNED AND WHEN ASKED WHAT WAS WRONG, TOLD HER THAT HE HAD HIS PROBLEMS AND DID NOT KNOW WHAT TO DO ABOUT IT. HE SAID CRIPTICALLY THAT HE HAD TO DO IT AND HEDID NOT WANT TO. HE WOULD NOT SAY WHAT IT WAS BUT IN RESPONSE TO HER PROBING SAID THAT IT WAS GOING TO HAPPEN SOON, WOULD MAKE NATIONAL HEADLINES AND WOULD BE JUST ABOUT AS BIG AS KENNEDY'S DEATH.

SHE SAID THAT ON MARCH TEN, BYRNE'S MOTHER DIED AND HE WAS GETTING READY TO GO TO NEW YORK WHERE FUNERAL WAS TO BE WHEN ON MARCH THIRTEEN, HIS SISTER IN LAW, GENEVIEVE, CALLED FROM LUBBOCK, TEXAS, TO TELL HIM THAT HIS TWIN BROTHER, HER HUSBAND, HAD BEEN KILLED IN VIET NAM. HE WENT TO LUBBOCK. MRS BIGELOW CALLED HIM FREQUENTLY ASKING WHEN HE WAS RETURNING TO DENVER. DURING THE CALLS SHE LEARNED HE AND GENEVIEVE HAD GONE OFF SOMEWHERE FOR A WEEK. SHE SAID HE WAS AT HIS SISTER IN LAWS AND WAS "ABSOLUTELY, OUT OF HIS MIND, DRUNK." SHE SAID HE SCREAMED AT HER FOR HAVING A NASTY MIND REGARDING GENEVIEVE AND HIM. IN SUBSEQUENT CALLS HE WAS CALMER INDICATING HE HAD A LOT TO DO IN CONNECTION WITH THE ESTATES.

SHE SAID BYRNE RETURNED TO DENVER ON MAY FOURTEEN LAST AND WAS AT HER PLACE THAT NIGHT "FAIRLY WELL DRUNK" BY NINE O'CLOCK. BEFORE JET HAND IN KING'S DEATH. SHE SAID HE REPLIED "WHAT DO YOU THINK, OF COURSE." SHE ASKED HIM IF JAMES EARL RAY DID THE SHOOTING AND HE REPLIED ASKING HER WHAT MADE HER THINK RAY DID IT. SHE SAID SHE INDICATED RAY WAS PROBABLY DEAD AND BYRNE SAID HE WAS NOT. SHE ASKED HIM IF THAT HAD BEEN A PICTURE OF RAY ON THE YACHT SHE HAD TAKEN. HE REPLIED IT WAS. SHE ASKED WHERE THE PICTURES WERE. HE REPLIED "YOU DON'T THINK I WOULD LEAVE THEM AROUND, DO YOU?" HE ENDED THE CONVERSATION BY SAYING HE WOULD NEVER LET "THEM" HURT HER.

NEXT MORNING ^{LATER} DISCOVERED LOSS AND NOTICED THAT ALL PICTURES OF CREWMEN OF YACHT WERE MISSING.

AFTER RETURN TO DENVER, SHE TRIED TO DISCUSS BYRNES COMMENTS IN ACAPULCO WITH HIM. HE TOLD HER "FOR GOD'S SAKE DON'T BRING THAT UP." THEY EVENTUALLY HAD WORDS AND DID NOT SEE EACH OTHER FROM JANUARY TWENTY SIX TO FEBRUARY NINE. [?] SHE SAID DUE TO NEED TO TALK TO SOMEONE SHE WENT TO HER ATTORNEY TODD BAKER/AND DISCUSSED THE MATTER BRIEFLY WITH HIM. ~~SHE~~ SAID HE LAUGHED AND SAID IT WAS IMPOSSIBLE, BUT IF SHE WAS WORRIED HE WOULD MAKE ONE TELEPHONE CALL AND WOULD FIND OUT WHAT IT WAS ALL ABOUT. SHE SAID BYRNE KNEW THAT SHE HAD SEEN HER ATTORNEY THE VERY NEXT DAY AND TOLD HER SHE WAS IN DEEP TROUBLE. THAT SAME DAY BYRNE PICKED UP THE PICTURES AND THEY TOOK THEM OVER TO HEYER'S TO SHOW. THEY ALL DRANK A LOT BUT NO ONE WAS DRUNK. AFTER HEYER'S WIFE WENT TO BED, BOTH BYRNE AND HEYER STARTED IN ON HER ASKING WHY SHE WENT TO

TO "TODD" AND TELLING HER SHE WAS GOING TO GET HERSELF, HER KIDS AND BYRNE KILLED. HEYERS CLAIMED HER HOUSE WAS "BUGGED" AND THAT THEY KNOW OF ALL HER CONVERSATIONS. HE SAID HE AND BYRNE HAD TO MAKE A CALL TO DALLAS AND GET BYRNE OUT OF TROUBLE. THEY ASKED HER TO GO TO THE CAR AND WAIT WHICH SHE DID FOR A WHILE. WHEN SHE CAME BACK IN THEY BOTH LECTURED HER SOME MORE AND GOT HER TO PROMISE SHE WOULD NOT TALK FURTHER. AFTERWARDS HEYER AGAIN CALLED DALLAS AND GAVE THE TELEPHONE TO BYRNE ~~WHEN~~ WHO TOOK IT INTO THE NEXT ROOM OUT OF EARSHOT AND TALKED FOR ABOUT FIVE MINUTES. BYRNE LATER TOOK HER HOME STILL LECTURING HER.

MRS. BIGELOW SAID AFTER THEIR FIGHT ON ~~14~~ JANUARY TWENTY SIX SHE NEXT SAW BYRNE ON FEBRUARY NINE LAST AT A PARTY GIVEN BY KATHY RAHEL. HE WENT TO LUBBOCK. MRS. BIGELOW CALLED HIM

FREQUENTLY ASKING WHEN HE WAS RETURNING TO DENVER. DURING THE CALLS SHE LEARNED HE AND GENEVIEVE HAD GONE OFF SOMEWHERE FOR A WEEK. THE NIGHT OF THE DAY ON WHICH MARTIN LUTHER KING WAS ASSINATED, WHILE OTHERS WERE AT HER HOUSE SHE AGAIN CALLED HIM. SHE SAID HE WAS AT HIS SISTER IN LAWS AND WAS "ABSOLUTELY, OUT OF HIS MIND, DRUNK." SHE SAID HE SCREAMED AT HER FOR HAVING A NASTY MIND REGARDING GENEVIEVE AND HIM. FBI Still Actively Seeks King Slayer

WASHINGTON, May 24—(AP) eral reports that Ray may be dead, Justice Department officials have pointed out continually that there is no evidence to support or refute this.

More than a month and a half after the murder of Dr. Martin Luther King Jr., FBI agents across the nation are reported still actively searching for the man accused of the killing — James Earl Ray.

FBI headquarters has been silent for weeks on the case, except to say that it still is being actively investigated — and that the bureau is not simply waiting for Ray to turn up some place.

Ray, 40, escaped April 23, 1967, from the Missouri State Penitentiary at Jefferson City where he had served eight years of a 20-year sentence for armed robbery.

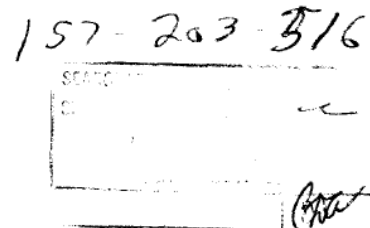

MISCHKE on April 7, 1968, that she observed an artist's sketch of the assassin of Dr. MARTIN LUTHER KING in the newspaper and believes that the sketch somewhat resembles a man she met on a flight from Denver, Colorado, to Colorado Springs, Colorado, on the evening of April 5, 1968. She recalled that the individual said his name was RICHARD KENTS (phonetic) and that he was en route from Nashville to Colorado Springs, to ski with an unnamed friend. She described the man as a white, male, about 25 years of age, six feet tall, medium build and black hair.

Records of Frontier Airlines, Flight 583, for April 5, 1968, indicate that the only passenger deplaning at Colorado Springs was (first name unknown) KINST, who had made reservations on April 3, 1968, for a Trans World Airlines flight from Nashville to St. Louis, and Denver and a Frontier Airlines flight on to Colorado Springs. At the same time, KINST made reservations for return flights to Nashville on April 7, 1968, leaving Denver at 6:05 p.m.

An official of Trans World Airlines advised SA ROY I. MISCHKE that R. KINST did depart Denver on Trans World Airlines Flight 444 and was due to arrive in Nashville aboard Eastern Airlines Flight 662 at 10:15 p.m., April 7, 1968.

ENGLAND that GARY LEE SMITH had applied for and received a Colorado Driver's License, No. [REDACTED]. Mr. DARMOPRAY made available the driver's license application and the Request for Search of National Driver Register.

Mr. DARMOPRAY stated he had talked with SMITH when he applied for the license and, during this conversation, SMITH had stated that in late December, 1967, he had completed three years with the U. S. Marine Corps, and had been discharged from Camp Lejeune, North Carolina. SMITH also stated that he was from Lincoln, Nebraska, and had had a Nebraska driver's license in the past. Mr. DARMOPRAY advised that SMITH had a self-made identification card and a brand new wallet. SMITH claimed he had recently lost his old wallet and all of his identification.

MARGARET PREMIER, Clerk, Adams County Department of Motor Vehicles, advised SA KELLY V. ENGLAND, on April 17, 1968, that she had observed that when SMITH paid for a driver's

On April 20, 1968, the FBI Identification Division was requested to compare the fingerprint on the driver's license application with fingerprints available in this case. By communication dated April 24, 1968, the FBI Identification Division advised that SMITH's fingerprint is not identical with the fingerprints of JAMES EARL RAY.
