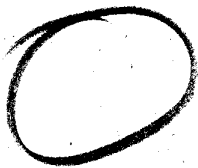

MOLLETT ADVISED, HOWEVER, HE RECEIVED PHONE CALL FROM HIS BROTHER IN FEB. SIXTYEIGHT AND AT THIS TIME HIS BROTHER ADVISED HIM HE WAS IN DENVER, COLORADO AND WAS DOING FINE. MOLLETT STATED ON APR. FIVE LAST HE RECEIVED A COLLECT CALL FROM HIS BROTHER IN DENVER. THE PHONE NUMBER THE CALL ORIGINATED FROM WAS SIX TWO THREE - FOUR FOUR SIX ONE, AND MOLLETT ADVISED IT SOUNDED LIKE IT CAME FROM A BAR BECAUSE OF BACKGROUND NOISES. 


