Only connection w/  
 Probably learned from Newspaper. Got impression  
 he not aboard.

From 1/26 - 2/9 didn't see Bob -  
 Had had words & she decided was giving  
 up. Tension had been building up over  
 the "children"

Had discussed several times prior 1/26/68

Bob knew she was very worried when  
 came back. Had cold in bed 3-4 days She  
 would try to bring up subj. He would say  
 For God's sake don't bring that up.

In DN on 1/12

Hale went down 2-3 days before.  
met there. Went to Ashdun. <sup>visiting the</sup>  
Hale mother drove to DS <sup>with Fawcett</sup> & then flew  
The left on Sunday, 1/14/68 with the  
Fawcett going back to Ashdun.

First time met Dee Hale.

Hale's made arrangements for house  
thru friends either in DS or Mex. City  
Las Brisas area of Acapulco  
House called Casa Josette

No idea who friends were.

Bob & Beglan paid to stay on. Paid  
to real estate agt in Acapulco. House  
had staff of 4, 3 bedroom & then bath-  
white stucco.

No one else joined party. all stayed  
at house.

★ 3 men would take off for San Tam  
after breakfast in 1 of 2 jeeps rented  
by Hale to get paper & for Hale & Fawcett  
to call office. No phone service in house  
Left about 2 hrs. Get back about noon

"Let's holler for Ryan" "For  
God's sake be quiet"

★ Pictures missing now. <sup>photos</sup>

Shorts back. Bob said now you  
know why rented sail boat. I was  
supposed to identify the crewman and  
the crewman was supposed to identify me.  
Went to shore.

Thinks Fawcett arranged speed boat  
trip next day. Toured around 3 cruise  
ships. Took close-up pics. They are  
missing. Then circled Altima II again.  
<sup>People</sup> <sup>crewmembers on deck</sup>  
~~Crewmembers~~ on far tail. Took pictures - missing  
<sup>but couldn't see.</sup>  
Probably 15 pics of ships missing.  
Waved, no conversation.

Had prints developed in Super Slings.  
Bob picked up - & kept in possession.

(Aer had camera exactly like Mr B.)  
Camera's confused during trip.

Bob said was going keep would get prints

In March, at Bob's apt., Bob drunk &

Started drinking but cold sober. She

Ryan. They want me to do a job.

I don't want to do it. As you know,  
I've been trying to get out of this for

Hale had said he had seen Ray Ryan on street

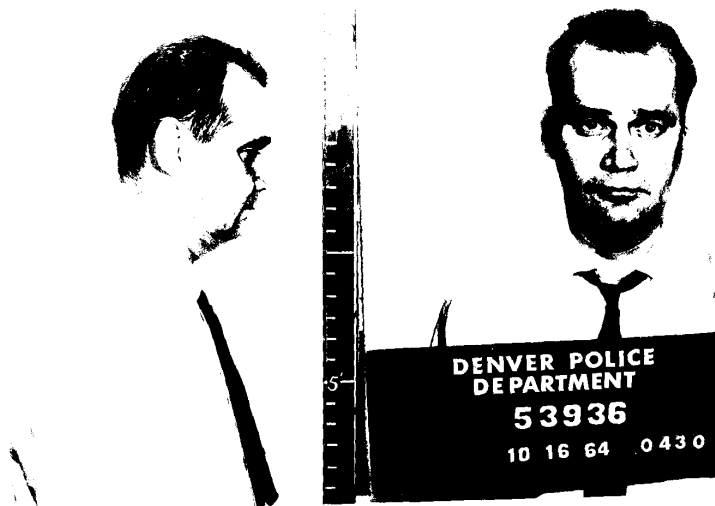

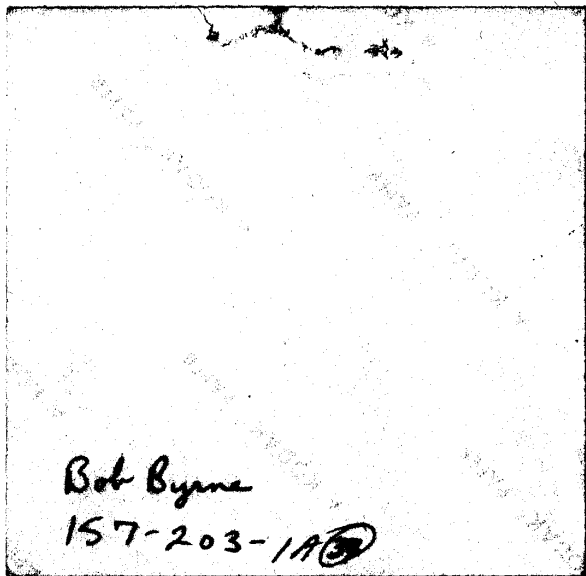
