If the call was made collect, the record would be kept where the long distance call was charged. If the call was a local call which would be dialed by the caller, no record is kept.

If a long distance call is prepaid by depositing the coins at the calling point, but no names given, in other words a person to person call or a station to station call, the records of the accounting office in Phoenix, Arizona would only show the number called and would be filed under the pay station telephone number.
