On 4/30/68 Detective V. R. FRANCO, EPTD Identification Division, advised he had compared JAMES EARL RAY's fingerprints with all unidentified fingerprints in the PD's Latent Fingerprint File and its Master Fingerprint file. RAY's fingerprints did not match any therein.

On 4/30/68 Deputy Sheriff JACK BRIGGS, EPSO, advised his department did not maintain an unidentified latent section.

On 4/30/68 SA JOHN J. CORLIAN advised:

Deputy Sheriff GUY FLETCHER, Midland SO, advised his department did not maintain an unidentified file.

Lt. ROGER MEURER, Midland PD, advised there were several hundred entries in individual case files that were unidentified; the department did not maintain an unidentified latent fingerprint file. He would check individual files, and would advise if any positive comparisons were made.

On 4/30/68 SA PAUL SJODAL advised Capt. BYRON HAWTHORNE, Odessa PD, furnished substantially the same information as Lt. MEURER. Capt. HAWTHORNE will advise if any positive comparisons were made.

At 6:30 PM, 4/30/68, Supervisor HUNTER HELGASON, Bureau, telephoned El Paso and advised that the place where the calls emanated is still in doubt after LOMAX had been interviewed in detail. He stated, however, that he ~~XXX~~ felt that the significant calls to check were the ones where the call had been placed from a booth in the El Paso ~~XXX~~ Division to out of state points, with particular emphasis on calls to Southern States southeast of the calling point and on calls to Missouri and California. He stated that he did not feel that short range calls such as from Marfa to Alpine, etc., were the type of calls which would be productive to check at this time. He was advised of the large distance factor and the number of calls involved which we had determined from research of telephone company records and he said that he felt that common sense should be used in the handling of this matter insofar as determining which calls, if checked out, might be imminently productive,

Night Supervisor HELGASON advised SA REID that LOMAX had made a press release at San Antonio, Texas, on 4/30/68, wherein he stated that it had been determined that RAY and CHARLES STEIN had eaten breakfast at Las Cruces, New Mexico, on the morning of 12/16/68, had driven to El Paso, Texas, where subject RAY purchased a new tire for the white Mustang, and then had driven on to San Antonio, Texas. LOMAX further indicated in his press release that subject RAY's car had skidded off the icy road near San Antonio and that RAY and STEIN then drove on to the next small town, where the new tire was put on the car.
