ON THE SAME DATE, MRS. MICHAL STONE, PASSENGER AGENT, FRONTIER AIRLINES, ALBUQ., ADVISED SHE RECALLS CARL RAY AS PERSON WHO APPLIED FOR A FRONTIER TEMPORARY CREDIT CARD AND WAS ALSO ISSUED A TICKET ON FLIGHT NO. FIVE EIGHT ONE, ON FOUR TWENTYSIX LAST FROM ALBUQ. TO PHOENIX. THE FOLLOWING DAY, CARL RAY ADVISED MRS. STONE HE WANTED FIRST CLASS JET FLIGHT NO. IF RAY BOARDED FLIGHT FOR PHOENIX, BOARDING COUPONS FOR FLIGHT NO. SEVEN EIGHT FIVE OF RAY'S ARE LOCATED AT FRONTIER IN DENVER. MRS. STONE DESCRIBED CARL RAY AS W/MA, TWENTYFIVE TO THIRTY YRS., SIX FT., ONE SIXTYFIVE LBS., SLENDER BUILD, DARK BROWN HR COMBED BACK ON SIDES WEARING TAN COLORED COWBOY HAT, DARK EYES AND EYE BROWS, DARK COMPLEXION (AS IF HE HAD TAN), WORE COWBOY BOOTS, REGULAR LOOKING NOSE AND EARS, WORE WESTERN STYLE LIGHT GREEN SWEDE COAT AND DARK PANTS.
