At 6:31 P.M., SA INGRAM arrived at his residence, at which time it was learned through news media that MARTIN LUTHER KING had been shot at Memphis, a little after 6:00 P.M., and was in critical condition. It was later determined that he had died in a local hospital in Memphis. The Jackson Office was contacted and instructions were given to immediately contact all Senior RA's, and each SRA would immediately account for their bombing suspects and subjects having a propensity for violence.

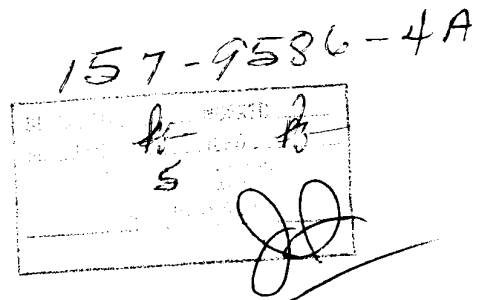
SA PUDDISTER was contacted and he stated he would handle the list of bombing suspects and Agents to whom assigned would be immediately contacted, and those Agents would account for their suspects.

SA FITZ PATRICK was contacted and was dispatched to the office to handle the racial intelligence, as well as assist PUDDISTER in the assassination case. Selected Agents were advised to immediately contact their informants, Klan and Negro. Immediate investigation was instituted in this matter.

April 4, 1968, at 7:55pm SA PUDDISTER received telephone call at residence from Desk #4 with instructions to assure each bombing suspect case agent verifies whereabouts of possible bombing suspects handled by Jackson assigned agents.

At 9:26pm. On duty at office. Verified that each SRA contacted with instructions to verify whereabouts of possible bombing suspects in RA territory.

9:51pm. SRA PROCTOR advised that six Meridian SAs on duty and had JOE DANIEL HAWKINS under close surveillance in Meridian. Individual with HAWKINS identified as WILLIAM PICKEL.

10:15pm. All major bombing suspects accounted for except CHARLES GREENE. See memo of SA PRICE, 4/5/68.

SA ROY MC DANIEL with M.B. Pierce at Jackson PD. Special detail Jackson PD on duty Lynch Street. THOMPSON'S TANK being moved into area on Lynch Street near Jackson State College.

11:13pm SA RABIDEAU reported MHSP at Rust College dispersed a group of about twenty students on Hwy 78 near the college engaged in rock throwing at passing vehicles. Incident occurred between 8:30pm and 9:00pm, 4/4/68. Twenty Six MHSP men standing by plus county and city law enforcement. No further incidents.

11:14pm SA JACK WILSON reported all quiet at Alcorn A & M.

11:25pm SRA JOHN PROCTOR reported JOE DANIEL HAWKINS and Bill PICKEL arrested in Meridian by PD for driving on one way street. Two guns in HAWKINS red Chevrolet. Both fingerprinted and released to appear in traffic court. Guns retained by PD. PROCTOR to get SN and description of weapons.

11:30pm SA VAN NOTE reported minor disturbance at Mississippi Valley State College, Itta Bena. About 300 students, broken windows. All quiet at present. Campus officials handled. MHSP standing by.



GREENE advised that his permanent address, and his mailing address is 69 Ragsdale Street, Hazlehurst, Mississippi, but that he only spends a night occasionally at this address. He said he does not actually live at 2882 Terry Road, but frequently visits at this address, which is the home of Mrs. ERLINE HOWARD, his ex-sister-in-law. GREENE stated that actually he does not have an address at which he regularly stays, and that sometimes he spends the night at the home of his ex-mother-in-law in Crystal Springs, and other times he spends the night with one or another of his women friends. (SIMMONS SHELTON of the Clarion Ledger, brother in law of the writer, advised that he saw HENSARLING in the business office of the paper after 3 pm on this date, has been searching for a photograph of HENSARLING at the paper and in his personal party pictures but had not locate one to date. He reiterated that based on his having known HENSARLING for years, having ridden home with him on a number of occasion, and his above average intelligence, he still finds it hard to believe that HENSARLING is a klansman.)

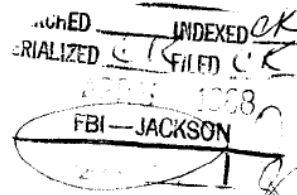

The following investigation was conducted on 4/5/68 at Columbus, Mississippi, by SA's BRENT W. WARBERG and LAWRENCE W. GORMAN:

TOMMY HARROLSON, manager and owner, G and H Liggett Rexall Drugstore, gave the following information:

HARROLSON stated that cash-register receipts for cash purchases made in his drugstore are automatically dated by the cash register. He stated that each cash-register receipt carries the title

Rexall Drug
Columbus, Miss.

Following this heading is the date of the purchase and below the date of the purchase is the amount of the purchase.

He stated that each cash-register receipt has a number; however, these numbers are immaterial to the business of his store. He stated when the numbers reach a level which he thinks is high he flips a switch on the cash register and the numbers start over. Therefore, the numbers mean nothing and no information concerning the accounting procedures of the store is filed by these numbers.
