ASSASSINATION OF MARTIN LUTHER KING, JR. RM

The following investigation was conducted on 4/5/68 at Columbus, Mississippi, by SA's BRENT W. WARBERG and LAWRENCE W. GORMAN:

TOPMY HARROLSON, menager and owner, G and H Liggett Rexall Drugstore, gave the following information:

HARROLSON stated that cash-register receipts for cash purchases made in his drugstore are automatically dated by the cash register. He stated that each cash-register receipt carries the title

G & H Remail Drug Columbus, Miss.

Following this heading is the date of the purchase and below the date of the purchase is the amount of the purchase.

He stated that each cash-register receipt has a number; however, these numbers are immaterial to the business of his store. He stated when the numbers reach a level which he thinks is high he flips a switch on the each register and the numbers start over. Therefore, the numbers mean nothing and no information concerning the accounting procedures of the store is filed by these numbers.

2 - Jackson BWW:mif (2) MW 157947.25 2K CK HARROLSON continued that the only other tickets handled by his drugstore are charge tickets, which carry the name G. & H. Liggett Rexall Drugstore, Columbus, Miss. He stated that the data has to be written in by a clerk and the numbers on these receipts go only to 50.

HARROLSON stated that his drugstore does put price tags on some articles. He stated that these price tags are labeled Liggett Rexall, and then the price of the article is written on the price tag and the price tag is put on the article.

He stated sacks in which merchandise is placed do not carry the name of his drugstore. He stated the only other label used by his drugstore is the label which is put on prescriptions and these contain the name G & H Rexall Drugs, Columbus, Mississippi; however, these are not placed on toilet articles.

HARROLSON continued that Liggett Rexall Drugs is a chain operation throughout the South. He stated his drugstore is the only Liggett Rexall Drugs in the state of Mississipi; however, other Liggett Drugs are predominant in Alabama, Georgia, and Florida.

HARROLSON was given a description of the unknown subject, and he stated he could not recall having sold any Head and Shoulders shampoo or Palmolive Rapid Shave to my individual answering this description.

SORNY SMITH, clerk, G & H Liggett Rexall Drug Company, stated he could not recall selling any articles to an individual answering the description of the unknown subject.

A female clerk is also employed in this store; however, she was presently at lunch and she will be contacted when she arrives back at the store.

ROBERT A. MC PHERSON, Mississippi Wholesale Hardware, Columbus, Miss., stated that he knew of no Compage or Rompage Hardware in and around the area of Columbus. He stated the only way he would be able to check something like this would be through Dun and Bradstreet and even at that he would have to have the name of a city.

At β :15 PM, 4-4-68, the Agent observed that the car of L. E. MATTHEWS, JR., was not at his home at RFD Florence, Miss. Two pickup trucks, believed to belong to MATTHEWS, were parked at the house, but no automobiles were observed on the premises.

An earlier telephone call to the home of MATTHEWS girl friend, ELAINE SMITH, reflected she was not at home and was not expected until later in the evening. Information previously received reflected that MATTHEWS planned to see his girl friend on the evening of 4-4-68.

At 10110 PM a telephone call to MATTHEWS residence was answered by a person believed to be his son, who advised that MATTHEWS was not at home, but was expected shortly. The person said that MATTHEWS had been at home during the early part of the evening. It will be noted that information was received by SA KEUTZER on the evening/of 4-4-68, that MATTHEWS was at home between six and seven PM.

BILLY CARR, rear of 601 East Leake Street, Clinton, Miss., was contacted at 11:10 PM, 4-4-68, and advised he was in the Clinton area during the afternoon of 4-4-68, had dinner during the early evening, and had been at his home the rest of the evening.




