On 4-7-68, Maxine Delbuono, night desk clerk, Downtowner Motel, Jackson advised she registered a man by the name of Fred P. Thorne, 1580 Channel, street of Memphis, Tenn., He was driving a 1968 white Tempest Pontiac with Tenn. license KN 4264. This man registered for two nights. *Daley*

Mrs. Delbuono also advised that Mr. Thorne was employed by the underwriters Salvage Company of Memphis according to her card in her files.

Mrs. Delbuono furnished the following description of Mr. Thorne:

Name: Fred P. Thorne
Ht: 5'10"
Wt: 140
Hair: Dark and had a bald spot in back of head.
Room: 719
age: 48

Artis Geeston, night bell hop, advised he recalls the man in 719 and that he believed him to be about 50, 5'9", 140, dark hair and very well dressed.

Both of the above persons advised Mr. Thorne had left the motel and had not returned. He left with a yellow ford bearing Mississippi license.

Both Mrs. Delbuono, and Mr. Geeston leave work at 11 p.m. and had not seen Mr. Thorne return. A check was made at room 719 and there was no one there.

Arrangements have been made to check with the above after 3p.m. on 4-8-68, to obtain any further information they may have concerning Mr. Thorne.

If above negative Mr. Thorne will be interviewed at this time.
