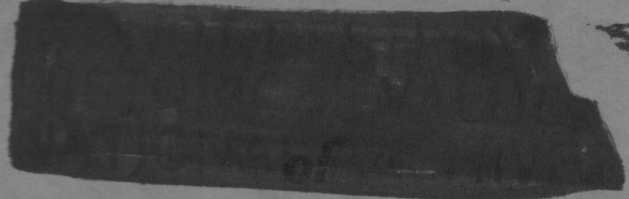

MR. JAMES JONES, TOBACCO, BEER, AND PRIVILEGE TAX DIVISION, MISS. STATE TAX COMMISSION, JACKSON, MISS., ADVISED THIS DATE THAT NUMBERS ON TAX STAMP EFFECTED BY SCHLITZ BREWING CO., LONGVIEW, TEXAS, AT TIME BEER IS CANNED AND FOR NO PARTICULAR SIGNIFICANCE TO MISS. TAX COMMISSION. MR. JONES ADVISED THAT BREWERY AT LONGVIEW, TEXAS, MIGHT POSSIBLY ATTRIBUTE SIGNIFICANCE TO NUMBERS ON TAX STAMP AND MIGHT CONCEIVABLY BE ABLE TO ADVISE DISTRIBUTOR TO WHICH INSTANT CANS SHIPPED.

AS A RESULT OF REFERENCED TEL CALL, SA CHARLES L. BROWN, RA, TYLER, TEXAS, ADVISED THAT HIS INITIAL INQUIRY AT SCHLITZ

BREWING COMPANY, LONGVIEW, TEXAS, INDICATES THAT ABOVE CAPTIONED NUMBERS INDICATE THAT BEER WAS CANNED ON MARCH FIFTEEN, SIXTYEIGHT, LONGVIEW, TEXAS, AND SUBSEQUENTLY SHIPPED TO STATE OF MISS. NO OTHER SIGNIFICANCE CAN BE ATTACHED TO THIS NUMBER. SCHLITZ BREWERY RECORDS INDICATE STATE OF MISS. HAS FIFTEEN DISTRIBUTORS. IDENTITY OF THESE DISTRIBUTORS BEING DETERMINED IN EVENT FURTHER IDENTIFYING INFORMATION RELATIVE TO BEER CANS IS OBTAINED.

HILLIS MC LEMORE, MANAGER, GRAHAM PAPER CO., JACKSON, MISS., ADVISED THIS DATE NAME "HOMESTEAD" IS TRADE NAME FOR BAGS DISTRIBUTED BY THEIR COMPANY. BAG IN QUESTION COULD HAVE BEEN MANUFACTURED IN NUMBER OF MILLS WHICH MANUFACTURE BAGS FOR GRAHAM UNDER TRADE NAME, AND POSSIBLY THE POINT OF MANUFACTURE COULD BE IDENTIFIED BY EXAMINATION OF BAG ITSELF AT ST. LOUIS. STATED COULD POSSIBLY RECOGNIZE DIE USED TO IMPRINT TRADE NAME, AS DIE COULD BE DIFFERENT AT EACH OF THE MILLS. NINETY PERCENT OF HIS BUSINESS IN STATE OF MISSISSIPPI IS SALES TO JOBBERS WHO IN TURN SELL TO INDIVIDUAL STORES OR RETAILERS.
