there was one white male sitting in the rear of this car on the passenger side of the vehicle. She stated there was possibly a second individual sitting in the rear seat of the vehicle; however, she could not be certain of this. She pointed out that the car apparently had clothing, or items, hanging in the car, and she just could not be certain whether or not she had observed a second individual sitting in the back seat of the car.

WALTON stated that the Mustang came to a quick stop and the white male sitting on the passenger side of the front seat got out of the car, proceeded around the vehicle, and got behind the steering wheel of the vehicle. She stated that the driver of the car apparently just scooted over the front seat and never actually got out of the car. WALTON stated that the vehicle immediately departed in what she considered to be a rather hasty fashion, spinning its tires in the gravel.

WALTON stated that the vehicle was definitely a white Mustang and she is relatively certain that it was a 1967 model vehicle. WALTON was requested to describe this vehicle in detail, and thereafter, furnished the following information:

WALTON stated she believed the vehicle was a two door, and was definitely not a convertible or sports model car. She stated she recalls observing a chrome strip running the complete length of the vehicle, and further recalls that the car was very clean, with shiny chrome hubcaps. WALTON stated she could not be certain concerning the license plates of the car, but believed the license plates had a white background and that the numbers or letters on the license plates were a dark color. WALTON stated that the only thing she could be certain about concerning the license plates was tat the license plates were not Mississippi tags.

WALTON was requested to describe the white males she observed in the white Mustang. She pointed out that

the individuals remaining in the car while it was stopped at Jack's Truck Stop were not observed by her very closely and she could not furnish any real details concerning their description. She did recall that the individuals were all white males, and she estimated the individuals to be in their early twenties. She stated that her first impression concerning these individuals was that they were young college men.

WALTON furnished the following description of the individual that actually got out of the white Mustang, and who walked around to the driver's side of this car:

Race: White Sex: Male Age: 23-24

Hair:

rather long like a
Beatle haircut; she
explained the hair

was combed to the side

WALTON stated this individual was tall and rather slim, and was wearing what she believes to have been a dark brown sports coat with a white shirt. She stated this individual was not wearing a tie, to the best of her memory. She further stated this individual walked with the top portion of his body leaning over. She explained that he did not walk standing straight up. She explained that the only other way she could describe this walk was that the individual appeared to be walking in a hurry.

WALTON has stated she did not recognize any of the individuals in this automobile, and that she did not recognize the car as belonging to anyone she was familiar with. She further stated it was questionable whether she could ever identify the one white male that she observed get out of the 1967 Mustang and walk around the car.

WALTON concluded by stating she could furnish no other information regarding the white males or the vehicle

they were driving. She did recall that the vehicle approached Jack's Truck Stop on Highway 78 from the north, and was headed south when it departed.

On April 10, 1968, C. W. Dempsey, Chief of Police, Cleveland, Mississippi, advised that Negro youths are still restless in Cleveland, Mississippi, and the curfew imposed from 6:00 p.m. to 5:00 a.m. on the previous evening is to be continued during the evening of April 10-11, 1968. He said his police department is closely following any developments regarding possible disturbances.

Murray L. Sills, Chief of Police, Vicksburg, Mississippi, advised on April 10, 1968, that unrest is still prevalent among young Negroes in the Vicksburg area. He said several anonymous telephone calls were received by the white owners of various Vicksburg businesses on this date indicating a threat to burn the establishments. Chief Sills said his department is closely following developments in this regard.

Boyce Ferguson, Chief of Police, Crystal Springs, Mississippi, advised on April 10, 1968, that several anonymous calls were received by Buster Whittington, white male, owner of a cleaning store and launderette in Crystal Springs. He said Whittington's launderette received much window damage from the Negro vandals on April 5, 1968. Chief Ferguson said his department is closely following developments in this regard and is keeping a close watch on Whittington's establishments.

On April 10, 1968, Charles Evers, Negro male, Mississippi National Association for the Advancement of Colored People (NAACP) Field Director, advised that a boycott of white-owned businesses instituted by Negroes on April 5, 1968, is to continue in effect throughout Mississippi through Saturday, April 13, 1968. He said the boycott has been effective in some areas and not effective at all in other areas. Evers reported he will lead a march to begin at 8:00 p.m., on April 11, 1968, at Fayette, Mississippi. He said the march is being staged to protest alleged discriminatory practices by the local Superintendent of Education. He said he expects about 300 Negro participants in this march.

Evers said he will also lead a march to begin at 11:00 a.m., on April 13, 1968, at Crystal Springs, Mississippi, to protest inadequate Negro housing, to seek additional jobs for Negroes, and related Negro grievances.

M. B. Pierce, Chief of Detectives, Jackson, Mississippi, Police Department, advised on April 10, 1968, Jackson was very quiet on this date and additional police units placed in operation following recent disturbances will be withdrawn on the evening of this date. He said additionally, police barracades near Jackson State College have been withdrawn.

Charles Marx, Administrative Assistant, Mississippi Highway Safety Patrol (MHSP), advised on April 10, 1968, he received no reports of disturbances throughout the State of Mississippi on this date. He said Highway Patrol units are still following closely any developments or possible incidents.

William Rist, Military Intelligence Group, Jackson, advised on April 10, 1968, that Mississippi National Guard units left their assembly areas and returned to their homes on this date. He said the state alert for the National Guard called on April 5, 1968, will terminate at midnight on April 10, 1968.

A confidential source who has provided reliable information in the past advised on April 11, 1968, that Marvin Louis Wilson and George Washington Ware, Jr., both Negro males, Student Non-Violent Coordinating Committee (SNCC) leaders, are still in the Jackson, Mississippi, vicinity.

Appropriate local, state, and Federal authorities were advised of the above information as it was received.

Gene Walters, Sheriff, Forrest County, Mississippi, advised on April 11, 1968, that a group of 20 Negro youths picketed in an orderly manner at a small shopping center at Palmers Crossing Community near Hattiesburg, Mississippi, from 12:30 p.m. to 3:30 p.m., on this date. The pickets carried signs which indicated they were representing the Mississippi Freedom Democratic Party (MFDP), a predominantly Negro political group in Mississippi. They carried signs also indicating the purpose of their picketing was to encourage Negroes to continue a boycott of white-owned businesses throughout the state, in memory of the late Dr. Martin Luther King, Jr., through April 13, 1968. Appearing at the scene of the picketing also was J. C. Killingsworth, Negro male, Chairman of the Forrest County Action Committee, a Negro group promoting civil rights. Also present on one occasion was Victoria Gray Adams, Negro female, Executive Board member of the MFDP. Sheriff Walters said the group was very orderly, advised him in advance that the picketing was to be conducted, and no incidents occurred.

Joel Chapman, white male, Superintendent of Schools, Shelby, Mississippi, advised on April 11, 1968, that five anonymous telephone calls were received by Lit P. Evans, Jr., Negro male, Principal of the Broad Street Negro high school, on this date. He said the anonymous callers sounded like

Negro youths and during their calls, they indicated the school would be burned. Chapman said that this school had a fifty percent absentee rate on this date. City and county law enforcement officials are closely following this matter.

L. B. Williams, Sheriff, Bolivar Courty, Mississippi, advised on April 11, 1968, that the Chinese owner of a grocery store at Cleveland, Mississippi, received anonymous threats that his store would be burned on this date. Indications were that the callers were young Negroes. Sheriff Williams said his office and the Cleveland Police Department are closely following this matter.

Frank Long, Editor, Greenwood, Mississippi, Commonwealth newspaper, advised on April 11, 1968, that his office received an anonymous call on this date that the newspaper office would be burned. He said it was the second call in this regard thathe had received during the present week The Greenwood Police Department has been notified and is closely following this matter.

Robert Pritchard, Sheriff, Jefferson County, Mississippi, advised on April 11, 1968, that about 375 Negroes marched from Adams Church (Negro) in Fayette, Mississippi, beginning at 8:50 p.m., on this date, to the County Courthouse there. The marchers were led by Charles Evers, Negro male, Mississippi National Association for the Advancement of Colored People (NAACP), Field Director. Upon arrival at the courthouse in Fayette, Evers addressed the group, saying the purpose of the march was to protest alleged discrimination in the Jefferson County School System. He directed his grievances toward D. G. McLaurin, white male, Jefferson County Superintendent of Education. He said the County School System has inadequate school equipment, the school buses are segregated, and related grievances. Evers said as a result of these grievances, a boycott by Negroes of white merchants in Fayette will begin on April 12, 1968, in an effort to put pressure on the city to correct these school grievances. Sheriff Pritchard said the group of marchers dispersed at 9:30 p.m., on April 11, 1968, without incident. He said

Evers announced before the group dispersed that he will also lead a march in Fayette at 2:00 p.m., on April 12, 1968, to re-emphasize the initiation of the boycott there.

M. B. Pierce, Chief of Detectives, Jackson, Mississippi, Police Department, advised that Charles Evers, on April 11, 1968, sent a telegram to Mayor Allen Thompson of Jackson, requesting to meet with Thompson and city officials in a conference on or before April 16, 1968, to discuss Negro problems in Jackson and the possible solutions. Pierce said Mayor Thompson will meet with Evers on or prior to that date in this regard.

Chief Pierce said the City of Jackson was quiet during the day and evening hours of April 11, 1968.

Charles Marx, Administrative Assistant, Mississippi Highway Safety Patrol (MHSP), advised on April 11, 1968, that he had received no reports of disturbances in Mississippi during the day and evening hours of April 11, 1968.

Appropriate local, state, and Federal authorities were advised of the above information as it was received.

Aaron E. Henry, Negro male, President, NAACP, State of Mississippi, who resides at Clarksdale, Mississippi, telephonically contacted the Jackson FBI Office April 13, 1968, and advised he received a telephone call from W. O. Dismuke, who is a white male, about 55 years of age, resides and operates a tire valcanizing company, Memphis, Tennessee. Dismuke is a former resident of Clarksdale and ran for mayor several years ago and considered to be a friend of Henry's. Dismuke advised Henry he should be very careful in the future, keep his name out of the press and take all precautions since one Teddy Carr "might be setting him up". Dismuke did not explain any further. Carr, in 1963, had thrown molotov cocktails into the home of Henry at Clarksdale. Henry could furnish no additional information, but is advising local authorities. He stated he has not seen nor had contact with Carr since 1963 and does not know his whereabouts.

Investigation was conducted by the Memphis FBI Office in 1963 in the case entitled "Theodore Allison Carr, ET AL, Molotov Cocktails Thrown Through Home of Aaron Henry, 636 Page Street, Clarksdale, April 12, 1963. Racial Matter". Carr is a white male born Memphis, Tennessee, and was found not guilty of the

MEARNS. DEAN RENNICK, Confidential Source, who knows the local Klansmen and their vehicles, assigted in this matter. Lights were on in all the houses of the Klansmen and except for the automobile of J. R. WOODS, all vehicles belonging to these Klansmen were accounted for, including the white Mustang of BENNIE FLOYD, JR. DEAN RENNICK advised that he was in the Alamatt Motel Restaurant, Greenville, at approximately 6:45 P.M., 4/4/68, at which time Dr. EVERETT MITCHELL, local leader of the OKKKK, called trying to locate members of the local Klan organizations.

Vehicle registration records for Washington County were reviewed on 4/5/68, and 4/6/68, concerning all Ford Mustangs license in Washington Co. On 4/6/68, COP WILLIAM C. BURNLEY, Captain ROY LONG, Captain HARVEY TACKETT, and several other older members of the Greenville Police Department, as well as one reportedly highly reliable source of the Greenville, Miss., PD, reviewed names of all persons owning Mustang automobiles in Washington Co. in an effort to locate individuals with white Mustangs and persons who have shown in any way a propensity for violence or strong opposition to the civil rights movement.

COP HAROLD SHAW, Hollandale, Miss., reviewed names of individuals in the Hollandale, Miss., area having Mustang automobiles on 4/6/68, with no suspects being developed. No Klansmen in the Hollandale area have white Mustangs.





Mrs. GRACE ROSCHELLE, 946 Myrtlewood Street, Jackson, Mississippi, telephonically advised as follows on this date:

She said her husband, RAYMOND ROSCHELLE, had stopped at a truck stop in Brookhaven, Mississippi, managed or operated by a Mrs. (first name unknown) MARTIN on the late evening of April 4, 1968. She said her husband overheard a conversation that one JESSIE KIMBELL, or KIMBALL, a white male from Brookhaven, Mississippi, had been having with some truck drivers at the truck stop. She said her husband told her that KIMBELL, or KIMBALL, who appeared to have been drinking, said he had just arrived from Memphis, and made some remarks about MARTIN LUTHER KING, JR's being shot there and about a blanket muffling the shot from the assassin. She said her husband continued that KIMBELL, or KIMBALL, related information that the gun used by the assassin had been purchased at a Sears, Roebuck and Company Store in Memphis, Tennessee, on Jefferson or Poplar Street. She said her husband overheard KIMBELL, or KIMBALL, to say he worked for a wholesale drugstore or pharmaceutical company in Brookhaven.

Mrs. ROSCHELLE said her husband told her that KIMBELL, or KIMBALL, was driving a late model white Chevrolet but her husband had been unable to obtain the license number. She said her husband did not want to be contacted by the FBI in this regard. She said the information she had provided from her husband could possibly have a bearing on the assassination of MARTIN LUTHER KING, JR.

Mrs. ROSCHELLE said she does not have a telephone at her residence but, if necessary, can be contacted at the home of a neighbor at telephone number 352-6010.

Mrs. GRADY MARTIN, JR., Route 2, Bogue Chitto, Mississippi, was advised of the identity of the interviewing Agent, who also advised her that she did not have to furnish any information, that any information she did furnish could be used in a court of law and that she could contact an attorney or anyone else at any time.

Mrs. MARTIN advised that she is the owner and operator of "The Chef" in Brookhaven, Mississippi, the only all-night truck stop from Jackson, Mississippi to the vicinity of New Orleans, Louisiana.

Mrs. MARTIN advised that she and one other girl worked the counter and tables at the cafe on the night of April 4, 1968. She advised the other waitress, worked only that one night and is a stranger to the Brookhaven, Mississippi area. She advised that during the night some four to six people (probably truck drivers) came into the place who stated they were in Memphis when Dr. KING was killed. She could not recall the names of any of them. She advised that at some time during the night a man did make a statement that the "blanket being used to muffle the sound of the rifle and the rifle being thrown into a store where they keep juke boxes."

Mrs. MARTIN could furnish no information regarding the identity of the party who made the above statement. She could not recall anything being said about where the rifle was purchased. She advised she does not know anything about a man by the name of JESSE KIMBALL who works: for a wholesale drug store or pharmaceutical company in Brookhaven, or anyone who

drives a white late model Chevrolet who may have made such statements. She advised that with the new girl working for her, she was very busy and simply does not recall who was in the place during that night. She recalled that many discussed the assassination in some manner, but she could recall only the statement about the blanket being used to muffle the rifle.

Mrs. MARTIN advised that should she remember anything further about the conversation, or who was present, she would contact the FBI.

Mr. ERNEST LEVON WILSON, 115 Montana Avenue, McComb, Mississippi, contacted the McComb Resident Agency of the FBI on April 9, 1968, and advised that he was contacted by a Mrs. MARTIN who operates "The Chef" in Brookhaven, Mississippi and advised that the "FBI" was by her home asking about him on April 7, 1968.

Mr. WILSON advised that from what Mrs. MARTIN told him, he feels certain he must be the party SA REESIE L. TIMMONS was seeking. He advised that he not only is a wholesale drug salesman, he drives a white 1967 Chevrolet, was in "The Chef" at midnight April 4, 1968, talking about the Rev. KING's assassination and was originally from Lincoln County.

Mr. WILSON advised that he sat at the counter with some six to eight unknown truck drivers and related a radio broadcast he had just heard on his way from Jackson, Mississippi to Brookhaven.

Mr. WILSON advised that the station broadcast an interview with a man in Memphis, Tennessee, who stated on the air that he saw a man throw a rifle and bag of some kind into his "amusement center" that must have been the rifle used in the assassination. He stated that the man stated on the air that he only saw the man's back and could not identify him. Mr. WILSON advised he did not make any statement about where the rifle was purchased or that if it was wrapped in a blanket. to muffle the sound, nor did he hear anyone else at the place make such a statement.

Mr. WILSON advised that Mrs. MARTIN told him she did not tell the FBI of his presence as she has known him all her life and did not want to get him in trouble. Mr. WILSON advised that Mrs. MARTIN's husband is currently under heavy bond, having been arrested for selling drugs, and Mrs. MARTIN was apparently concerned that she might be in trouble of some kind.

Mr. WILSON advised he knows nothing further about the conversation.


