VOLUNTARY APPEARANCE; ADVICE OF RIGHTS
YOUR RIGHTS

Before we ask you any questions, you must understand your rights. You have the right to remain silent. Anything you say can be used against you in court. You have the right to talk to a lawyer for advice before we ask you any questions, and to have him with you during questioning. You have this right to the advice and presence of a lawyer even if you cannot afford to hire one. We have no way of giving you a lawyer, but one will be appointed for you, if you wish, if and when you go to court. If you wish to answer questions now without a lawyer present, you have the right to stop answering questions at any time. You also have the right to stop answering at any time until you talk to a lawyer.

WAIVER

I, Scott Owen Bell have come to
the Las Vegas Office of the Federal Bureau of Investigation (FBI)
of my own choice to talk with Special Agents of the FBI about a crime which
they are investigating. I know that I am not under arrest and that I can leave
this office if I wish to do so.

Prior to any questioning, I was furnished the above statement of my rights at 1:39 P on 7/31/68 at Las Vegas, Nevada,

I WAS TELEPHONICALLY CONTACTED AT 9:30 PM THIS DATE BY ASAC JOHN F. MORLEY, FBI DENVER AT MY HOME.

MR. MORLEY RELATED THE FOLLOWING INFORMATION FROM FBI, WASHINGTON, D.C.

IN VIEW OF THE POSSIBLE RACIAL DISTURBANCE ARISING FROM THE ASSASSINATION OF MARTIN LUTHER KING, JR. ALL SAC'S MUST:

(1) TAKE NECESSARY PRECAUTIONS WITH RESPECT TO PERSONNEL PROCEEDING TO OFFICES AND TRAVELING TOMORROW AND THE FOLLOWING WEEKEND. BE SURE PERSONNEL ARE MOST JUDICIOUS AS TO WHEN AND WHERE THEY TRAVEL, DEPENDING OF COURSE UPON LOCAL CONDITIONS.

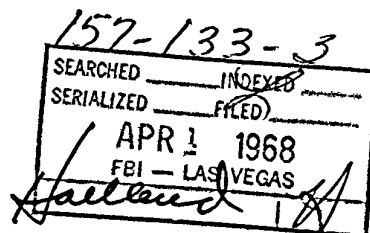
EACH SAC MUST EXERCISE PRUDENCE AND ISSUE APPROPRIATE INSTRUCTIONS UNDER THE CIRCUMSTANCES.

(2) EACH SAC MUST UNDERSTAND HE HAS THE RESPONSIBILITY TO HAVE ADEQUATE PERSONNEL ON DUTY TO HANDLE ANY EMERGENCY THAT MAY ARRISE DURING THE CRITICAL HOURS AHEAD.

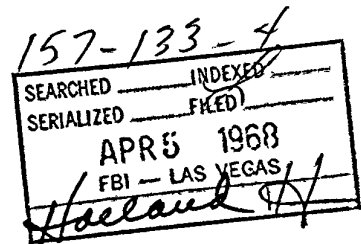

NUMEROUS MEMORIAL SERVICES PLANNED TO HONOR KING IN AREA CHURCHES THIS DATE AND OVER WEEKEND. ^{SOME} ~~NUMEROUS~~ DISTURBANCES WITH RACIAL OVERTONES HAVE OCCURRED AT LOCAL HIGH SCHOOLS IN LAS VEGAS AREA AND HAVE BEEN CLOSELY CONTROLLED BY LOCAL AUTHORITIES. LAS VEGAS PD, CLARK COUNTY SO, AND NORTH LAS VEGAS PD HAVE CANCELLED DAYS OFF AND WILL HAVE ADDITIONAL PLAINCLOTHES PATROL UNITS IN ^{PERTINENT} ~~CHURCH~~ AREAS TWENTY FOUR HOURS A DAY FRIDAY, SATURDAY, AND SUNDAY.
