The following is a synopsis of the enclosed material:

Investigation at Provincial Motel, New Orleans, determined that ERIC S. GALT registered at motel on 12/17/67. Interviews of motel officials and employees in regards to GALT negative. Registration for GALT, as well as indented writing found on paper in motel room, rented by GALT, obtained and forwarded to FBI Laboratory. Laboratory examination of the registration card conducted; however no latent fingerprints obtained,

and the handwriting appearing on this registration card does not sufficiently augment previous writings of GALT to permit a satisfactory comparison of the "HARVEY LOWMYER" signature. Indented writing found on paper in room contained telephone numbers and names of persons. These individuals subsequently identified and advised they belonged to organization known as "Parents Without Partners" and had recently been contacted by another member from Pontiac, Mich. Motel records indicated this person from Pontiac, Mich., used same room as previously used by GALT on 3/25-27/68.

Teacher, BOB STERLING^{aka}; CHARLES HART at Chicago connected with dancing business; CHEVELLE (LNU); a couple, FRANK D. and JANET KAISER who are now married. MEYERS, owner of studio and YVONNE BENOIT who he said is from Houma, used to date her; her parents run possibly an automobile shop.

^{us.} Students, Mrs. MARGARET JONES, 2622 David Drive, Kenner, friend of LUTZ. Described an old fat woman by name of VAN SCOOTER; woman EULA GALIANO, one of MEYERS students, 401 Avenue B, Westwego.

Students cont'd: Woman (FNU) BARTH, cannot describe at all. White female, AURORA WEBER, cocktail waitress in the Fontainebleau Room at the Roosevelt Hotel.

DESIMONE said BILL only worked three or four days during summer of 1964. He was hired by MEYERS. Was a heavy drinker and was let go after three or four days.

MARTIN MYERS was President of Continental Dance.

On 4/19/68, GEORGE S. FRIERSON, JR., 2015 State St., NOLA, Tel. # TW1-7442, telephonically advised his mother lives at 623 Royal Street, NOLA, Tel. # JA5-5763, and she rents rooms at that address. FRIERSON furnished the following information which he said he was furnished by his mother's maid, MARY MURPHY:

On 3/29/68, an individual giving him name as SCOTT NORDAL, white male, came to the 623 Royal St. address and wanted to rent a room. He paid a week's rent in advance and moved in on April 1, 1968. NORDAL was last seen by MARY MURPHY on Wednesday, 4/17/68, when she asked him for past due room rent. While living at 623 Royal St., NORDAL was employed at the Court of Two Sisters as a waiter. MARY MURPHY said that NORDAL stayed off and on in his room and she does not know on what days he was or was not there.

MARY MURPHY saw the photograph of GALT in the newspaper on 4/18/68, and she feels the man who stayed at 623 Royal St. is identical to the photograph of GALT.

FRIERSON advised that his mother is presently ill, and that MARY MURPHY has been handling the rental of the rooms at her house. He said that MARY MURPHY's daughter is the only person he knows other than MARY MURPHY who saw the man who gave his name as NORDAL. He suggested that the Court of Two Sisters may be able to give information as to days worked by NORDAL.

FRIERSON was informed that MARY MURPHY will be contacted by an Agent if it is felt necessary to talk further with her. He requested that the Agent call her at the telephone number JA5-5763 before going there in person to let her know he is coming. FRIERSON said he never saw NORDAL but that he will be glad to talk further with the FBI if the FBI feels it is necessary. He said he is going out of town this afternoon and will not return until the afternoon of 4/20/68.

LAWRENCE C. MOREL was contacted 4/19/68, at the Thompson Packers, Inc., 3259 Chippewa St., NOLA, and advised as follows:

He stated that at some time in 1964 he and his wife were members and pupils of the Continental Dance Club Studio, with its office on Common St. He advised that they became members approximately three weeks after the dance studio opened. He stated that he does not consider himself to have a good memory but advised that his wife does. He requested that both he and his wife be contacted together at their home, 6170 Marshall Foch St., during the afternoon of 4/19/68. He stated that, with reference to the dance studio, at this time, he recalls certain pupils whom he and his wife knew but advised that by thinking about this, he could probably recall more.

MOREL stated that a couple, OTIS and ETHEL BOURGEOIS, who are friends of him and his wife, were very active members of the dance studio and knew many of the pupils, as well as the instructors. He advised that the BOURGEOIS reside at 125 N. Cortez St., NOLA, and that OTIS BOURGEOIS drives a bus for New Orleans Public Service. MOREL stated that two other pupils of the dance studio were PEGGY JONES, who resided on Elysian Fields Ave., and GEORGE JUNKER or JUNKER. MOREL advised that BOURGEOIS would probably know the whereabouts and present addresses of JONES and JUNKER.

MOREL ADvised he would attempt to recall other names as well as locate any pictures which they might have with reference to the dance studio.

SA BARON stated that he had secured an automatic projector and was preparing to view the colored slides of all prisoners released from Angola from approximately 1960 to the present time. This review will be limited to former prisoners of the white race but will include all types of releases.

SA BARON pointed out that this wholesale viewing is necessary due to the filing system at ~~Angola~~ which is not broken down separately as to release dates.

The colored slides contain the name of the former prisoner, the LSP number and the release date.

SA's BARON, PETERSEN and RIZER will select "look alike" and review the individual files of these individuals for the purposes of elimination.

SA BARON will telephonically contact New Orleans at approximately 3:30 PM to furnish the results of this project at which time he felt he would be in a position to indicate as to how much more work remained to be done.

ATTORNEY GENERAL RAMSEY CLARK ANNOUNCED TODAY THAT THE FBI HAS IDENTIFIED JAMES EARL RAY, AN ESCAPEE FROM THE MISSOURI STATE PENITENTIARY, AS ERIC STARVO GALT, AGAINST WHOM A FEDERAL COMPLAINT WAS FILED LAST WEDNESDAY IN CONNECTION WITH THE FATAL SHOOTING OF THE REVEREND DR. MARTIN LUTHER KING, JR.

DIRECTOR J. EDGAR HOOVER SAID THAT A SYSTEMATIC AND EXHAUSTIVE SEARCH OF LATENT FINGERPRINTS UNCOVERED IN THE DR. KING CASE AGAINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FROM WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI'S IDENTIFICATION DIVISION LED TO THE DETERMINATION THAT GALT AND RAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI STATE PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967. HE HAD BEEN RECEIVED AT THAT INSTITUTION ON MARCH 17, 1960, TO SERVE A 20-YEAR SENTENCE FOLLOWING CONVICTION IN ST. LOUIS FOR ARMED ROBBERY AND FOR OPERATING A MOTOR VEHICLE WITHOUT PERMISSION OF THE OWNER.

IN SEPTEMBER, 1966, WHILE SERVING THIS SENTENCE, HE WAS CONFINED FOR A TIME IN THE MAXIMUM SECURITY WARD AT THE STATE HOSPITAL AT FULTON, MISSOURI.

ACCORDING TO MR. HOOVER, RAY HAS A KNOWN ARREST RECORD DATING BACK TO 1949. PRIOR TO THE 1960 CONVICTION FOR WHICH HE RECEIVED THE 20-YEAR TERM, RAY HAD BEEN CONVICTED OF BURGLARY IN LOS ANGELES, CALIFORNIA, IN 1949; ARMED ROBBERY IN CHICAGO, ILLINOIS, IN 1952; AND FORGING UNITED STATES POSTAL MONEY ORDERS IN MISSOURI IN 1955.

HE HAS SERVED TERMS IN THE LOS ANGELES COUNTY JAIL IN 1949; IN STATE PRISONS AT JOLIET AND PONTIAC, ILLINOIS, IN 1952-54; AND IN THE FEDERAL PENITENTIARY AT LEAVENWORTH, KANSAS, IN 1955-58.

RAY WAS AN ENLISTED MAN IN THE UNITED STATES ARMY FROM FEBRUARY, 1946, TO DECEMBER, 1948, AT WHICH TIME HE WAS GIVEN A GENERAL DISCHARGE DUE TO INEPTNESS AND LACK OF ADAPTABILITY FOR MILITARY SERVICE. WHILE IN THE ARMY, HE RECEIVED A THREE-MONTH SENTENCE AT HARD LABOR FOR BEING DRUNK AND BREAKING ARREST.

MR. HOOVER SAID THAT DURING HIS CRIMINAL CAREER, RAY HAS ALSO USED THE NAMES OF JAMES MCBRIDE, JAMES WALTON, W. C. HERRON AND JAMES O'CONNER. HE IS A WHITE MALE; CLAIMS TO HAVE

BEEN BORN [REDACTED] IN ILLINOIS; IS APPROXIMATELY 5 FEET 10 INCHES TALL AND WEIGHS ABOUT 163 TO 174 POUNDS. HE HAS BLUE EYES AND BROWN HAIR. THERE IS A SMALL SCAR ON THE CENTER OF HIS FOREHEAD AND A SCAR ON THE PALM OF HIS RIGHT HAND.

RAY HAS CLAIMED THAT HE ATTENDED SCHOOL THROUGH THE 10TH GRADE IN ALTON, ILLINOIS. HE HAS HAD THE REPUTATION OF BEING A "DRIFTER" SINCE LEAVING SCHOOL. HIS VOCATIONAL EXPERIENCE INCLUDES WORKING AS A BAKER, LABORER AND COLOR MATCHER.

IN CONNECTION WITH HIS ESCAPE FROM THE MISSOURI STATE PENITENTIARY, AN FBI COMPLAINT WAS FILED IN JEFFERSON CITY, MISSOURI, ON JULY 20, 1967, CHARGING RAY WITH UNLAWFULLY FLEEING FROM THE STATE OF MISSOURI TO AVOID CONFINEMENT. HE HAS BEEN A FEDERAL FUGITIVE SINCE THEN.

RAY SHOULD BE CONSIDERED ARMED AND EXTREMELY DANGEROUS. ANYONE HAVING INFORMATION CONCERNING HIM SHOULD IMMEDIATELY CONTACT FBI HEADQUARTERS IN WASHINGTON, D. C., OR THE NEAREST FBI OFFICE.

Mr. MOORE advised that there is a central repository for all income tax returns made out by any individual in the United States located at the following address:

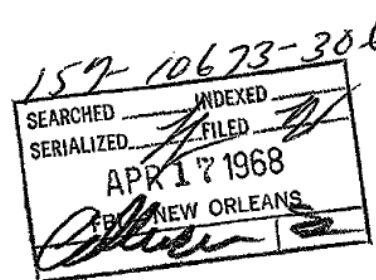

She said that she had seen in this mornings paper containing a photo of ERIC STARVO GALT, and she wanted to relate the following information.

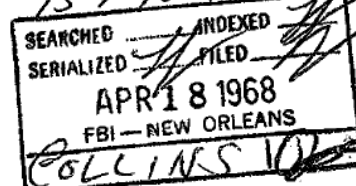

The following investigation was conducted by
SA ELMER B. LITCHFIELD at Baton Rouge, La.:

CHARLES L. MILLER, JR., attorney, 103 19th St., advised on April 18, 1968, that for about a six-month period prior to May 1, 1964, he was the licensee for the Arthur Murray Dance Studios at Baton Rouge, La. He advised that on about May 1, 1964, he left Baton Rouge and went to New Orleans La., where he enrolled for the summer session at Tulane University. While attending the 1964 summer session at Tulane, he worked nights as a dance instructor at Arthur Murray's in New Orleans for about one month. On approximately 6/1/64 he went to work as an instructor at the Continental Dance Studio in New Orleans, and worked there for also approximately one month. He advised that he does not recall ERIC S. GALT by name, and does not recognize photograph of GALT as being anyone known to him.

However, GALT's face in the photograph has the same general shape as an individual known to him as DUHON. He advised that DUHON, whose first name is unknown to him, worked for him as a dance instructor in Baton Rouge, and also worked at the Continental Studio in New Orleans. He believes that DUHON was also employed at Bohn Ford Company in New Orleans during the time he was an instructor at the Continental Studio. DUHON claimed to have a brother who was a jockey and rode horses during the racing season at the Fair Grounds Race Track in New Orleans.

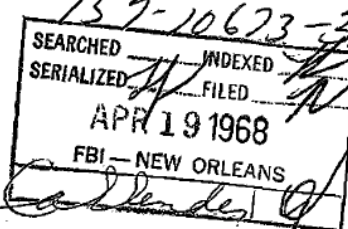

DANCING SCHOOLS

The following investigation was conducted by Special Agent LELAND A. LYNN on April 18, 1968, at Lafayette, Louisiana:

Mr. HUEY DUGAS, Salesman, Abdella's Department Store, advised that he attended the Arthur Murray Dancing School in Lafayette in 1959 and 1960. The school was operated by Mr. ROY TRUXILLO, who departed Lafayette about 1960 or 1961, for San Juan, Puerto, Rico. This school was owned by a Mr. COLE in Baton Rouge, Louisiana, who also operated an Arthur Murray School in Baton Rouge.

Mr. DUGAS stated that he was familiar with the dancing schools in Lafayette and, to his knowledge, there have not been any ballroom dancing schools in Lafayette since that time.

Mrs. KATHLEEN T. DALY, 111 Baudoin Drive, former owner of the Thibodeaux Academy School of Dancing, 819 Foreman Drive, and JUNE MONTGOMERY, 714 Foreman Drive, advised that they do not teach adult ballroom dancing, and all the dancing schools in Lafayette are for children of ballet dancing. Both advised that ERIC STARVO GALT is not known to them.
