

On this date JOSEPH TRUMELL, 5619 Magazine Street, New Orleans, La., advised the writer that on the morning of April 3 or 4, 1968, between the hours of 10am and 11:30am, while he was in the lobby of the Sheraton Charles Hotel, he noticed an individual, whom he described as a white male, 40 years old, 5:8: to 5:10:, 125-135, and wearing a white straw Panama hat, gray suit coat, blue slacks, white shirt and tie, acting very strangely. TRUDELL stated this person seemed to be in a highly nervous state, chain smoking, constantly changing seats, walking around and frequently looking up toward the balcony. TRUDELL also noticed this person, when purchasing a pack of cigaretes, pull out a large roll of money from his pants pocket. When this person left the lobby he did so by himself and walking at a fast pace. TRUDELL did not see this person talk with anyone in the hotel lobby not did he see the individual leave with anyone not see where he went once he left the hotel.

TRUDELL does not recall who was on duty when this individual bought the cigaretes, and he did not tell anyone of his observations until PURNEL BARKER, Hotel Chief of Security arrived on duty.

TRUDELL observed two photo's of JAMES EARL RAY, and stated that the individual he observed in the hotel lobby may have been identical, noting that the facial features, as he recalls them, were about the same, but he could not see the person's hair because of the hat which the person did not take off. TRUDELL advised the person he saw was clean shaven and neat, but TRUDELL did not notice if he had one ear more protruding than the other, nor did he recall observing the individual tug at one of his ear lobes in a nervous fashion.

TRUDELL is retired, has no home telephone, and can usually be located in the lobby of the Sheraton Charles Hotel, Common Street. TRUDELL had never seen this individual prior to this one time nor has he seen him since.

The following investigation was conducted by SA JAMES D. HILL at New Orleans, La.:

On 4/19/68 Mr. JOSEPH A. GOWAN, 2221 Brainard St., New Orleans, La., Staff Law Clerk, Fourt of Appeals for the Fifth U.S. Circuit Court, furnished the following information:

Mr. GOWAN advised he was a student at the Continental Dance Clubion Common St. for approximately 18 months during 1964 and 1965. He advised that he was a student of the club up until October, 1965, at which time the Continental closed for business.

GOWAN advised he did not recall the name of ERIC S. GALT as being associated with Continental Dance Club. When a photograph of GALT was displayed to GOWAN, he advised that the picture might be somewhat familiar as a former student, but that he might have this picture confused with one he has seen in the current newspapers. GOWAN advised that the only individual that he can recall who might possibly have been GALT was a man who was a student only a short time, possibly three or four weeks. GOWAN said he recalls this man due to a misunderstanding at one of the dance studio parties. GOWAN claimed that he inadvertently sat on this individual, and that this individual had reacted in such a manner as to put GOWAN in fear of bodily attack. GOWAN stated that he had apologized

The following investigation was conducted by SA JAMES D. HILL at New Orleans on 4/19/68:

A female employee at Papa Joe's on Bourbon St., who declined to give her name, advised that during 1964 and 1965 she acted as a bookkeeper for Papa Joe's, and in this capacity maintained the payroll records of all personnel employed at Papa Joe's.

She stated that FNU KELLY, a voluptuous redhead, was in all probability TINA LOUISE, who at various times has used the name of TINA KELLY or TINA MAKIE. She stated that LOUISE is no longer employed at Papa Joe's, but that she could most probably be contacted through her sister, who is a stripper at the Hotsy Totsy Club. She stated that the sister dances under the name of DONNA.

She further advised that she knew that KELLY had at one time given dance lessons or been employed as a part-time dance instructor.
