





GRACIN is a Negro male, born in New Orleans

porter.

GRACIN saw a photograph of JAMES EARL MAY in "The Times-Picayune" newspaper on 5/8/68, which was reported to be the "latest photo of slay suspect."

An unknown man who looks identical to the latest published photo of RAY was a passenger on Southern Pacific Train # 2 en route from Los Angeles, California, to New Orleans, which arrived in New Orleans on Saturday during the early part of April, 1968, and which Saturday was on an "even-numbered" date in April. The day on which the train arrived in New Orleans was shortly after the nurder of Dr. KING. GRACIN is not sure; but he believes date of arrival of train was 4/6/68.

GRACIN boarded the above train in Lafayette, La., and began work. On the train, GRACIN and the above-mentioned man got into conversation with each other. The man told GRACIN he wanted to go to the Roof Garden Club on Monroe Street, off Bringier Street, Algiers - Gretna, La., near Jefferson Parish and Grleans Parish line. The man asked GRACIN how he could get to the Roof Garden by public transportation since the man had insufficient funds to hire a cab. During the conversation, GRACIN commented he lived in Algiers, and the man asked GRACIN if he would give him a ride to the Roof Garden. After thinking about it, GRACIN told the man he would give him a ride. The man was to wait for GRACIN in the train terminal in New Orleans.

After train arrived in New Orleans and GRACIN had completed his duties, he (GRACIN) went into the terminal to look for the man. GRACIN looked all over the terminal but he

could not see the man. About the time GRACIN decided the man had not waited for him and GRACIN was about to leave, the man came up behind GRACIN and asked GRACIN if he was ready to go. GRACIN does not know where the man could possibly have been in the terminal since he looked all over it for the man.

While going over the Miss. River Bridge, the man began talking about the racial situation in the U.S. and he mentioned the KING nurder case. The man commented that he "was sorry Dr. KING was nurdered." The man continued and expressed the view that Negroes would never be on the same leve as white people and that Negroes had insufficient education and training to reach that level. The man said he believed KING and other leaders of civil rights were fighting a losing battle. During his comments the man used the words, "Let's face it." When the man saw that his comments "angered" GRACIN, the man immediately changed the subject.

Just as GRACIN was leaving the Bridge, the man said he was not going to the Roof Garden but was going to visit his sister, who he said lived in the 400 block of Franklin Avenue, Gretna, La. GRACIN took the man to a house in the 400 block of Frankling Avenue, Gretna, where the man got out of GRACIN's car. GRACIN does not recall the exact address, but he said he could point out the house of mecessary. They arrived at the house at approximately 9, p.m., and the house was dark.

The man never gave GRACIN his name. The man said he had come from Los Angeles. GRACIN described the man as a white male, in late 30's or early 40's, 5'8" - 5'10", 180 pounds or more, dark hair, wore blue or black beret cocked on left side of head, were sport clothes—light sport shirt and light treusers. The man appeared to be traveling alone. The man carried a small suitcase—approximately 30" x 14" *** is size. The man did not smoke and he definitely did not have a Southern drawl.

GRACIN stated he has seen the publicable photographs of RAY and they have all looked familiar to him but he was not able to place where he had seen the man until he saw the picture on 5/8/68.

GRACIN advised that JOSEPH FOOTES, employed as a porter at the New Orleans Train Terminal say the above-mentioned man. GRACIN said FOOTES lives on Iberville Street, New Orleans, exact address unknown. FOOTES and ease on the train on which the man arrived.

GRACIN advised that it takes Southern Pacific Train # 2 forty-four (44) hours to come from Los Angeles to New Orleans. He said the train which arrives in New Orleans on Saturday Teaves Los Angeles between 8 and 9 p.m. the previous Thursday.

GRACIN stated that, if he is correct in that the date of the arrival of the train in New Orleans was 4/6/68, and if the man had ridden the train from Los Angeles, the man would have had to boarded the train in Los Angeles between 8 and 9 p.m., 4/4/68.





WANTED BY THE FBI



JAMES EARL RAY, also known as Eric Starvo Galt, Harvey Lowmyer, John Willard, James McBride, James Walton, W. C. Herron and James O'Conner.

James Earl Ray, a Missouri prison escapee, sought under the alias Eric Starvo Galt in connection with the gunshot slaying of civil rights leader Dr. Martin Luther King, Jr., is one of the FBI's "Ten Most Wanted Fugitives." FBI Director J. Edgar Hoover ordered the special addition of Ray to the "Top Ten" list to insure widespread dissemination of Ray's photograph and description to speed his location.

Ray has been intensively sought since the murder of Dr. King on April 4, 1968, as he stood on the balcony of a Memphis, Tennessee, motel. An exhaustive FBI fingerprint search, comparing latent fingerprints uncovered in the Dr. King case against finger-

latent fingerprints uncovered in the Dr. King case against fingerprints of over 53,000 persons on whom wanted notices were posted, determined that Galt and Ray are identical.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias of Galt, with conspiring to interfere with a Constitutional Right of a citizen. Ray, who escaped on April 23, 1967, from the Missouri State Penitentiary, is also sought for unlawful flight to avoid confinement for robbery. His long criminal record also includes convictions for hurglary and

also sought for unlawful flight to avoid confinement for robbery. His long criminal record also includes convictions for burglary and forging U.S. Postal Money Orders.

A white American, born in Alton, Illinois, on March 10, 1928, Ray is 5'10' tall, weighs 163 to 174 pounds, has blue eyes and short brown hair. He has a nervous habit of tugging at an ear lobe and his left ear protrudes noticeably. Known as a "loner" and "drifter," Ray has worked as a baker, laborer and color matcher. He has taken dancing lessons and completed a course at a school of hartending. of bartending.

Consider Ray armed and extremely dangerous. Report any information concerning him to the nearest FBI office.

On May 6, 1968, Mr. Charles I. Denechaud, Jr., an attorney located at 1412 Pere Marquette Building, New Orleans, Louisiana, appeared at the New Orleans Office of the Federal Bureau of Investigation, along with Mr. Cecil M. Shilstone. Mr. Denechaud stated he has represented Mr. Shilstone for many years and that Mr. Shilstone was insistent upon coming to the New Orleans Office of the FBI to provide certain information.

Mr. Shilstone stated he is president of the Shilstone Testing Laboratory. Inc., as well as president of the Shilstone and Associates, located at 814 Conti Street in New Orleans. He stated that in the past he has had an association with District Attorney Jim Garnison in regards to Garrison's probe of the assassination of Aresident John F. Kennedy. He said this association with Garrison was strictly to give financial support to Garrison's investigation. Mr. Shilstone said that at the inception of Garrison's investigation into the assassination of President Kennedy and prior to the time that Clay Shaw was arrested, Garrison needed money to conduct his inquiry. As a result, Garrison contacted Shilstone, as well as Willard Robertson and Charles Rauch (phonetic), requesting contributions. He said these three individuals, as well as others, whom he did not name, contributed money to Garrison and had formed a group known as "Truth and Consequences."

Mr. Shilstone stated his purpose in appearing at the New Orleans Office of the FBI was that in the past day or so individuals had told him there was a rumor going around New Orleans that Shilstone is the New Orleans industrialist and

"political killer" referred to in the New Orleans newspapers a week or so ago in connection with the murder of Martin Luther King. Shilstone stated he had read these articles in the New Orleans papers and that he had no idea as to how these rumors got started. He said the following individuals were personal friends of his and had contacted him and had told him about the rumors:

Harry Batt, owner and operator of Pontchartrain Beach Amusement Park

Louis Rousell, a New Orleans financier

Clem Seart, President of the National American Bank in New Orleans

A New Orleans physician whom he did not wish to identify

Mr. Shilstone stated that in the past he has been a political ally of Governor John McKelthen, Governor of Louisiana and had contributed to the Governor's campaign and had, in fact, "master-minded" the Governor's re-election for a second term.

Mr. Denechaud stated that about a week ago he was informed by Carlos Chimera, who is the operator of the Pere Marquette Garage, that Chimera had been informed by Joseph Dirosa that rumors were circulating that the person referred to in the newspapers as the New Orleans industrialist was Cecil Shilstone.

Mr. Shilstone stated he had no information in regards to the assassination of Martin Luther King, Jr., and that when the various people had told him about these rumors, he informed them there was nothing to these rumors. Mr. Shilstone stated he had not attempted to ascertain the source of the rumors. Mr. Shilstone related that he was concerned that these rumors.

One copy each of the airtel and letterhead memorandum are being designated for Dallas and Memphis as they are origin in the above cases.

During the time Mr. CECIL M. SHILSTONE, who is identified in the enclosed letterhead memorandum, was providing the information, he inquired as to whether he was under investigation in the MURKIN case. Mr. SHILSTONE was informed that no comment could be made; however, this was not to imply one way or the other, in that all investigations and information developed in any case investigated by the FBI was strictly confidential. Mr. SHILSTONE also inquired as to whether the FBI would make a statement that he was not involved in the MURKIN case and was again informed that the FBI had no comment.

Mr. SHILSTONE inquired as to whether his appearance at the New Orleans Office of the FBI would be made a matter of record and was informed that this would be done.

The files of the New Orleans Division contain several references in regard to Bufile 62-109060, relating to SHILSTONE. These references reveal that SHILSTONE was one of the organizers of a group of local New Orleans businessmen who formed an organization known as Truth and Consequences, which gave money to District Attorney JAMES GARRISON to conduct his probe. Other references in the New Orleans file reveal that SHILSTONE is president of the Shilstone Testing Laboratory which conducts various tests on winning horses at Louisiana race tracks.

BEFORE ME, the undersigned authority, personally came and appeared:

SAM J. RECILE

who being by me first duly sworn did depose and say:

That he is a resident of the City of New Orleans, Louisiana, and appears herein (at the request of Honorable Edmund E. Talbot, Referee of the U. S. Bankruptcy Court) for the purpose of making the following statements to relate certain events that have occurred since April 15th, 1968, immediately following affiant's testifying in the United States District Court in affiant's Bankruptcy Proceedings now pending before Judge Talbot;

While under examination by J. B. Kiefer and Edward Heller, Attorneys for Ingard O. Johannesen, Trustee, affiant stated, under oath, that on April 15th, 1968 he appeared at 501 Masonic Temple Building in the courtroom of Judge Talbot, Referee in Bankruptcy, pursuant to a subpoena duces tecum relative to a First Meeting of Creditors in the pending bankruptcy proceedings, and testified as to preliminary matters involving said proceedings;

That on Tuesday, April 16th, 1968, at about 11:00 A.M., the said First Meeting of Creditors was reconvened and affiant again testified under oath. Numerous questions were asked by Messrs. Kiefer and Heller, Attorneys, all of which affiant was required to answer and did answer to the best of his recollection. Also, in accordance with a subpoena duces tecum, affiant had produced certain records, etc., and when affiant was questioned concerning said records, he testified with respect to the transactions that were reflected by said records, etc., including transactions that affiant had, individually and on behalf of one or more of the corporations controlled directly or indirectly by him with Louis J. Roussel who acted individually or on behalf of one or more corporations which he represented or controlled. In this connection, affiant testified that Louis J. Roussel attempted to take over assets valued (as reported by the Times-Picayune) at approximately \$3,900,000.00, for \$225,000.00, the said assets representing shares of stock in a corporation known as Louisiana Citrus Lands, Inc. All details of this transaction were related in affiant's testimony, particularly the methods which Mr. Roussel had

used, including certain part proceedings still pending in the Civil District Court for the Parish of Orleans, entitled "Gulf Natural Gas Co. vs. Sam J. Recile" and "Sam J. Recile Reconventional Demand against Gulf Natural Gas Co., Louis J. Roussel, et als". (No. 456-272). During said examination, under oath, certain other questions were asked pertaining to other transactions between Roussel and affiant (individually and on behalf of one or more companies in which affiant had an interest). These questions were answered to the best of affiant's ability and, where full information was not readily available, affiant referred to the files and agreed, at counsel's request, to prepare the information with documentation wherever possible for further testimony at a later hearing. Most of the documents referred to will be found in the files that were turned over to Mr. Albert J. Ward, Jr., Trustee, and Hon. Frederick J. R. Heebe, Judge, in the Chapter XII Proceedings filed by affiant and were, when affiant was testifying and still are, therefore, in the possession of the United States District Court. At approximately 4:00 P.M. the Hearing ended and affiant returned to his office at 510 O'Keefe Avenue in the City of New Orleans.

Affiant further states that he left his office at approximately 6:00 P.M. (April 16th, 1968) to go to his home at 6225 Paris Avenue, where he resides with his wife and children. At approximately 2:00 A.M. on Wednesday, April 17th, 1968, affiant received a telephone call at 288-7678 (one of the two telephone numbers which he has at his home - the other number being 288-7677, both of which are unlisted and have been for approximately the last 7 years). Affiant answered the telephone and the party on the other end did not say a word; however, in the background, in a loud and boisterous voice, one or more voices stated "yes, he's at home" and hung up. Affiant purposely did not say anything other than "hello" because affiant did not wish to awaken his wife. Being concerned, affiant tried to go back to sleep and may or may not have slept but at 4:00 A.M. the call was repeated, during which approximately the same events occurred. At that time, affiant did ask "who's calling?" The party on the line hung up but affiant was unable to go back to sleep since he was fearful for the welfare of his wife and children. Affiant, therefore, called Frank Spalitta and repeated said incidents to him en route to the office that same morning.

Affiant furth, states that he arrived at his enfice at 510 O'Keefe Avenue, between 7:00 and 8:00 A.M., (April 17th, 1968) and shortly after 8:00 A.M., affiant received a telephone call from one Manfred Sternberg. Mr. Sternberg identified himself to affiant (and affiant well knows Manfred Sternberg's voice). Manfred Sternberg's opening statement was "Hello Cousin", a phrase which Sternberg has used in dealing with affiant for a number of years. Affiant and Sternberg first exchanged the time of day and Sternberg then stated that he had not talked to affiant for some time but was interested, of course, in the various developments in the reorganization, his interest being both as a creditor and as an admitted admirer of the things affiant had done for the City of New Orleans. After these first remarks, Sternberg said he was calling to give affiant some very serious advice which affiant may or may not accept; however, he (Sternberg) felt that affiant should consider it. Sternberg then stated that he had read the reports of affiant's testimony at the bankruptcy hearing and he wanted to advise affiant to "take it easy on Mr. Louis J. Roussel - that Mr. Roussel was a very dear friend of his (Sternberg) and an associate and that the testimony being given by affiant was ruining Mr. Roussel and that he did not appreciate it nor did Mr. Roussel". Sternberg further stated that Roussel was a powerful man and that it would be to affiant's best interest to stop testifying.

- Affiant told Sternberg, in the presence of Frank Spalitta and J. J. Morrison, affiant's attorney, that affiant was testifying in a bankruptcy proceeding, under oath, and was giving evidence and supplying documents in accordance with subpoenas - that it was and has always been affiant's intention to tell only the truth and to that end whatever questions were asked of him he would answer to the best of his ability and whatever documents were subpoenaed he would produce if they were in his possession. Sternberg then related to affiant that he felt that affiant was much smarter than that and should realize the power that Louis J. Roussel commanded in this community and that he could very well be ruining any possibility of ever working out any reorganization; and Sternberg then stated that he knew affiant had been working very feverishly in attempting to effectuate a plan of reorganization with one or more parties, all to no avail; that Mr. Roussel was the party who could make or break any plan and Sternberg explained as a for instance, the Hughes Plan, which he said had failed because Mr. Roussel would not go along with it. Sternberg also said: "I, as a creditor, would be more than happy to receive 50% of my money, since I have made many thousands of dollars with you and your companies; how. ever; the Hughes Plan of 5.5 million on Baton Rouge properties was only suggestive of more money coming -- I would have taken not only half but I would have been willing to take stock in a company and I am now willing to do these things but you must stop testifying against Roussel." With that, Sternberg asked who the "Franchard people" were and affiant stated that they were a public company under the control of some 18,000 stockholders and were very sound, in his opinion, and knowledgeable in dealing with and owning real estate in the United States and Canada. Sternberg then stated to affiant that if the Franchard Plan went through, it would most likely be one way for affiant not to further testify but affiant told Sternberg that he would continue to testify so long as Judge Talbot required affiant's appearance in the matter. With respect to Sternberg's comments about the Franchard Corporation, affiant thanked Sternberg and suggested to him that if he had any further suggestions, he should call one or more of the men who were acting as informal committeemen pursuant to an offer made to C. Ellis Henican, Chairman of said Committee, and to affiant's knowledge, Mr. Henican had, pursuant to the said offer from Franchard, requested capable and knowledgeable men such as John Oulliber, President of the National Bank of Commerce, Clem Sehrt, Vice Chairman and former President of the National American Bank, Moise Steeg, Attorney, and others and that these men had offered to help by giving advice and that any one of these men would be in a position to consider his suggestions and, possibly, put them to good use if he desired to contact them. Sternberg reassured affiant that he wanted to do anything he possibly could to assist in this matter and at that point the telephone call ended.

(About midway during the conversation with Sternberg, Spalitta walked in with Morrison and handed affiant a note asking "who are you speaking to"? and on the same note affiant wrote the name "Sternberg". With that, Spalitta and Morrison, with affiant's knowledge and consent, got on the extension phones. When this happened, Sternberg asked who was on the 'phone and Spalitta said "hello" to him. Spalitta and Morrison are available to confirm, under oath, the part of the telephone conversation mentioned above which they heard.)

On Wednesday, April 17th, affiant was preparing information pertaining to subpoenas regarding various mortgage transactions that he had made, individually or on behalf of one or more of his corporations. One of such

mortgages involved money at affiant had borrowed from Sarnberg, or one or more of his entities, which had been negotiated by Louis J. Roussel. The plan that was set up by Mr. Roussel was that affiant was to loan Sternberg some money with money that Mr. Roussel was loaning to one of affiant's corporations and, in return, Sternberg would loan to affiant a larger amount and receive a higher rate of interest than the Bank would charge, i.e., the National American Bank, and Sternberg would borrow his money from the National American Bank. This transaction was one where the files were not readily available since most of the files had been forwarded to Judge Heebe and Mr. Ward, so affiant called Sternberg and asked him if he could make available copies of the papers concerning this particular transaction. Sternberg advised affiant that he would be most happy, as he had previously told affiant, to cooperate in any way that he could but asked "what the hell do you want these records for?". Affiant explained to Sternberg that he was preparing information in compliance with a subpoena and that affiant's records were not all available at that time and affiant thought that possibly Sternberg could assist him by giving him photostatic copies of the papers on this particular deal. Sternberg stated that his records were in Baton Rouge but he would use his best efforts to obtain the copies. On the same day, Sternberg called back and stated to affiant that he had contacted Baton Rouge and that all he had were just his promissory notes but that all of the other papers and files had been destroyed. At this time, Sternberg became very emotional. At that time Mr. Morrison, Mr. Spalitta and Mr. Gerber, Chicago Counsel, were in affiant's office. Mr. Spalitta, at affiant's request, picked up the extension telephone and affiant pulled his hand telephone away from his ear so the whole conversation could be heard by Messrs. Morrison and Gerber. At this point, Sternberg stated "you are trying not only to ruin Mr. Roussel but me, and let me tell you one goddamn thing what you don't know and you should know is that Louie is a very powerful man. He is my friend and Sehrt, Judge Boyle and a lot of other powerful people are behind him and you are wasting your time. If you are trying to prove usury, as far as my loans are concerned, or any of the Roussel loans are concerned, I will take care of that. I know J. B. 'Kiefer and I know who he owes money to and I will take care of that bastard. I will have all his damn loans called. My lawyer will handle Mr. Kiefer and you can rest assured that Mr. Roussel can

likewise handle Mr. Kiefer so you just go ahead and forger about these records of ours and you take some good advice if you know what is good for you and stop testifying and digging in any matters pertaining to deals that I made with you or Roussel and I made with you. You are wasting your time. I have already told you there is only one man in this community who can make or break any reorganization and that is Louis J. Roussel and you should know that by this time and if you don't know it by now you are dumber than I thought you were and not as smart as I thought you were". Affiant explained to Sternberg that he was not interested in all of his advice nor his yelling, as he was, but that affiant was testifying in the Federal Court and he was going to tell the truth and that all of his records were now the property of the Federal Court and any questions that were being asked relative to any transaction (whatever it may be), were going to be answered by affiant, under oath, to the best of his ability. Sternberg broke in and said "but there is no reason in the world why you have to ruin people like our friend Louie because you are just burying your own self". Affiant replied" "Manfred, if you are threatening me, it won't do any good. You will have to first kill me and bury me face down but I will not do anything other than tell the truth and I don't appreciate your intimidation." He said, "take it as you wish". With that, the conversation ended.

Affiant left the office that afternoon and, at approximately 10:00 P.M., received another call on No. 288-7678. The party started, without asking affiant's name, by merely saying "you no good bastard, you keep testifying and running off your big mouth and we will take care of you. You think you are smart". He then hung up. At approximately 2:00 A.M., another call was received on the same number and a very sharp male voice stated "you bastard, when are you going to learn to stop ruining your friends" and hung up.

On Thursday, April 18th, shortly after 8:00 A.M., with Spalitta, Gerber and Gene Leslie, affiant arrived at his office and as affiant was getting out of the automobile, he was surprised to see Manfred Sternberg on the side walk. Sternberg said he was very happy to see affiant and then asked affiant to walk with him to the corner of O'Keefe and Poydras. Sternberg then said, "I see you are still battling" and asked what was new with "Franchard". Affiant told Sternberg that Franchard was still working with the possibility of reorganizing the various properties and, with that, Sternberg again advised affiant that he was trying to help but affiant should shut his big mouth and not

antagonize the only man the world who could cause the organization to make or break and that was Roussel. He also said, "your testimony has caused me to be walking down this street this morning -- I can't even have coffee with Louie -- he is like a maniac. You are ruining his life. Louie was your friend. You are going to have to quit testifying against him. Now I'm telling you what you should do -- you take it or leave it. I think you are very foolish and you are going to have to suffer the consequences and your children and family are going to be ruined". Affiant reiterated to Sternberg that he was merely telling the truth on the witness stand and so long as he was forced to appear and testify, he had no control over the matter but that he owed it to himself, to his family, to the community and to the court to give whatever information was requested to the best of his ability. Affiant and Sternberg became boisterous and at Spalitta's suggestion, affiant withdrew by telling Sternberg that affiant had a meeting and had to excuse himself.

Affiant then went into his office (at 510 O'Keefe) and, at about 8:45 A.M., he went to Judge Gertler's office regarding a matter involving Plaza Tower, and later went to Judge Marcus' office concerning 6225 Paris Avenue.

(Both offices were in the Civil District Court Building in the Civic Center).

These matters were concluded at approximately 12:10 P.M. At 1:00 P.M., affiant was due in Judge Talbot's Court. Affiant came back to his office with Messrs.

Gerber and Spalitta. At 1:00 P.M. affiant went to Judge Talbot's Court and testified from 1:00 to 4:00 P.M. At that time, affiant's testimony was relative to City Investments Co., Inc. and about certain property which affiant had agreed to purchase in the 1000 block of Bourbon Street. Affiant stated that title to this property had been taken in the names of John Toler and Dr. Francis LeJeune and that he was to receive a counter letter from them setting out affiant's undivided one-third interest in and to said property.

Affiant returned to his office shortly after 4:00 P.M. and received another telephone call from Manfred Sternberg. Sternberg stated that he wanted to first congratulate affiant on being able to stop the Plaza Tower Sale and the sale of affiant's home at 6225 Paris Avenue. He called it the "coup de coup". Affiant did not respond to these statements with a direct answer and Sternberg immediately asked: "Is Franchard still in the deal?" and affiant said, "I hope so -- I only wish I had more time to work with Franchard instead of being in court". Sternberg then asked "When are you going back to court"

and affiant told him he would be back the next day and Sternberg said, "I want to give you some good advice". At this point, Messrs. Gerber, Morrison' and Spalitta were in affiant's office and he put the telephone where they could all hear. Sternberg said, "you are gonna have to take it easy on Louie. If you don't you are gonna ruin that man - you are gonna ruin me - and let me tell you one thing - that guy has power. You are dealing with Judge Boyle and Clem Sehrt. Louie has some real power and they are going to bury you. You go ahead and keep testifying against him and you are going to ruin us." At that time affiant lost his patience and told Sternberg that he didn't appreciate his threats - that he had been receiving threats nightly at his home and they were in the same category as those Sternberg was then making and if he or Mr. Roussel wanted to intimidate affiant in an effort to get affiant to change his testimony, they would have to kill affiant and affiant again told Sternberg that he would appreciate not receiving any more of his telephone calls or threats and affiant then hung up. Sternberg called back but Messrs. Gerber, Morrison and Spalitta advised affiant not to take any further calls from Sternberg and affiant took the advice.

Following affiant's testimony in open Court on April 16th, 1968, a news release appeared in the April 18th, 1968 issue of the New Orleans States-Item of a statement made by F. D. V. de la Barre, Attorney for Louis J. Roussel, in which it was stated that the Gulf Natural Gas Corporation, (controlled by Mr. Roussel) had no interest in acquiring affiant's shares in the Louisiana Citrus Lands, Inc. and would gladly release the shares upon receiving \$225,000.00 plus interest and attorneys' fees, and that if the shares were put up at public sale, the Gulf Natural Gas Corporation would not bid one cent more than that for them.

Affiant testified under oath at the Bankruptcy Court, on April 19th, 1968, from about 10:00 A.M. to approximately 2:00 P.M., without interruption. During the examination, affiant was questioned by J. B. Kiefer, Attorney for affiant's Trustee, concerning de la Barre's statement. Affiant disagreed with the said statement, particularly that portion which stated that Gulf Natural Gas Corporation had no interest in retaining affiant's said shares provided it received \$225,000.00 plus interest and costs, and, in support of affiant's disagreement, affiant referred to the two letters dated November 27, 1967 and November 29, 1967, written by Peter J. Butler of the firm of Schrt, Boyle and
