A search of the subject a room, located a .765 caliber Belguin Browning Automatic, Serial Number 57195, which contained one live cartridgesds the chamber and five live cartridges in the clip. A second .38 caliber revolver, American Double Action, five shot revolver; Serial Number 249, was also located and found to contain three live cartridges in the cylinder.

Upon questioning, JAMES EARL RAY admitted that he was the owner of these weapons and made the statement to the officers, "I guess you want me for that Kroger Store stick-up." RAY was thereafter conveyed to City Hospital for examination and found to be suffering from a laceration of the scalp, which was not considered to be serious; and with no other apparent injuries. He was thereafter conveyed to the Police Station where he was charged:

The second individual involved in the burglary, JAMES OWENS, was conveyed directly from the place of apprehension to the St. Louis Police.

The 1958 Plymouth sedan used in the commission of the robbery was determined to be the property of JAMES L. OWENS and was towed away from in front of the Park Avenue address and held in custody by local pelice.

When questioned further at the District Station, OWENS stated he had first become acquainted with JAMES EARL RAY about three months prior to the offense, having met him at the St. Louis Rescue Mission located at 4023 Glive Street. Both eventually began speaking to each other of financial difficulty and eventually came to an agreement to pull a hold-up.

OWENS advised that in the early p.m. of October 9, 1959, he and RAY "cased" the store, which they eventaully robbed on the following day. OWENS admitted that JAMES EARL RAY had given him the suub-mose revolver which he had used in the hold-up and that he had driven RAY to a place where he let RAY out of his 1958 Plymouth automobile for the purpose of stealing a second automobile to use in the hold-up.

Both automobiles were then driven to the intersection of Indiana and Potomac Streets in St. Louis. The stolen car, the previously mentioned Ford, was then driven to the scene of the crime, and the store was entered by both men.

RAY proceeded to a small office located in the front of the store, where he pointed the automatic pistol he was carrying at the man in the office, commanding him to open the safe. OWENS remained close to the front door where he acted as a look-out and, according to OWENS, left his revolver in his coat pocket. OWENS stated after RAY failed to get the man in the office to open the safe, he pointed the automatic pistol at a woman cashier, ordered her to step aside, and then reached into the open cash drawer, removing an unknown sum of currency. Both men then left the sotre and departed in the stolen Ford automobile.

A switch was thereafter made and both men then drove to RAY's home in OWENS' 1958 Plymouth.

Upon arrival, they proceeded to the bathroom of RAY's home where OWENS returned RAY's revolver and RAY gave OWENS \$60.00 in six \$10.00 bills, which constituted OWENS' share of the money taken in the robbery. OWENS then left RAY's residence and proceeded to his automobile where he was placed under arrest.

RAY, when interviewed, refused to make any statement, but OWENS later viewed RAY and positively identified him as the man who had accompanied him to the Kroger Store and assisted him in the commission of the hold-up.

Both individuals were thereafter charged with robbery with a deadly weapon and operating an automobile without the owner's consent. An additional charge of resisting arrest was placed against RAY.

The St. Louis Police Department, Bureau of Records, had no information on JAMES EARL RAY, but the report reflects

that RAY acknowledged a 1951 robbery at Chicago, Illinois, for which he was sentenced to twenty-one months in the Pontiac Reformatory and a 1955 arrest for transportation of forged documents, for which he received a sentence of thirty-four months to the Federal Penitentiary at Fort Leavenworth.

AT STALOUIS WISSOURI:

The following investigation was conducted by SA JOHN O. THATHEWRY, JR. on May 7, 1968:

Wh. EDMOND HATTON, 2023 Park Avenue, advised he had purchased the building at that address in August of 1960. He has never seen JAMES EARL RAY and was not aware of his existence until recent publicity.

He stated Mr. E. C. COWLET who lives in an upstairs room at that address was living in the building at the time RAY was arrested there in 1959. A Miss JONES, present address unknown, also resided in the building at that time. The building was previously owned by a Mrs. G. MC LAUGHLIN who still resides in the St. Louis area but whose exact address was unknown to him.

Mr. E. C. COWLEY, Room 8, 2023 Park Avenue, advised the had occupied Room 5 at that address which was adjacent to Boom 6 which was occupied by RAY at the time of his 1959 Kroger robbery arrest. Mr. COWLEY had no contact with RAY. RAY had only been in the room for approximately three days at the time of the arrest. Mr. COWLEY recalled that on the morning of RAY's arrest he had observed two young men, one of whom was probably RAY, go into RAY's room just before he left for work that morning at approximately 9:00 a.m. That was the last he ever saw of RAY as he COWLEY, had been at work at the time of the arrest.

He was unable to recall the identities of any other tenants who had resided there at the time of the arrest except for a Mrs. G. MC LAUGHLIN who was owner of the building at that time and a Miss JONES who currently resides in the heighborhood but whose address is unknown.

Mr. W. M. HOOD, 2031 Park Avenue, advised he and his wife had witnessed the policemen in the yard at the house next door at the time of RAY's arrest in 1959, although they never saw RAY. He was unable to recall the identities of any other residents of the building at that time. He never saw RAY and had no information concerning him.

Mrs. REUBEN CRAFT, 2015 Park Avenue, advised she had resided in that area for approximately the past four years; that she had never seen subject and never heard of him until recently; and that she had no information concerning him.

The current residence of Miss LORETTA JONES, who formerly resided at 2023 Park, was determined to be 2335 Park Avenue, however, repeated attempts to contact her at that address proved fruitless.

Mrs. G. MC LAUGHLIN, 3020 Hawthorn, advised she had formerly owned the building at 2023 Park Avenue. She said that RAY had resided there less than a week prior to his arrest in 1959, and that she had no prior or subsequent knowledge or information concerning him.

PIXON advised that he stayed at the Rio Hotel, Puerto vallantol Mexico, from October 20 to 22, 1967. He and his wife, GLORIA, flew to Puerto Vallanto from Guadalajara, Mexico, via Mexicana Air Lines. They met friends, Mr. and Mrs. BEN LAPIN Of San Francisco. California at the Rio Hotel. DIXON thinks that he and his wife occupied Room #206.

DIXON viewed photographs of JAMES EARL RAY as depicted on FBI Wanted Flyer #442A, dated April 19, 1968. He advised that he does not recall having seen this man at the Ric Hetel. He could furnish no information concerning RAY.

On April 30, 1968, GLORIA L. (Mrs. RICHARD) BIXON, nee BRITTON, 13000 Voodley Lane, St. Louis, was interviewed at 8701 McKenzie Road, Affton, Missouri, where she is employed as a secretary to the Superintendent of Affton Schools.

Mrs. DIXON furnished essentially the same information as her husband. She viewed photographs of JAMES EARL RAY as depicted on FBI wanted Flyer #442-A. She stated that she doesn't recall having seen RAY at the Rio Hotel during October, 1967, and could furnish no information concerning RAY.

Mr. RAS NEWSOME, Supervisor, Reservations Sales, Trans World Airlines, Inc., 440 Mansion House Center, Fourth Street and Vashington Avenue, caused a search of his company's records to be made regarding TWA flights 489, 529, and 537 which departed Atlanta, Georgia, on April 5, 6, 11, and 12, 1968. This search failed to reveal that any passenger giving a name W. C. HERRON, JAMES MC BRIDE, JAMES O'CONNER, JAMES WALTON or JAMES VALYOU rode any of these flights. An additional search regarding persons who made reservations and cancelled them was also made for the above names on the above flights without effecting an identification. All of the above flights departed as scheduled except flight 489 on April 11, 1968, which was cancelled because no equipment was available.

Mr. IRVIN STRICKLAND, Supervisor, Reservations Sales, TWA, placed stops for the names JAMES EARL RAY, ERIC STARVO GALT, W. C. HERRON, HARVEY LOWHYER, JAMES MC BRIDE, JAMES O'CONNER, JAMES WALTON, JAMES WALYOU, and JOHN WILLARD with all reservations agents employed by TWA at St. Louis, Missouri.

On April 25, 1968, Mr. BAUL FICE, formerly employed as Director of the Exit, a so-called Christian coffee house. Located in Gaslight Square, StatLouis, Missouri, at Boyle and Olive Streets, now employed as a teacher. University of Missouri at St. Louis, was contacted by SAA HOWARD C. KENNEDY at the YMCA, Fifteenth and Locust Streets, St. Louis, where he was then teaching. He furnished the following information.

He is very well acquainted with many persons frequenting the Gaslight Square area having been employed as Director of the Exit for several years. He resided in that area during the entire time. In his opinion there are no nippie rooming houses located outside the area of McPherson Street between Boyle and Taylor. Almost all of the rooming houses located in that area are at times occupied by hippies. He estimated that there are about 100 "hardcore hippies" living in the St. Louis area, and all of them are located on McPherson Street. There are perhaps several hundred young persons who are generally known as weekend hippies or "plastic hippies", but in his omnion, these persons are attending school as students or employed in industry in this area and are not to be confused with bons fide hippies. Mr. PICK was unable to furnish any information concerning JAMES EARL RAY, whose photograph was exhibited to him as was descriptive information concerning RAY.

RE PRIBON-ASSOCIATE VALUER E. NOLAN

The following lavestigation was conducted by SAS ROBERT A. HESS and PATRICK W. BRADLEY on April 24, 1968, at St. Louis. Niesouri.

Mr. SAM KRAMER was contacted at his place of business, the Plaza Buffet, 18th and Chestnut Street, St. Louis,
Missouri, at which time he advised that he is not in fact
an uncle of former Missouri prison immate, WALTER E. NOLAN,
however, is commonly referred to as an uncle by NOLAN because
in the past he and his wife have made efforts to rehabilitate
and befriend NOLAN.

He stated that last fall (1967) NOLAN was again released from the state penitentiary, however, since that time he (KRAMER) has made no further attempt at rehabilitation of NOLAN. He stated that occasionally NOLAN comes by his place of business, the last time being Saturday. April 20, 1968, at which time he cashed a \$10 check drawn on the State Bank and Trust Company of Wellston, Missouri.

He stated that it is his understanding since NOLAN's release he has worked as a baker at Hullings Restaurant, 8th and Olive, and worked subsequent to that for a few weeks on a part-time basis as a cook on a river boat, barge line name unknown. Mr. KRAMER stated that he has no knowledge as to his current employment or current residence address.

Mr. KRANER stated that his residence may be known to newscaster LES CARMICHAEL. KMOX Television Station. Mr. KRAMER pointed out that CARMICHAEL was in touch with NOLAN obtaining historical data regarding his lengthy imprisonment primarily for a human interest news-type story.

LES CARMICHAEL, KMOX TV, 1215 Cole Street, St. Louis Missouri, advised that last fall he noticed an article in the newspaper regarding a prisoner writing his own brief and getting a release from prison and this article slauted the version to the point where it appeared the man might have been unjustly imprisoned. As a result of this he contacted 2 St 44-775

WALTER E. NOLAN the ex-convict in question in an effort to obtain some human interest story for a news item. He noted that he contacted NOLAN through a well-known St. Louis attorney whose name he could not immediately recall but whose name was either in the newspaper article or came to his attention as NOLAN's representative from some other source. Mr. CARMICHAEL also related that the reason why he followed up this was because when he contacted the attorney, the attorney spoke highly of NOLAN's intelligence and his legal ability in the preparation of legal briefs.

Mr. CARMICHAEL stated that after a number of contacts with MOLAN he did not feel that there was sufficient human interest in the matter to follow it any further and just left it drop. Mr. CARMICHAEL stated that in his conversations with NOLAN as he recalls NOLAN was a highly intelligent individual, was not radical or an extremist in any manner with the exception of having an extremely hostile attitude toward the authorities at the various penitentiaries he has been in. Mr. CARMICHAEL reiterated that NOLAN never displayed any racial extremism emotion. Mr. CARMICHAEL advised that at no time does he ever recall NOLAN mentioning JAMES EARL RAY as an associate or friend in prison.

The following information is confidential and can only be obtained by the issuance of a subpoena duces tecum issued to HENRY E. CLABOUGH. Manager, Bookkeeping Department, State Bank and Trust Company of Wellston, Wellston, Missouria

Mr. HENRY E. CLABOUGH, Manager, Bookkeeping Department, advised that they have an account in the name of WALTER E. NOLAN, giving an address in care of Mrs. CARMEN PATTON, 5266 Washington Boulevard, St. Louis; Missouri, 63108. Mr. CLABOUGH stated that this checking account has a current balance of \$18.34 and was opened in November, 1967. Since November, 1967, the average monthly balance has been \$17. Mr. CLABOUGH stated there are no major deposits nor withdrawals, the last deposit being made on April 16, 1968, in the amount of \$113.26.

Mr. CLABOUGH stated that their central indices do a not reflect any other accounts nor do they reflect that this individual has a safety deposit box at this bank.

Mrs. CARMEN PATTON, 5206 Washington Boulevard, St. Louis, Missouri, telephone #FO 1-5462, advised that WALTER E. NOLAN resides as a roomer at this address. Mrs. PATTON stated that because of the newspaper publicity at the time of Mr. NOLAN's release from prison she is aware of his background as an ex-convict. She pointed out, however, that he is extremely quiet, mannerly, and appears to be a regular working individual. He does not have associates frequenting the rooming house and although she has no knowledge of his current employment he is employed somewhere as a cook and usually arrives home around 5:00 p.m.

Mrs. PATTON pointed out that he has been attempting to get some type of job with the Anti-Poverty Program and she displayed a note that had been left earlier this date to Mr. NOLAN which indicated that he should report ready for work in connection with the proverty program at 2420 Cass Avenue at 9:00 a.m. on April 29, 1968.

On April 24, 1968, IC JOHN D. DYER, JR. checked the records of the St. Louis Police Department and determined that under their #18295 and FBI #41847, WALTER ELISWORTH NOLAN has the following record:

At the onset of the interview SAs PATRICK W. BRADLEY and ROBERT A. HESS identified themselves to WALTER E. NOLAN in the looby of the rooming house where he resides. After being advised of the identity of the interviewing agents he stated. "I want nothing to do with you people.", and then said. "What do you want with we?" I haven't done anything since I've been out.

Mr. NOLAN was advised that we were not investigating his activities, however, we were conducting a fugitive investigation to locate one JAMES EARL RAY, a former inmate of the Missouri State Penitentiary. At this point NOLAN stated, "I remember Jim Ray but I don't know anything about him now and if I did know anything about him I wouldn't tell any representative of law enforcement."

It was pointed out to NOLAN that the agents had spoken earlier in the day to acquaintances of NOLAN who spoke very highly of NOLAN's intelligence and ability in legal research and briefs. Therefore, he should have a clear understanding of the possible consequences of harboring a fugitive

NOLAN stated that he had nothing to do with the escape of RAY and has not seen or heard from RAY since the Saturday before he left from behind the walls of the Missouri State Penitentiary.

At this point NOLAN volunteered that he knew JIM RAY approximately 10 years, the entire acquaintanceship being made and carried on in the Missouri State Penitentiary. He pointed out that he was aware of RAY planning to escape on the three occasions that he attempted to do so, however, was not aware of the details of the plans nor was he aware of the exact time that RAY planned to go. He noted that he resided in the same hall with RAY although both he and RAY were celled individually, not having cellmates. He further noted that RAY was gone approximately 30 days from the penitentiary before his escape was reported and during that 30-day period on a daily basis he was reported present in the hall when he actually had already escaped.

NOLAR stated that he believes that he (NOLAN) was the closest associate that RAY had his the benitentiary and walked in the yard with him daily. He pointed out that RAY in effect was a loner with no one really close to him. NOLAN stated that even though he considered himself the closest friend of RAY, RAY never really told him any personal information other than on one occasion he mentioned that he had an unnamed brother in Chicago; Illinois, and allegedly was raised in a small lown in the State of Illinois.

NOLAN stated that RAY was a loner in his opinion because he felt all convicts were potential "stool pigeon material" and he did not trust any of them because he had been "done in a couple of times" by the stool pigeon system that operated in the prison. At this point NOLAN noted that it was his opinion that if RAY saw one of his former follow-convicts he would immediately leave the area for fear of that individual turning "stool pigeon." He continued indicating that he felt RAY would never contact a former fellow-convict for this reason including himself.

With regard to RAY's last escape from the penitentiary he stated that it was not as reported that RAY left in a bread box because he knew it to be a fact that RAY walked out the front door of the prison. He would not go into further details regarding this statement. When questioned as to whether or not he meant there was a bribery in connection with this escape he stated that he did not mean it in this manner, however, would not slaborate.

With regard to RAY's prior escape attempts. on one escape attempt charge he pied insanity as his defense and subsequently was sent to Fulton Mental Hospital for observation and after a short period of time was returned to the Missouri State Penitentiary adjudged sane.

With regard to RAY's emotional feelings he stated that JIM RAY was not an extremist, he never knew him to be emotional over anything; and if JIM RAY is responsible for the death of Dr. KING he feels that he was completely out of character with the person he knew as JIM RAY in the Missouri State Penitentiary. He described RAY's demeanor as being

that of a cynical individual, however, the cynicism always being in a humorous vane. NOLAN pointed out that RAY had the unique ability of being able to laugh at himself and be cynical in a humorous way about his own past mistakes.

NOIAN pointed out that the majority of the conversation between him and RAY had to do with their legal research in regard to preparing briefs for themselves in an attempt to gain freedom from prison. He pointed out RAY was extremely interested in law, especially if it concerned his particular case. This interest was to the extent that RAY spent extra moneys to purchase law books and literature regarding recent court decisions.

NOLAN again reiterated that he felt that RAY would never contact him and doubts that RAY even knows his current location, however, he reluctantly agreed to notify the FBI if he was contacted by RAY because of the possibility of a law violation which would cause him (NOLAN) to return to prison which he does not want to do.

He noted that in the preparation of the brief by which he was released he had obtained the services of Attorney ORVILLE RICHARDSON in St. Louis for arguing the brief through approaching a judge by letter and suggesting the appointment of one or five attorneys by which ORVILLE RICHARDSON was the appointed one.

NOLAN indicated that he is currently employed as a second cook at the Heritage House Restaurant in St. Louis, however, is going to work in connection with the poverty program on April 29, 1968, in St. Louis noting that he is doing this at a reduced salary in an effort to help others rehabilitate themselves.

He again noted that he never knew of RAY to have any racial extremist emotions or ideas particularly pointing out that during part of the time RAY was in prison he was employed in the kitchen with many members of the Negro race and he always spoke well of anybody who held up their own end of the work regardless of their race. He never expressed any animosity toward anyone because of their color.

She stated she has since remarried and since her divorce from DRAKE has had no contact or communication from him.

She supposed that subsequent to his release he would return to St. Louis, Missouri, where his mother, OLLA DRAKE, resides on North Ninth Street.

JOHNSON: While an inmate in the Missouri State Penitentiary (MSP), DRAKE became acquainted with JAMES EARL RAY and subsequently became good friends until DRAKE's release in June, 1965. Their main association at the prison was when they got together in the prison yard and conversed while walking for exercise. During this association, DRAKE feels that he became as close a friend to RAY as anyone at the prison. He described RAY as a "loner" and "close-mouthed", who kept his own counsel and did not even mention his planned escape which DRAKE later learned was an unsuccessful attempt by him to go over the wall on a ladder. RAY had very few friends, however, he mixed well with other inmates, both black and white, and had never shown any propensity for violence or appeared to be a racist. DRAKE said there were several instances of racial trouble at the penitentiary, but RAY never seemed to get involved or to express his fellings in the matter one way or another. RAY often mentioned that he could not do his twenty year sentence, but never indicated any escape plans or any contacts with outside individuals. The only member of RAY's family he referred to was his brother, JACK RAY of St. Louis. DRAKE recalled JACK visited his brother at prison on the average of possibly once a year. DRAKE vaguely recalled RAY mentioning that he had another brother who was killed in an automobile accident in northern Missouri, but did not recall RAY mentioning any other relatives. RAY did not discuss his general background, other than mentioning on several occasions he had previously done time at Menard State Prison, Chester, Illinois. RAY was not addicted to use of drugs, however, DRAKE said nearly all inmates "fooled around" with anything they could get their hands on and that if RAY used any form of drugs it was unknown to DRAKE. 143 2025 RELEASE UNDER E.O. 14176

SL 44-775 WCJ/ral DRAKE said about two weeks after his release in June, 1965, he visited JACK RAY in St. Louis upon the request of JIMMY and this was the last time he saw JACK. Their conversation primarily concerned JIM's welfare at the MSP. DRAKE had no heard of RAY's escape and presumed he was still in prison until the recently publicity about him. DRAKE regards RAY as a small-time robber, mentally incapable of planning the assassination of Dr. MARTIN LUTHER KING without additional intelligent guidance from some other source. He believes RAY capable of being hired for this but would certainly not be alone in this matter. He is also of the opinion that whoever hired RAY, that person or group has disposed of him. He commented with the "heat" on RAY and rewards advertised, it would be extremely difficult for a fellow like RAY to hide. DRAKE indicated he would cooperate in any way he could with the FBI in the event any information came to his attention regarding the whereabouts of JAMES EARL RAY. CARL DRAKE said his brother, JAMES FRANCIS DRAKE, was also an inmate at the MSP and was acquainted with RAY through their association in the exercise yard. DRAKE, his brother JAMES and RAY all walked together on many occasions. JAMES FRANCIS DRAKE was released two years before CARL and later served time at Terre Haute Federal Prison being released in November, 1967. CARL said his brother JAMES resides with his mother, OLA DRAKE, at Modesta, Illinois, and is currently employed at the Valley Steel Company, Jacksonville, Illinois. 2025 RELEASE UNDER E.O. 14176

ORVILLE ERNEST GANN was interviewed at Dismas House, 901 Cole Street, at which time he advised that his last Missouri State Penitentiary (MSP) number was 69729. GANN stated he first entered the MSP in August, 1926, on a four-year sentence of burglary from Butler County, Missouri. He re-entered the MSP April, 1931, on a 25-year sentence for nurder from Butler County and entered a third time in April, 1955, on a 20-year sentence for armed robbery at St. Louis, Missouri. He was released from this institution on parole to Dismas House on April 9, 1968.

GANN is presently employed in maintenance work at the Milner Hotel, 20th and Washington, but is seeking employment as an employee of the Missouri State Hospital on Arsenal Street in the laundry department. GANN expects to be residing soon with his wife, EILEEN MASCHINO, 4040 Laclede in St. Louis.

GANN knew subject RAY casually while they were both inmates in MSP at Jefferson City. During the period of this casual acquaintance, RAY was living in K Hall while GANN was a resident of J Hall. Their association consisted of casual passing in the hallways of the institution, some slight association in the yard and slight association based on the fact that RAY worked on the food detail and sometimes served special dishes to GANN and GANN reciprocated by giving RAY special consideration in connection with his laundry service since GANN was assigned to the laundry in the institution. GANN recalled that RAY was always a neat, clean individual, but he stated he could not picture RAY as a person who would plan and carry out an assassination such as that committed on Doctor MARTIN LUTHER KING.

GANN stated he had never heard RAY or anyone else in the institution discuss any plans concerning the assassination of KING or anyone else for a monetary consideration. He recalled vaguely the name COOLEY (phonetic) among inmates in the MSP but could not place this individual as to race or any associates. When questioned concerning possible close associates of subject RAY while he was in the MSP, GANN named one CARL DRAKE, age about 40, tinner, who has returned to the St. Louis area and was recently short in South St. Louis in a tavern brawl. He also mentioned one "TAD" RICHARDSON employed in a small cleaning establishment in the 1600 block of South Jefferson in St. Louis, Missouri.

When questioned concerning any individuals in the MSP who might be capable of planning a major assassination such as that of

KING he named BOBBY ASH, current inmate of the penitentiary who is doing 30 years for armed robbery in the vicinity of Kamsas City Missouri. He also named JIM BRADLEY, who is serving time in the penitentiary for killing a St. Louis policeman. He described the majority of the MSP inmates as small time boodlums but advised that ASH and BRADLEY may have connections on the outside that would afford them information such as a planned assassimation. He attributed political connections to ASH.

He pointed out at the time of RAY's escape from the penitentiary he, GANN, was not a tone formit at Jefferson City but at the honor farm located at Fordland near Springfield, Missouri.

AT MOBERLY, MISSOURI

The following investigation was conducted by Special Agent JAMES A. DUFFEY:

Convict JOHN EDWARD JOHNSON, Number 09876, Men's Training Center, advised on May 3, 1968, he knew subject when both of them were prisoners were at Missouri State Penitentiary at Jefferson City, Missouri. He was never a close associate of RAY and last saw him in 1964. He has observed photographs in the newspaper recently and recognized them as being of the person he knew as JIM RAY.

He never heard RAY make any antagonistic remarks concerning Negroes and never heard him mention Dr. KING.

The names "COOLEY" or "COOLEY Associates" was not familiar to him. He never heard any gossip at the prison that any amount of money would be paid to anyone for the death of KING. He was unable to suggest the name of any person who would have been a close associate or confident of subject.

The Springfield Division, on April 26, 1968, requested that the Miami Division be furnished available information in St. Louis files concerning PAUL ARTHUR LAIL, JR. for the assistance of the Miami Division in conducting an interview of LAIL at his residence, 34 Barbodos Drive, Palm Springs, West Palm Beach, Florida.

MISSOURI MISSOURI

A review of St. Louis files on April 27, 1968, concerning PAUL ARTHUR LAIL, JR. disclosed that LAIL had been sentenced at Stoddard County, Missouri, on June 20, 1963, on a fraudulent check charge. He escaped on June 22 or 23, 1963 by sawing the bars of the jail. Process for unlawful flight to avoid confinement was issued, and LAIL was subsequently apprehended at Galesburg, Illinois, on October 12, 1963. He was returned to local authorities.

LAIL WAS CONSIDERED ARMED AND DANGEROUS BECAUSE HE HAD A .22 CALIBER WEAPON.

The following investigation was conducted by Special Agent JAMES A. DUFFEY:

Convict FRANK MAYBERRY, Number 13763, Men's Training Center, advised on May 3, 1968, he was only in the Missouri State Penitentiary at Jefferson City, Missouri, from December, 1962, until August, 1963, when he was paroled. He thereafter violated his parole and was sent to the Renz Prison Farm until he was discharged on May 15, 1964. He was again sentenced in March, 1965, and sent to the Missouri State Penitentiary. Except for the thirty day processing section on each occasion he was assigned to the "L" Hall outside the walls.

He was unable to recall ever seeing or hearing anything about subject until after the assassination of KING.

MAYBERRY stated he had never heard any mention of "COOLEY" or "COOLEY Associates" in prison and he was not aware of any prison gossip to the effect that the killing of Dr. KING might be worth some money. He was unable to suggest the identity of any individual who might have been closely associated with RAY and he had no information concerning him.

The Jacksonville Division by communication dated April 30, 1968, advised that BILLIE MILES, presently at the new prison at Moberly, Missouri, was an acquaintance of JAMES EARL RAY.

The following investigation was conducted by SA WILLIAM B. DUNCAN on April 30, 1968:

AT MOBERLY, MISSOURI:

Mr. A. H. BALDWIN, Associate Warden, Missouri Training School for Men, Moberly, Missouri, advised from records that the only two NILES he presently has in the institution are JOHN SHRMAN MILES, FBI #367 878 D, and LAVELLA MILES, FBI #388 565 B.

The institution at one time had BILLY MAC MILES, also known as MILLY MAX MILES, FBI #89 784 C, who was transferred from Moberly to Fordland, an honor camp, operated in the Missouri Prison System out of Jefferson City, Missouri, on February 10, 1964. He came to the institution originally on August 16, 1963, transferred to Moberly, September 13, 1963, transferred to Fordland, September 10, 1964.

Mr. BALDWIN determined by telephone from Jefferson City from Mr. DON BUNKER of the Records Office, that MILES was paroled from Fordland on September 29, 1964, returned as a parole violator on May 31, 1966, and released from Jefferson City on January 20, 1967, upon completion of his sentence. His relatives were listed as father - GARIE MILES, Marshfield, Missouri; wife - SHIRLEY SUE MILES, 612 Burford Street, Marshfield, Missouri.

FORMER INNATES INCARCERATED WITH JAMES EARL RAY

The Kansas City Division by communication dated May 1, 1968; advised that FRED MILLER, Missouri Corrections #02273, and FRED HENRY MILLER, Missouri Corrections #66535, are both incarcerated at the Missouri Training School for Men at Moberly, Missouri, and were former inmates of Subject JAMES EARL RAY,

The following investigation was conducted by SA WILLIAM R. DUNCAN on May 1, 1968:

AT MOBERLY, MISSOURI:

FRED HENRY MILLER, white, male, Missouri Training School for Men #66535, advised that he was convicted and sentenced to a life term for murder on November 2, 1952, in Wayne County, Missouri. He served time at Jefferson City, Missouri, from November, 1952, through July 1965, when he was transferred to Moberly, Missouri. He was transferred back to Jefferson City, Missouri, during August 1966, and stayed there until February 4, 1968, when he was transferred back to Moberly, Missouri. During this time he was Hall Tender of "A" Hall and a clerk in the Honor Barracks. He knew JAMES EARL RAY by sight and by reputation. He knows nothing personally about him and was not even a speaking acquaintance. He is the only FRED MILLER he has known either in Jefferson City or Moberly in the 152 years that he has been there.

Mrs. PAULINE DICKERSON, Missouri Training School for Men, advised that they have no record of a FRED MILLER, #02273, and this is not even a good number for the Missouri Training School for Men.

RE PELLOW PRISONER JAMES LOMA OWENS

The following investigation was conducted by SAS KENNETH'A. VILLIAMS and JOHN O. TRETHEVEY, JR. at St. Louis Missouri

The records of the Missouri State Penitentiary, Jefferson City, Missouri, reflect the last known address listed for JAMES LONA OWENS as being in care of his wife, BETTY OWENS, 4447 Rosenary Berkeley, Missouri.

On April 25, 1968, it was observed that Rosemary Lane, Berkeley, Missouri, extends only from 9336 through 9522. A review of the St. Louis City and St. Louis County Directories for the 9300 through the 9500 block of Rosemary Lane listed no one named OWENS living in the area

On April 24, 1968, IC JOHN D. DYER, JR. ascertained that the Commercial Credit Rating Company has no record of JAMES LOMA OWENS.

The records of the St. Louis Police Department reflect the last known address for OWENS, listed in October, 1959, as 4023 Olive Street, St. Louis, Missouri. This address is now occupied by non-Caucasians.

On May 6, 1968, Mrs. MARY LEVAN. Secretary, Barbers Union #102. 2133 Hampton Avenue, advised a search of the active and inactive members of Union #102 failed to reflect any records to JAMES LOMA OWENS. She also advised that she examined the records of licenses issued to barbers who are non-members of the union and also advised these records were negative concerning OWENS. She stated Barbers Union 102 includes Jefferson, Franklin, St. Charles, and St. Louis Counties as well as the City of St. Louis, Missouri. She also advised that a convicted felon cannot receive a barber's license in the State of Missouri.

On May 7, 1968, Mrs. EMMA MC CLURE, 9447 Rosemary Lane, Berkeley, Missouri, advised her daughter, BETTY, was formerly married to JAMES LOMA OWENS. They were diverced six years ago and BETTY has remarried. Living somewhere in the greater St. Louis area. She advised that she was under 2 51. 44-775

the impression that OWENS was still serving a sentence in the Missouri State Penitentiary. She advised she is positive that her daughter, BETTY, does not know the Whereabouts of OWENS. Mrs. MC CLURE stated she does not know where her daughter is living since their relationship is very estranged and she, herself, had not seen her daughter in the past 18 months. She advised her daughter married an individual named JESSE SMITH but she did not know any further information concerning him. Mrs. MC CLURE advised that she did not approve of her daughter's marriage to OWENS and actually knew very little concerning him or his background. She stated OWENS mother reportedly lives in Honolulu, Hawaii, and she would venture a guess that he is most likely to be incarcerated in some penal institution since he was always breaking the law.

On May 6, 1968, Mrs. DAVIDA WILKIN, Secretary, Missouri State Board of Pardon and Parole, 1500 Big Bend Boule-vard, advised she possessed no record of JAMES LOMA OWENS as a current parolee, "She advised complete records of all current and former state parolees are maintained in Jefferson City, Missouri, and records are returned to Jefferson City after a parolee becomes inactive."

RE: PRISON INMATE LEO HOLDEN PARKER

AT ST. LOUIS. MISSOURI

The Kansas City Division advised on April 26, 1968, captioned prisoner at Missouri State Penitentiary claimed he was innocent of the crime of kidnaping for which he was being imprisoned; that the victims had identified a retouched photograph of him; and that victims claimed their kidnaper stated he had broken out of prison and needed a car. He felt he bore such a physical resemblance to subject RAY that RAY might actually have been responsible for the kidnaping.

The following investigation was conducted by SA HAROLD R. DOBSON on April 26, 1968, telephonically:

Detectives JOHN I EPPING and EDWARD ALLERS, 5th District, St. Louis, Missouri, Police Department, advised there is no actual similarity of features or appearance between LEO HOLDEN PARKER and subject RAY. They denies that a retouched photograph had been utilized in the identification of PARKER and stated that a copy of the regular mug photograph which had been used would be available at 5th District Headquarters on the following day. They stated that comparison of that photograph with the photograph of subject RAY failed to disclose any similarities.

They advised further that PARKER is known as a "jail house lawyer" and conducted his own defense at the time of his trial. They ventured the opinion that PARKER is mentally unbalanced.

The following investigation was conducted by SAS JAMES R. LINDSAY and LAWRENCE B. CURTIN:

On April 27, 1968, Mr. and Mrs. GEORGE MC QUADE, JR., 4708 Plover, St. Louis, Missouri, advised that photograph of JAMES EARL RAY is not identical to LEO HOLDEN PARKER, the person who kidnapped them and stole their vehicle.

Mrs. MC QUADE who is the former RITA BROCKELMAN, advised that similarities in PARKER's hairline with JAMES EARL RAY, but PARKER is one who they identified as the kidnapper.

GEORGE MC QUADE advised he saw no similarity between PARKER and JAMES EARL RAY.

He advised that PARKER from his observation is a "nut," and thinks he is a legal brain, and attempted to con-duct his own defense. MC QUADE advised that PARKER was identified in open court as the person who committed this local crime.

Mr. MC QUADE advised that he believes that PARKER is trying to obtain coverage in the news media and attempt to get another trial.
