Mr. CHARLES ABERCKOMBIE, Superintendent, Services Industries, formerly known as Kohlers Snow White Laundry and Cleaners, 1861 North Doergenois Street, New Orleans, Louisiana, exhibited Thermo Seal Marking Machine bearing serial number R31942, model H5K1, and stated that this machine has not been in operation for at least the past two years.

Mr. ABERCROMBIE exhibited Thermo Seal Marking Machine bearing serial number R31913, model number H5Kl, which he stated was one of four Thermo Seal Marking Machines presently in use by the laundry, but only as a substitute machine in the event one of the other three machines was to break down. It was observed by the Agents that the other three machines were model H6U4Cl. Mr. ABERCROMBIE furnished samples of the model H5Kl machine using codes "O2B-6" and "D2B-6".

Mr. ABERCROMBIE stated that to the best of his knowledge, neither of the above two codes have been used by their laundry for the past two years, stating that he had only been employed by the company for the past two years.

Mr. ABERCROMBIE furnished samples of the model H6 machines, which samples were visibly longer than the tapes in question from the H5 machines.
