Re memo of SA JAMES R. MARTIN, 4/17/68, and Albany airtel, 4/12/68.

The following investigation was conducted by SA JOE C. SPARKS, 5/1/68, in the Virgin Islands:

WILFRED VOGEL, Manager, La Croix Laundry and Cleaners, Fredericksted, St. Croix, advised that he uses Thermo-Seal only on laundered items received from individuals and neither on dry cleaning nor commercial laundry received. Red, blue, yellow, green, tan, and brown tapes are used to differentiate between various laundry "batches." The code system is such that the first and/or second digit of the group indicates the number of articles to be laundered in the particular order. For example, in an 8 item order the first 2 digits would be -8; in a 12 item order the first digits would be 12. The third entry is a letter *from* ~~the~~ designating the particular week of the month. The fourth entry is a number designating the day of the week. The fifth and sixth numbers are customer numbers that identify the individual who brought the order for laundry. VOGEL checked with all of the operators of the Thermo-Seal tape machine and advised that in no instance do they ever use a zero to begin the code group. He advised that his Thermo-Seal tape machine was not at the moment operable but as soon as it was repaired he would run off several samples of the tape and make them available to the interviewing agent.

~~OSGOOD~~ HARVEY, Manager, Band Box Laundry and Dry Cleaners, St. Thomas, advised that he uses a Thermo-Seal tape machine to identify both laundry and dry cleaning processed by his plant. A different colored tape is used for each day of the week: pink on Tuesday, yellow on Wednesday, orange on Thursday, purple on Friday, and white on Saturday. The colors blue and green are used in emergency when one of the other colors is not available. He advised that his code system is entirely different from that apparently utilized in the photograph displayed to him. His code is a 6 digit system that uses no dashes. After examining the photograph and showing the photograph to the Thermo-Seal tape operators all agreed that the tape photographed would not have been produced in that particular laundry.

On this date, S/Sgt. EDWARD WIENCLAW, Ramey AFB, telephonically advised that during 1962 he dated a girl by the name of BESS RAY. ~~At the time he did not know she was married, and later he~~ learned that she was married and her husband was serving time for armed robbery. He said he dated BESS RAY in Spokane, Wash. where she was living on Maxwell St. (number unknown) with her mother. She was also working in one of the "chain" stores in Spokane.

He said he later heard she had moved and was recently living in Juneau, Alaska.

WIENCLAW said he could furnish no further information regarding the matter, but thought it might be of interest to the F.B.I. He advised he did not know the name of BESS' husband, where he had served time, the name of BESS' mother, her address, nor where exactly BESS was living or working in Juneau.

In order to cover the possibility that subject may have died since commission of the crime, the U. S. Census Bureau and Department of Health, Education and Welfare were contacted and they advised that no central records of unidentified deceased are maintained by those agencies. It was suggested that each state may maintain such a record in their Bureau of Vital Statistics or similar agency.

There is no known Federal law requiring the maintenance of such information; and it is possible that if any record of unidentified dead is maintained, it would only be maintained at local police departments, morgues, medical facilities, or the like.

Each office covering state capitals should check to ascertain if such records are maintained, and if so, should check records for the period from 4-5-68, to date, for any information which might possibly identify subject Ray with unidentified deceased person over that period.

If there is no central record repository maintained in the various states or nationally in the case of Mexico and Canada, you should, in connection with your contacts with law enforcement agencies on this case or other Bureau matters, make appropriate inquiries relative to

unidentified dead for the period beginning 4-5-68; and if fingerprints on such dead are maintained, they should be compared with those on the Identification Order on Ray in order to effect identification or nonidentification. This should be handled in the normal course of business and only reasonable investigation should be pursued along these lines.

The Identification Division has placed an appropriate stop on unidentified deceased inquiries it may receive. If feasible, appropriate offices and Legats, Mexico City and Ottawa should place similar stops with appropriate state, local or national agencies in your territories.

As instructed by ASAC YATTEAU, PSI RAYMOND CARL MEVS was contacted on 4/5/68, concerning captioned matter.

MEVS advised that he shared the grief of the community upon learning of the assassination of Dr. MARTIN LUTHER KING. He advised that he has no knowledge of any demonstrations or retaliatory actions planned on the part of any residents of the Virgin Islands. He was instructed to keep alert for any such information and would report it immediately to the contacting agent. Arrangements were made to recontact PSI on 4/8/68 for any information he might have developed.

Carrera Criminal del Supuesto Matador de Martin L. King

LOS ANGELES, James Earl Ray, el hombre de quien se sospecha haber dado muerte al Dr. Martin Luther King, inició su carrera criminal en la parte baja de Los Angeles una noche de octubre hace dieciocho años.

Trató de robarse una maquina de escribir de las oficinas, en el tercer piso, de la cafetería "Forum".

El segundo administrador de la cafetería lo sorprendió en el acto y riñó con él, pero Ray logró escapar, no por mucho tiempo sin embargo. Cuando huía a través de la zona de estacionamiento de vehículos de la cafetería, uno de los cuidadores de automóviles oyó las voces del segundo administrador y logró atraparlo.

Lucharon los dos hombres. Ray logró desasirse pero cayeron al pavimento, desde el bolsillo rasgado de su camisa, una libreta de ahorros y el certificado de licenciamiento de las fuerzas armadas.

Esta ocurrencia y una extraña coincidencia— condujeron al primer arresto en la larga carrera de Ray al margen de la ley, un largo tramo de mala conducta que, aparentemente, llegó a la cúspide en Memphis el día 4 de abril cuando fue asesinado el Dr. King.

Cuatro días después del episodio de la maquina de escribir, el cuidador de automóviles reconoció a Ray cuando salía de un banco.

Llamó la atención de un policía cercano quien arrestó a Ray y lo identificó en virtud de la libreta de ahorros y de los papeles del ejército. Ray fue condenado a 90 días de prisión en la cárcel del condado pero puesto bajo libertad condicional durante dos años por el juez Turney Fox, hoy retirado.

La tenidad del juez Fox se basó en el informe que rindió el vicedelegado de libertad condicional Herbert H. Audit y en la

petición que al efecto hizo el defensor de oficio Richard S. Buckley, quien representó a Ray, en aquellos días sin empleo y sin recursos.

Audit está actualmente a cargo del Departamento de Libertad Condicional de Santa Mónica y Buckley es hoy jefe del Departamento de Defensores de Oficio.

Buckley, al solicitar que se pusiera a Ray en libertad condicional el día 30 de diciembre de 1949 ante el juez Fox que iba a pronunciar sentencia, dijo:

—No sólo creo que este hombre es elegible para disfrutar de libertad condicional sino que estimo que es persona que se lo merece... Este hombre está en condiciones de valerse por sí mismo y, aparentemente así lo estuvo haciendo durante un período de tiempo...

Y agregó:

—Parece ser hombre económico. Hizo algunos ahorros y se comportó relativamente bien en el ejército. En vista de estas circunstancias, creo que no se corren riesgos en conserlele libertad condicional.

—Me parece que su argumentación es aceptable, le respondió el juez Fox.

Luego el juez, volviéndose a Ray, le informó de las condiciones en que se le pondría en libertad.

—Quiero que no frecuente usted lugares donde se venden bebidas alcohólicas y que se abstenga de tomarlas por otros medios o de otras procedencias....

Audit, el encargado de las libertades condicionales, había hecho notar previamente que Ray "emplea gran parte de su tiempo en citas con mujeres" y que había admitido "usar a veces cantidades excesivas de intoxicantes".

Estas observaciones y la del juez— tiene hoy cierta resonancia irónica ya que las mujeres y los licores parecen haber ju-

gado papel determinante en la vida subsiguiente de Ray que en aquella ocasión sólo contaba 21 años de edad.

Audit observó también que Ray parecía persona de inteligencia normal; que era católico romano aunque no concurría a misa; que iba al cine dos o tres veces por semana y que "gusta de leer revistas y libros corrientes".

Ray, quien sólo llevaba dos días en Los Angeles cuando el incidente en la cafetería. "Forum", era el mayor de una familia con tres hijos, informó Audit el juez Fox.

El informe del funcionario de libertad condicional agregaba además: que había sido criado por sus padres en Alton y en Quincy, estado de Illinois, al otro lado del río Missisipi, frente a San Luis.

Que su padre, Gordon, había muerto en 1946, época en que el jovenzuelo Ray tuvo que dejar la escuela secundaria en Ewing, Misuri, también al otro lado del río frente a su residencia. Sólo había llegado hasta el noveno grado.

Que Ray se alistó en el Ejército el día 29 de febrero de 1946 y fue licenciado —como soldado raso— el día 23 de diciembre de 1948.

Que pasó la mayor parte de su vida militar en Alemania, durante parte de este tiempo incorporado a la policía militar.

Después de su licenciamiento, vivió aparentemente en su casa con la paga que recibía como parte del llamado "reajuste del retorno a la vida civil". Cuando se terminaron estos ingresos se trasladó a Chicago donde entró a trabajar, manipulando un molde en una fábrica de artículos de goma. Por las noches concurría a una escuela de mecánicos de televisión, cinco veces por semana.

Ganaba 55 dólares semanales, pero en septiembre de 1949 fue despedido del empleo por razones de economía en la fábrica

Se quedó en Chicago sólo unos cuantos días antes de partir hacia Los Angeles.

Aquí negó que hubiera entrado a la cafetería con intenciones de robar. Dijo que había ido a un cine momentos antes y que había ascendido por una escalera de escape de incendios hasta las oficinas del tercer piso del "Forum".

—Creo, dijo entonces, que me había tomado unas cuantas cervezas de más....

Al ser detenido, negó haber tenido encuentros previos con la ley.

Girls Claim To See Ray In San Juan

HARTFORD, Conn. (AP) — The Federal Bureau of Investigation is looking into the claim of two girls that they saw a man in San Juan International Airport who they believe to be the man accused of killing Dr. Martin Luther King Jr., an FBI spokesman said Thursday.

The story of the girls' encounter with the man whose face and actions closely resembled that of James Earl Ray, alias Eric Starvo Galt, was reported in Thursday's edition of the Hartford Times as told by the girls to a Spanish columnist for the paper.

The two, Lucy Eneida Gomez, 19, and Carmen Ana Maldonado, 16, informed the FBI on arrival here Tuesday of their experience while buying tickets at the San Juan airport Thursday.

A man shoved into the line ahead of them at the Pan American Airways, they said. He had a nervous habit of pulling his right earlobe and constantly bit

his lower lip and was bug-eyed when talking with the ticket agent.

The girls said the man asked for a ticket to Jamaica or "anywhere in South America," Lucy said. When informed of a vacancy on a flight to Miami, she related, "he said, 'No, I don't want to go to the States.'"

Lucy said she and her friend noticed the similarity between the man's appearance and photographs of Ray that had been published in Puerto Rican newspapers.

The FBI spokesman would say only that the report had been received and passed on to "the proper authorities," including those in Puerto Rico.

On 5/14/68, THEODORE GUMBS, Frenchtown, St. Thomas, Virgin Islands, furnished SA JOE C. SPARKS the following information:

On 4/30/68, Tuesday, (at 1:30 PM), GUMBS was in the Back Street Magazine Store, when he observed an individual that strongly resembles the photograph of JAMES EARL RAY, taken 1968. GUMBS had been studying a Wanted Flyer for RAY the day before in the post office, and for this reason, he had been alert for RAY. The description of this individual fit that given for RAY. He was deeply tanned, but with a light streak on each temple as though he wore glasses when in the sun. He spoke with a Southern drawl. He was wearing brown levis and a light colored sport shirt. In addition, he wore cowboy boots, the upper part of which had been cut away.

GUMBS left the store and reported the incident to a policewoman, who was on the street in front of the Apothegary Shop. She told him that it was her understanding that JAMES EARL RAY was dead and that the individual he saw could not have been him. Because of this, GUMBS did not pursue the matter. He later, while discussing this with friends, was urged to report it to the Federal Bureau of Investigation (FBI), which he was now doing. He has not seen this individual since 4/30/68, although he has been alert for him.

On 5/14/68, LILLIAN GRIFFITH, GLENA PETERSON, and GEORGE RIEHLEY, Manager, all of Back Street Magazine Store, were interviewed and advised they had not seen anyone resembling JAMES EARL RAY. These were the only three employees of the Back Street Magazine Store.

The above information was made available to the Bureau of Investigation of the St. Thomas Police Department, through Detective AL LEERDAM (NA).

On 5/10/68, SA MOORE responded to a telephone contact of JOHN BAZZUTO, owner-operator, Tropical Motors, St. Thomas, Virgin Islands, who advised that he had some information to furnish with reference to JAMES EARL RAY. When contacted, Mr. BAZZUTO advised that on the prior evening, his wife had been reading the local newspaper, which was carrying a picture of JAMES EARL RAY and he noticed that she was staring at the picture an unusually long time. He made a humorous comment with reference to the fact that she may have seen the fellow and she replied very seriously that she was almost certain that she had seen the man that day at Lindbergh Bay Beach. He questioned her very closely and he now believes that she is convinced that she has seen the man. He recommended that she be contacted.

Mrs. JOHN BAZZUTO was contacted and she advised that on the previous day, 5/9/68, she had been at Lindbergh Bay Beach, St. Thomas, Virgin Islands, between noon and 3:00 PM. She noticed the man on the beach who was alone, about 40 years old, 5'10-5'11" tall, well suntanned. At various times, this man was engaged in conversation with other people on the beach and at one point, she overheard him say that he had been in the real estate business in California with FRED BERGER's sister. He also made comments to the effect that he had recently been in California and Mexico. He was very deeply suntanned. The IO and Wanted Flyer on JAMES EARL RAY was exhibited to Mrs. BAZZUTO and she repeated that she was certain as to the identification.

The IO and Wanted Flyer photographs were exhibited to LOUIS LINDQVIST and LEO MAHONEY, life guards at Lindbergh Bay Beach and who were on duty on 5/9/68, and while they remembered the individual described by Mrs. BAZZUTO, they stated that he in no way resembled the photographs on the IO and Wanted Flyer.

On 5/10/68, Mr. FRED BERGER, Public Relations Officer for the Government of the Virgin Islands, was contacted at Government House and he advised that the man who was described by Mrs. BAZZUTO as being on Lindbergh Bay Beach on 5/9/68, was JAMES MALLOWAY, who had been in business with Mr. BERGER's sister in Santa Barbara, California, for the past ten years in the sale of real estate. He arrived on St. Thomas on 5/4/68, from California and was met by Mr. BERGER at the insistence of Mr. BERGER's sister, who had written to her brother and furnished a photograph of Mr. MALLOWAY so that he would be able to identify him at the airport. Mr. BERGER stated that Mr. MALLOWAY did not resemble the photographs of JAMES EARL RAY in anyway.

ADMINISTRATIVE

On April 30, 1968, PCI JOHN TALLMAN, owner - operator, Carousel Bar, waterfront, Charlotte Amalie, St. Thomas, Virgin Islands, advised SA JOE C. SPARKS that he had been alert for the presence of JAMES EARL RAY since originally contacted by FBI Agents. PCI TALLMAN stated he was tending bar at the Carousel on Wednesday evening, April 24, 1968, and does not recall seeing anyone resembling RAY or anyone fitting the description given by Dr. RICHARD WIER.

PCI TALLMAN stated that JAMES EARL RAY propaganda in the Virgin Islands, which have eighty-five per cent Negro population, has generated wide interest and has been highlighted in local news media. PCI sights this interest as reason why he doubts RAY could be in the Virgin Islands undisguised and not be detected.

The following investigation was conducted at San Juan, Puerto Rico:

On April 5, 1968, all sources, racial, criminal, and security, of the San Juan Office (SJO) were contacted with negative results.

The night of April 12, 1968, Assistant Commissioner CHARLES GRONEVELDT, Department of Public Safety, St. Croix, Virgin Islands (VI), advised SA ROBERT L. MOORE that one DONALD CHURCHILL had left personal belongings at the Club Comanche Hotel, St. Croix, V. I., and mysteriously disappeared. According to GRONEVELDT, CHURCHILL fits the description of ERIC STARVO GALT and those who have seen him say he bears a striking resemblance to a UPI telephoto sketch of a police drawing for the MURKIN suspect that appeared in the April 8, 1968, issue of the "New York Daily News."

On April 13, 1968, the following investigation was conducted by SAs ROBERT L. MOORE and JOE C. SPARKS, at St. Croix, VI:

ROBERT PETERSON, Manager, Club Comanche, St. Croix, VI, advised CHURCHILL entered the Club Comanche on April 6, 1968, without a reservation and asked for a room. They told him Room 5 would be available for four days and he registered for it. He left the hotel and returned shortly thereafter with four or five bags and some boxes. In the registration book, he had given the address of 75 Willow Street, Brooklyn, New York. He printed his name and address. PETERSON saw nothing more of CHURCHILL until the following morning, when he appeared in the lobby saying that he intended to go to St. Thomas for the day. He had a small box with him. PETERSON mentioned the fact that it was customary for a deposit to be made, CHURCHILL left a \$100.00 American Express Check, Number RA34-962-243, which he told PETERSON he would countersign when he returned.

PETERSON described him as a white American male, in his late 30s or early 40s, six feet tall, medium to thin build, brown hair, with no distinguishing physical features. He did appear to be somewhat "wild-eyed" and nervous. CHURCHILL has not been seen or heard of since and his personal belongings, some of which were strewn about the room, have been collected and are being maintained by the hotel.

CATHERINE GOLDEN, Desk Clerk, Club Comanche Hotel, advised that she was present in the lobby the morning that the subject departed, saying he was going to St. Thomas for the day. She found his conversation somewhat peculiar, although she did not state exactly why, and described him as a "kook." She feels he made too big an issue of the fact that there should be no worry about his ability to pay for his room. She described him as a white American male, about 5' 9" tall, light complexion, but slightly tanned, light brown hair combed straight back, possibly brown eyes, but no glasses, 36 to 37 years of age, wearing a brown knit shirt and slacks, has somewhat thin face with a prominent nose.

CHURCHILL's personal effects were examined and the following was observed:

CHURCHILL was estranged from his wife, FAITH DENNIS, and appears to be in a controversy over the custody of the children. He seems to be a man of some means and may be the recipient of several hundred thousand dollars left by his father, ARTHUR. Among other things, he had in his belongings the April 3, 1968, late City Edition of the "New York Times." He had marked an article about MC CARTHY winning the Wisconsin election and President JOHNSON polling forty per cent of the votes.

He marked another article captioned "Soviet Believe Testing Rockets, Able to Guide Bombs From Orbit." He also had the April 5, 1968, issue of the "Washington Post," Section A, the bulk of which was devoted to the assassination of Dr. Reverend MARTIN LUTHER KING. He had written on page one in ink the following:

"Dearest Bob. I am addressing you in a way that could be misunderstood but in my opinion, you are a Prince of Peace - I hope we may meet someday. Thank you."

A copy of employment resume was located which shows among other things the fact that he was employed for five years as a Pan American Airways Navigator. He has kept many scribbled notes concerning his marital problem, including dates that his wife has indicated she was going to obtain a divorce. There is no indication among any of these notes that he has any racial preoccupation. He has expired U. S. ordinary Passport number [REDACTED] issued in 1959, at London, England. A photograph of the subject was obtained from his personal belongings.

A review of Antilles Air Boat's manifest established that DONALD CHURCHILL flew at 11:01 AM, on April 8, 1968, from St. Croix, to St. Thomas, VI, aboard Antilles Air Boat using one way ticket number 05601. ELIZABETH WILSON, Antilles Air Boat, advised when he departed he was dressed in Bermuda shorts, a tan shirt and necktie and carrying a heavy winter overcoat.

On April 16, 1968, JOSE CESTERO MAS, who resides at Calle 11, Block 29 #6, Santa Rosa, Bayamon, Puerto Rico, personally advised SA JOSEPH KAY BROOKS that near the end of February, 1968, he had been in the Professional Hospital and shared a room with a man by the name of DAVILA. He said

that DAVILA had a relative named GILBERTO DIAZ AVILES, who visited in the hospital on occasion. He said that DAVILA was the person who expressed extreme hate for the Negroes and became very boisterous and loud and bordered on violence in discussing the subject.

CESTERO advised that he does not know the address of DIAZ, but he is employed by TIPPETT-ABBETT, Room 612 or 616, Fomento Building, Hato Rey, Puerto Rico. He stated that DIAZ very closely resembles the artist's conception appearing in the "El Mundo" newspaper of the murder suspect. He described DAVILA as a white male, age approximately 25 to 30.

On April 19, 1968, G. VANDO, Accountant, TIPPETT-ABBETT-MC CARTHY-STRATTON, 268 Ponce de Leon Avenue, Hato Rey, Puerto Rico (Fomento Building), advised SA JAMES R. MARTIN that GILBERTO DIAZ MILAN is an employee of this company and was present for work every day during the month of April, 1968, with the exception of one half day on April 16, 1968.

Mr. VANDO advised that he is the Accountant for the company and prepares the attendance and payroll record, and in his position he has observed DIAZ on every day that he was at work.

A photograph of the artist's conception of unknown subject in this case as described by witnesses was exhibited to Mr. VANDO and he advised that DIAZ does not in any way resemble this photograph.

On April 19, 1968, Lieutenant FELIX VEGA, Lares, Puerto Rico, advised SA THOMAS H. GREENE that a complainant, FELIPE HERNANDEZ, who resides on the highway between Lares and Arecibo #129, Puerto Rico, furnished the following information:

A photo of ERIC STARVO GALT appearing in the "El Mundo" newspaper contains the same general characteristics of an individual known as JOE, last name unknown,

who is married to MERITA CASULL, formerly of Barrio Vayana de Hatillo, Puerto Rico, on April 6, 1968, and left Puerto Rico on April 13, 1968.

Their present address is believed to be #1035 De Kalb Avenue, Brooklyn, New York.

During their stay near Lares, JOE was known to have \$5,000 in cash on his person, acted extremely nervous and was frequently observed covering his face with his hat. JOE is described as 35 to 40 years of age, 5'7" tall, weighs 160 to 170 pounds, smokes Camel and Chesterfield brand cigarettes.

On April 20, 1968, FELIPE HERNANDEZ VELEZ BAYOMEY, Arecibo, Puerto Rico, advised SA GREENE that JOE, last name unknown, and wife, MERITA CASULL VELEZ, arrived at Arecibo, Puerto Rico, on April 11, 1968. JOE reportedly said that he had been in Puerto Rico about a week. VELEZ had no information as to where JOE had been prior to that date or his whereabouts on April 4, 1968. VELEZ described JOE as a white male, age 35 to 40, approximately 5'8", weighs 160 to 180 pounds, build - heavy, large stomach, dark brown hair, brown eyes. MERITA CASULL VELEZ, described as white female, age 42 to 45, height 5'4", weighs 110 pounds, black hair, brown eyes. Both JOE and MERITA reside at #1035 De Kalb Avenue, Brooklyn, New York, the home of MERITA's father, BENITO CASULL. Additional relatives of MERITA are GEORGE CASULL VELEZ and his wife ANASASIA, #888 Myrtle Avenue, Brooklyn, New York; IRMA CASULL, wife of OSCAR GONZALEZ, #814 Myrtle Avenue, Brooklyn, New York.

Mr. JOSEPH CHIRICO and wife MERITA CHIRICO, nee MERITA CASULL VELEZ, interviewed on April 20, 1968, by SA JAMES J. CUMMINGS at #1035 A De Kalb Avenue, Brooklyn, New York.

Mr. CHIRICO born on [redacted] at Brooklyn, New York, speaks with Italian accent, has olive complexion, 175 to 190 pounds, 5'6" tall. CHIRICO

is bald from beginning of forehead to point three to four inches back on scalp.

On basis of observation and above data, CHIRICO determined not identical to JAMES EARL RAY.

On April 20, 1968, MIGUEL ANGELO OLIVO telephonically advised that his mother recognized the picture appearing in the "El Mundo" newspaper of ERIC STARVO GALT as that of a man who was riding the bus to the San Juan International Airport on Monday, April 15, 1968.

OLIVO stated the man was described as 5'8" tall, wearing white and blue checkered shorts, tennis shoes, with dirty blond hair, blue eyes, and of approximately 35 years of age.

OLIVO stated he is the owner of the sign shop which is located across the street from the Swiss Chalet, Santurce, Puerto Rico. He advised he could be contacted at his residence telephone 785-4658, and his business telephone 724-0284.

On April 23, 1968, OLIVO was contacted at his place of business and advised that his mother is Mrs. MARIA FERRER, who resides at 1B 32 Royal Palm, Bayamon, Puerto Rico.

On April 23, 1968, SA BUFRED M. MOSLEY attempted to contact Mrs. MARIA FERRER BALCELLS at 1B 32 Royal Palm, Bayamon, Puerto Rico. On April 24, 1968, Mrs. FERRER advised SA MOSLEY of the following information:

On Monday, April 15, 1968, at about 5 PM, she caught an airport bound bus at stop #19 on Fernandez Juncos Avenue. She advised that this bus was crowded and that one of the male passengers who was standing in the bus when she boarded was later seen by her in the airport terminal. FERRER stated that she had gone to the airport

to recover a piece of luggage and did not notice any person or place contacted by the above mentioned passenger during the period of approximately one hour that she was in the airport terminal.

FERRER stated that she boarded a bus marked "Airport via Condado" upon leaving the airport terminal with her piece of luggage, and took a seat next to a window on the right side in the middle of the bus. She advised that moments later, the above mentioned individual entered the bus; walked to the rear portion and then returned and sat in the seat immediately to her left. She advised that she did not get a good look at this individual's face from the front, inasmuch as he never turned his head while sitting next to her even though he talked to her in English and did not know Spanish. She furnished the following description of the above individual:

Mrs. FERRER advised that while returning from the airport, the above described man mentioned that he was from Connecticut and was looking at a folded map (origin unknown) and he asked her if the bus would pass close to Punta Las Marias. She said that she told him that the bus would pass very close to that area and he then told the bus driver to remember to stop in that area. FERRER then stated that the above unknown male wanted to

know how frequently the buses that ran between Punta Las Marias area and the airport. She advised that they operated frequently and told him so. She stated that he got off the bus at Llorens Torres, near a small triangular park and walked towards the beach. She stated that he turned and waved to her from the sidewalk and she caught a glimpse of his face from the front.

FERRER advised that on April 20, 1968, she saw a photograph of ERIC STARVO GALT in the local paper, "El Mundo", and that the photo displayed bore a very strong resemblance to the man that she described above as having been on the bus with her. When asked as to why she remembered this man, she stated that she thought it very strange that the man of the bus would never turn and face her even though they conversed during their trip together.

Mrs. FERRER viewed several photos and selected the photos on I.O. 4182, JAMES EARL RAY, (the two photos of the left) as being very close to the person she saw on April 15, 1968. She stated that the man she saw had longer (medium length) hair and she was not sure of the straight-on face photo of JAMES EARL RAY, aka, but noted that the profile shot was very close to the man she described above, however, she stated she could not state the individual she saw was identical with JAMES EARL RAY.

On April 25, 1968, an examination was made of the area along Baldorioty Avenue which Mrs. FERRER described as the point of departure from the bus by the above described unknown male. It was determined that this individual had apparently departed the bus on April 15, 1968, at the corner of Jupiter Street and Baldorioty Avenue.

The following guest houses in this area were contacted with negative results:

On the same date, HENRY MARQUEZ RODRIGUEZ, White Castle Guest House, 106 Doncella Street, advised that several days prior a young man had inquired about a room, but desired something cheaper than \$25.00 per week. This young man was described as follows: white male, age 20's, six feet tall, 185 pounds, sandy hair.

RODRIGUEZ stated that the above person bore a slight resemblance to the 1960 photos of JAMES EARL RAY on I. O. #4182, but that this person was definitely not RAY based on age.

On April 25, 1968, Mr. and Mrs. O.S.E. PERKINS, the owners of the Villa Mar Guest House, #4 Caoba Street, advised that on April 15, 1968, one ROBERT C. WHELAN registered at their guest house and gave his address as #1773 Central Avenue, Bridgeport, Connecticut. They advised that WHELAN left to return to Connecticut on April 22, 1968, with some money which was cabled to him by his father. They described WHELAN as follows: white male, age 20's, six feet tall, 175 to 180 pounds, brown hair, blue eyes, no scars or marks recalled. the PERKINS observed I.O. #4182 and advised that WHELAN was not identical with JAMES EARL RAY, but noted the the profile photo of RAY bore some resemblance to the profile of WHELAN.

On April 26, 1968, FREDERICK WUERTH, Casa Meyer, Old San Juan, telephonically contacted SA CHARLES A. MOSHER at the SJO and advised he thought he had seen an individual answering the description of JAMES EARL RAY. WUERTH stated he was calling from the Excelsior Theater, Calle Parque, Stop 23, Santurce, and that he would wait at the theater for an FBI Agent to contact him.

SA MOSHER and SA H. LAMAR MEYER went immediately to the theater and contacted WUERTH. Photographs of RAY, and his physical description were furnished to WUERTH. He stated the individual to whom he was referring, who had left

the theater, definitely did not answer RAY's description, and did not look at all like the photographs of RAY which were exhibited to him. He advised this individual had a receding hairline to the point of being almost bald, what hair he did have was in a crew cut. WUERTH took a close look at this individual and is positive that his eyes were green, not blue as are RAY's, he estimated the man to be approximately 180 to 190 pounds. He is also positive the individual to whom he is referring did not have a protruding left ear.

The manager, and employees of the theater were exhibited photographs of RAY and stated they had definitely not seen anyone answering RAY's description in the theater, and that only two or three "Continental's" had entered the theater for the matinee, and that none looked anything like RAY.

SA MOSHER and SA MEYER personally observed all patrons of the theater and could find no one resembling RAY.

On April 29, 1968, the Baltimore Office advised that RICHARD WIER, D.D.S., 2401 Pennsylvania Avenue, Wilmington, Delaware, advised on April 24, 1968, he spoke for twenty minutes to a fellow customer at the Carousel Bar on the waterfront, St. Thomas, Virgin Islands (VI), who looked exactly like the 1960 photograph of JAMES EARL RAY. He stated the individual does not look like the 1968 photograph. The individual was described as a white male, 40 to 50 years old, 5'10" tall, stocky muscular appearance, blue eyes, short brown hair, freckled complexion, strong southern accent, wearing white sports shirt and drinking beer. Individual stated he was in the Merchant Marine for fourteen years and now doing similar work. He likes cities such as San Francisco, New Orleans, and Cape Town, South Africa, the best. WIER stated that from a distance of one-two feet he could not observe a scar on the forehead of this individual.

On April 30, 1968, Bartenders BUD EBERHARDT and THOMAS BYRD as well as all waitresses in the Carousel Bar, waterfront, Charlotte Amalie, Virgin Islands, were interviewed by SA JOE C. SPARKS and could furnish no positive information concerning the presence of anyone resembling JAMES EARL RAY being present of the Carousel Bar on April 24, 1968.

On April 30, 1968, the Jacksonville Division advised that the Regional Inspector, Internal Revenue Service, Atlanta, Georgia, discovered a tax return for JAMES EARL RAY, JR., Social Security number [REDACTED]. The return indicates that RAY, JR., is with the U. S. Navy, Jacksonville, Florida.

Personal records at Naval Air Station Cecil Field, Jacksonville, Florida, reflect RAY, JR., departed on April 25, 1968, for temporary active duty at Roosevelt Roads Naval Station, San Juan, Puerto Rico, as Mess Cook for four weeks.

On May 1, 1968, JAMES EARL RAY, JR., advised SA DAVID C. MC MICHAEL that he is the son of Lieutenant Colonel JAMES EARL RAY, who is in the U. S. Army, presently serving in Vietnam. He advised his mother is TERESA LEE RAY and resides at 403 Honeysuckle Court Montgomery, Alabama. RAY, JR., advised he is not acquainted with JAMES EARL RAY, subject of this investigation, and does not believe they are related.

RAY advised his grandparents, Mr. and Mrs. RUFUS RAY, 25 East South Street, Montgomery, Alabama, are originally from Washington, D.C., and would know if any relation exists with the subject of this case.

RAY, JR., advised he is assigned to Navy Squadron VA-174, temporarily assigned at Roosevelt Road Naval Station, Puerto Rico, and will return to Cecil Field, Jacksonville, Florida, about May 25, 1968.

On May 1, 1968, the Mobile Division advised that investigation in Montgomery, Alabama, reflects RUFUS RAY, 25 East South Street, is a retired Internal Revenue Service employee known to Senior Resident Agent SPENCER H. ROBB for approximately twenty-three years. RAY advised that his son, Lt. Col. JAMES EARL RAY is presently serving with the U. S. Army in South Vietnam, and his grandson, JAMES EARL RAY, JR., is currently in the U. S. Navy in Jacksonville, Florida. RAY states subject of this case is not related in any way to this family and he had no knowledge of him.

On April 28, 1968, at 9:30 PM, SA JOE C. SPARKS received an anonymous telephone call at his home. The caller advised that one week ago at approximately 10:30 AM he was at Red Hook, St. Thomas, VI, and overheard a conversation between a forty year old white male and one of the employees of the Dohm Water Taxi Service. The forty year old white male fits the description of the individual sought in the MURKIN case and looked similar to the caller to a picture he saw in the April 20, 1968, issue of the New York Times. He said this unknown individual inquired as to places to stay in Cruz Bay, St. John, and Mead's was recommended to him as a comfortable spot that was not too expensive.

SA SPARKS conducted the following investigation on April 29, 1968:

PER DOHM, Operator of the Dohm Water Taxi, Red Hook, St. Thomas, advised that he recalled having spoken to an individual approximately a week ago who was inquiring about a place to stay in Cruz Bay, St. John, VI. He explained that the incident stood out in his memory since almost without exception anyone going to St. John has reservations there for a place to stay. Since DOHM transports so many people to and from St. John from Red Hook, he was unable to furnish a description of the individual in question. He viewed photographs of RAY, aka GALT, and advised that he could not state that

the individual in question looked like these photographs. After transporting the individual in question to Cruz Bay, DOHM saw him sometime later, possibly the following day, and inquired if he had found a place to stay. The individual told him that he was staying at Ellington's Guest House.

Mr. and Mrs. RICHARD ELLINGTON, Ellington's Guest House, advised that the only unaccompanied male guest they had had was VICTOR VILLEMAIN who stayed with them two days beginning April 23, 1968. He gave as his home address #31 Union Square, New York City, 10003. He had a bar bill of \$4.55 and paid \$20 a night for the two nights. Both Mr. and Mrs. ELLINGTON advised that VILLEMAIN was over fifty years of age, had long hair and walked with a cane. His manner was effeminate and they suspect that he is a homosexual. After examining photographs of RAY, aka GALT, they advised there was no question in their mind but that this VILLEMAIN could not be identical with RAY.

With the assistance of Patrolman V. SPRAUVE, St. John Police Department, the following individuals were contacted concerning the possibility of RAY having been in the area or been a guest at their establishments. No positive information was developed. Mrs. MEAD, Mead's Guest House, Cruz Bay, St. John, VI; Mr. and Mrs. JOHN R. WOODSIDE, Cinnamon Bay, St. John, VI; DAVID BREWER, Manager, Caneel Bay Plantation, St. John, VI.

Photographs of RAY were left with Captain LEANDER R. JURGEN, St. Thomas Police Department, who was made aware of the circumstances of the anonymous telephone call. He advised that he would re-alert the nine men on his force in St. John, to be doubly alert for any individual who might fit the description of RAY and immediately notify the contacting agent.

On May 2, 1968, ROBERT WILSON, Chief of Detectives, St. Thomas Police Department, advised that

he had received word from Patrolman THOMAS, St. John, VI, that Miss MALVERN SEWER, operator of Malvern's Guest House in Cruz Bay, St. John, had advised him that the man the FBI had been inquiring about two days earlier was now at her guest house.

On the afternoon of May 2, 1968, Patrolman V. SPRAUVE, St. John Police Department, advised that he had shown Miss SEWER photographs of the MURKIN suspect and she advised that the individual at her guest house was positively not identical with RAY. SPRAUVE advised that Miss MALVERN was not available for interview that afternoon since she had departed for Coral Bay.

Additional wanted flyers were furnished to Captain JURGENS who assured that they would be prominently posted throughout the island of St. John.

On May 9, 1968, Mrs. EMILLIE R. SNIDER, Dependent wife to Air Force Sergeant, Ramey Air Force Base, Puerto Rico, 313 B-7th Street, advised SA THOMAS H. GREENE that on April 25, 1968, she was at the Island of Curacao on a vacation tour. Sometime between 12 noon and 1 PM, April 25, 1968, she was eating lunch in the Lido Restaurant, Curacao, and observed two men in the restaurant, one of whom she says strikingly resembles newspaper photo of JAMES EARL RAY.

She said this individual who resembled subject was seated, with his back to the wall, at the second table on the right from the entrance into the restaurant section of the Lido.

Mrs. SNIDER said that because she is of the Negro race she contemplated in her mind for the past several days that she might have been prejudiced in thinking this individual resembled RAY or that he actually did. She is of the opinion, after making honest memory study, that unknown person in the restaurant could very well have been the subject.

Unknown person was overheard to order something to eat, the last part of his order consisting of "rice and iced tea." Unknown person has a very definite Southern accent.

This person was wearing slacks, color unknown, and a rumpled white shirt. He appeared to be about thirty-seven years of age, approximately six feet, 180 to 185 pounds, sandy colored hair, very dry, complexion ruddy around the cheeks and nose. The only distinguishing feature of unknown person was a definite cleft in center of chin such as appears in the pictures of subject. Unknown person appeared to have a somewhat fleshier face than that of photo of subject she has observed.

She advised she had not seen this individual prior to this encounter nor since. Mrs. SNIDER stated she could furnish no further detailed information concerning unknown person and as far as she knows, this person did not alert the attention of anyone she knows.

On May 13, 1968, Staff Sergeant EDWARD WIENCLAW, Ramey Air Force Base, Puerto Rico, telephonically advised that during 1962, he dated a girl by the name of BESS RAY. He later learned that she was married and her husband was serving time for armed robbery. He said he dated BESS RAY in Spokane, Washington, where she was living on Maxwell Street (number unknown), with her mother. She was also working in one of the "chain" stores in Spokane.

He said he later heard she had moved and was recently living in Juneau, Alaska.

WIENCLAW said he could furnish no further information regarding the matter, but thought it might be of interest to the FBI. He advised he did not know the name of BESS' husband, where he had served time, the name of BESS' mother, her address, nor where exactly BESS was living or working in Juneau.
