For the information of the Bureau and interested effices, the following investigation was conducted at Griando, Florida, by SAs THOMAS J. VILLES and CORDON W. TINDLE. BAILLY SANDLIN, Insurance Adjustor, 1906 West Colonial Drive, Orlando, Florida, telephonically advised SA WILKES on 4/25/68 that at appreximately 8:55 a.m., 4/25/68, he drove up in front of his office and noticed a man sitting in a 1967 or 1968 dark blue, 4-door Chevrelet. He stated the only numbers of the Florida tag he could recall were 74-15 with rest of numbers unknown and he could not recall how many digits were in the tag number. He advised the Chevrolet was parked in the carport at his office. He said the man who resembled JANES MARL RAY, pointed a saubsecod revolver at him, and said, "You min't seen me" and drove east on Colemial Drive to the next street (Yern Drive) where he turned right. SANDLIN stated he got into his car and tried to follow the individual but never saw the Chevrolet amin.

It was noted by SA WILEES during the telephone call from SAMPLIE that his voice had been unusually hesitant between words and sentences, however, at the time it was believed to be due to excitement.

J. R. SHITH, Detective Bureau, Orlande, Florida Police Department, was immediately informed of the above by SA JAMES B. MAYLET.

By a arriving at 1906 West Colemial Drive, MAILEY SEMBLIN was interviewed in person by SAs TINDLE and WILES. As the interview progressed, it became evident through SAMBLIN'S behavior and by his own admission that he was under the influence of liquer. He stated that he was an alcoholic and that during the morning of April 34, 1968, his girlfriend, CMARLOTTE HeBANIEL had tried to counit suicide in his apartment at 77 East Amelia, Orlando, Florida. MANBLIN asserted he became upset at this and had been drinking beer and Yedka from the morning of April 34, 1968 through the time the agents contacted him in person.

Every effort was made to ascertain if there was any truth in SANDLIN'S statements, however, he continually changed his description of the suspect and varied the sequence of events as well as the times they were alleged to have occurred.

On April 25, 1968, Mrs. ANN VACHER,
1904 West Colonial Brive, and Mrs. ALFRED PRIMACIA,
1918 West Codedial, who are located immediately
adjacent to SANDLIN'S effice advised that from at least
8200 a.m. until they were contacted by the agents ther
had been no other car in SANDLIN'S carport except his
Bodge. Both wemen were positive no Chevrolet, described
above, had been in or near SANDLIN'S effice that day
since at least 8:00 a.m.

on April 25, 1966, Mrs. MARGARRY TATION, widow of Deputy Sheriff PHILIP TATION, 1113 Santa Anits, advised agents she is the secretary to SAMBLIN and that she had received a call from him that merning. She stated he sounded very unusual and she wendered if he had been drinking. She asserted that MARBLIN had previously told her he was an alcoholic and was active in alcoholics anenymous. He has also told her that when he drinks, he has hallucinations thinking he has achieved great success. Mrs. TATION further stated that SANDLIN told her during his phone call that merning that when he arrived at his office he had been accested by a man in a car in the carport of his office who stuck a gun in his face, According to SANDLIN, this had caused him to be upoet.

Ers. TATIOR also declared that she talked with the landlers and occupents of the other half of the building, in which SANDLIN'S office is located and Mrs. WILLIAM MURRELL, 1904 West Colonial Brive had advised her that she had arrived at the effice at the same time as shillill and there was no car in the carport at that time. During the afternoon of April 25, 1968, NOMALD E. ERIGIER, Riegior and Advociates, Insurance Adjustors, Deland, Florida, tolophonically advised SA VILIES he was SAMBLIN'S employer. He stated he had gone to SARBLER'S office a short time previous that same day, in answer to a phone call from Mrs. TAYLOR whose he found SANDLIN passed out due to drunkedness. He stated he closed the office, took SANDLIN home and put him to bed.

JAMES FULLER, Detective Sergeant, Orlando PD was apprised of the above.

About mid-morning, April 25, 1968,
BAILEY SANDLIN, 1996 West Colonial Drive, Orlando,
Florida, telephonically advised SA BORERY C. BALL at
the Orlando Resident Agency that he had previously
telephoned the Orlando Residence Agency on the same
morning and he had been contacted by two agents whose
mames he could not recall. He related he was recentacting
the resident agency since the individual whom he had
talked with the previous time had telephoned him and
threatened him.

SA RALL contacted the Orlando FD and was not at 1906 West Colonial Drive by Sorgeant STRAUB of the Orlando FD and during a short conversation with SANDLIN he stated he was fearful of his life since the previous described individual had threatened to return to his office and to kill him.

During the conversation with SAMBLIN it was obvious to SA BALL that SAMBLIN had been drinking and such opinion was confirmed by Sergoant STRAUS. SAMBLIN was shown the identification order for JAMES HARL RAY and stated that the individual depicted thereon resembled the individual who had threatened him earlier that same day. Due to the obvious intoxicated condition of SAMBLIN, no further attempt was made to interview him.

Due to the above set forth facts, no further action has been taken.

On 5/3/68, STANLEY TREPACHKO, 2524 Elyria Avenue SW, Large, Florida, telephonically contacted the Tampa Office and advised that he had observed an individual at the Mambo Lounge, IndianRocks Beach, Florida, on 5/3/68, who he believed to bear a resemblance to subject. He said that he would not be available for interview on 5/3/68, but could be contacted at his home on the morning of 5/4/68.

On 5/4/68, STANLEY TREPACHKO, 2524 Elyria Avenue St. Largo. Florida, advised that between 5:30 P.M. and 6:00 P.M. he and his wife were at the Mambo Lounge, Indian Rocks Beach, Florida, and he observed an individual who he believed to resemble the photograph of RAY. He said that this individual was a white, male, age in 30s, 5'11", medium build, and that he observed a tattoo (not recalled) on this persons right forearm. He said that this person also touched his ear on occasions which he recalled being a pecularity of RAY. He said that this person was alone and sat about midway at the "U" shaped bar; no vehicle was observed; and this person remained for only a few minutes. He said that the photo which it was believed this person resembled was the front view photograph of RAY taken in 1960, appearing on IO and wanted flyer. He said that he is acquainted with the owner of the Mambo Lounge, TONY VON, but cannot recall VOY being present, and the only person known that he recalls being present was the barmaid, JOYCE LNU. He said that she should recall this person and would be on duty during the evening hours.

On 5/4/68, TONY VON, owner, Nambo Lounge, IndianRocks Beach, Florida, advised that he was in the lounge all day on 5/3/68, and believes he observed all patrons during the day. He said that photographs of JAMES EARL RAY are all unfamiliar to him. He said that JOYCE LAWSON was on duty during the hours of 5:30 - 6:00 P.M. and would have served anyon e at the bar.



JOYCE LAWSON, barmaid, Mambo Lounge, Indian Rocks Beach, Florida, advised that she was on duty behind the bar during the hours of 5:30 -6:00 P.M. and would have served any customer during that period. She said that she recalls her activities during the hour 5:30 -6:00 P.M. and that several of the lounge "regulars" were seated at one end. She said that she recalls two males sitting at the other end of the bar and recalls a lone individual sitting about mid-way at the bar which is obviously the person in question. She said that this person ordered one beer and left without finishing the beer. She said that she took this persons order and had occasion to observe him and that she can see no similarity between this person and photographs of RAY. She said that she had also observed photographs of RAY appearing in papers and on TV and feels that if she should see him that it would refresh her recollection and she would have recalled. She said that owner, TONY VON, was in a booth at the time and would not have observed anyone at the bar nor would any other customer as they would have been considerably removed from this individual. She reit rated that she saw no resemblance between this individual and photographs of RAY. She said that this person was a stranger, that she observed no car, and noted nothing unusual about him.
