CONDITIONS

It is further understood and agreed:

The order on the reverse hereof is subject to the following terms and conditions which have been mutually agreed upon:

- I. The purchaser agrees to deliver the certificate of title to any boat traded herein along with the delivery of such boat and the purchaser warrants such used boat, motor, trailer or accessory to be his property free and clear of all liens and encumbrances.
- 2.
