

CONDITIONS

It is further understood and agreed:

The order on the reverse hereof is subject to the following terms and conditions which have been mutually agreed upon:

1. The purchaser agrees to deliver the certificate of title to any boat traded herein along with the delivery of such boat and the purchaser warrants such used boat, motor, trailer or accessory to be his property free and clear of all liens and encumbrances.

2. The manufacturer has the right to make any changes in the model or design of any accessories and part of any new boat, motor, trailer or accessory at any time without creating any obligation on the part of McKay Chris Craft Sales, or the manufacturer, to make corresponding changes in the boat, motor, trailer or accessory covered by this order either before or subsequent to the delivery of such boat, motor, trailer or accessory to the purchaser.

3. McKay Chris Craft Sales, shall not be liable for delays caused by the manufacturer, accidents, strikes, fires or other causes beyond the control of McKay Chris Craft Sales.

4. Upon the failure or refusal of the purchaser to complete said purchase for any reason the cash deposit and the purchaser's merchandise taken in trade may be retained as liquidated damages, and in the event a used boat, motor, trailer or accessory has been taken in trade, the purchaser hereby authorizes McKay Chris Craft Sales, to sell said used boat, motor, trailer or accessory and McKay Chris Craft Sales, shall be entitled to reimburse themselves out of the proceeds of such sale for any expense incurred in storing, insuring, conditioning and advertising said boat, motor, trailer or accessory for sale plus a selling commission of 10 per cent of the gross sale price.

5. The price of the boat, motor, trailer or accessory quoted does not include any tax or taxes imposed by any government authority prior to or at the time of delivery of such boat, motor, trailer or accessory unless expressly so stated, but the purchaser assumes and agrees to pay, unless prohibited by law, any taxes except income taxes, imposed on or incidental to the transaction herein, regardless of the person having the tax liability.

6. The price of the boat, motor, trailer or accessory quoted herein is based upon the prevailing price in effect at the time of the acceptance of the order. Any increase in price made and published by the manufacturer prior to delivery cannot be contemplated by McKay Chris Craft Sales, and must be assumed by the purchaser if in effect at the time of delivery.

7. If the vendor McKay Chris Craft Sales, has taken any merchandise in trade on this order and if for any reason this order is cancelled by either party prior to delivery of the merchandise in this order McKay Chris Craft Sales, will return to the purchaser the merchandise or the sum of the monies received for the disposed of merchandise and will charge the customer any costs incurred in storing, selling and preparing such merchandise for sale plus a commission of 10 per cent of such sale price, if the merchandise has been sold, rather than the trade in allowance specified on the front hereof.

8. If the manufacturer because of making unanticipated model changes or discontinuing models makes it impossible for McKay Chris Craft Sales, to make delivery of the merchandise covered by this order this order may be cancelled by McKay Chris Craft Sales, in accordance with the terms provided in paragraph 7 above or a new model may be substituted by the purchaser of an equal or greater price in accordance with paragraph 6 above.

9. It is expressly agreed that the manufacturer's warranty on any new boat, motor, trailer or accessory will apply to this order and McKay Chris Craft Sales, will act as agent between the purchaser in the enforcement of the manufacturer's warranty.

McKay Chris Craft Sales, agrees to install any part or parts furnished under the manufacturer's warranty on the boat, motor, trailers or accessories covered in this order without charge to the owner.

This warranty does not apply to second-hand or used boats, motors, trailers or accessories.

McKay Chris Craft Sales, makes no warranty of fitness, express or implied, as to the merchandise sold by this order.

10. In the event that the transaction referred to in this order is not a cash transaction, the purchaser herein, before or at the time of delivery of the boat, motor, trailer or accessory ordered, and in accordance with the terms and conditions of payment indicated on the front of this order, will execute a conditional sales contract, chattel mortgage or such other form of agreement as may be indicated on the front of this order.

11. In consideration of the value of the merchandise received, the purchaser agrees to pay the installment specified, and in the event of default in payment when due to pay the entire remaining balance in one lump sum, on demand, together with annual interest from demand at 6% on the unpaid sum due, plus all costs of collection including a reasonable attorney's fee. The purchaser also agrees that he does waive his personal property homestead exemption rights, as to the particular merchandise hereby purchased.

12. In case the boat, motor, trailer or accessory covered by this order is used merchandise, McKay Chris Craft Sales, will replace any parts deemed to be defective at a charge to the buyer of 50 per cent of the material cost and 50 per cent of the labor charge involved for a period of 60 days after date of purchase. It is understood that such replacement must be authorized by McKay Chris Craft Sales, prior to such replacement. The extent of prior usage of used boats, motors, trailers, or accessories naturally cannot be guaranteed by the vendor.
