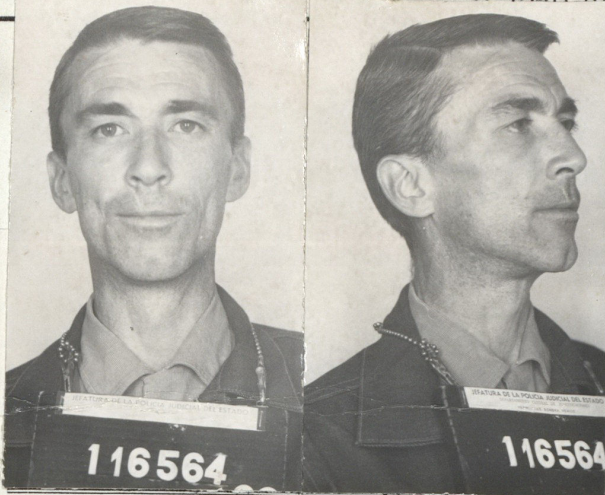

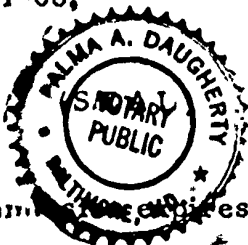

She is the wife of ^{Juan} Manuel Frezoso Gutierrez.

She did not recall subject or his car as she was upstairs in their apt. She does recall the fact an American came in to buy a 7.45 X 14 tire and, since they did not have one, clerk Teresa Fernandez sold him a ~~7.45~~ 7.50 X 15. He asked for a discount because it was the wrong size & T.F. called up to the apt for auth to give a discount - Mrs. F auth 10%.

She could recall no further about the actual sale, even to say how long ago it was. She said her brother mounted the tire but could recall nothing of the incident.

She said a Mex investigation had been in a couple of weeks earlier inquiring of the same person.

Mrs. Frezoso said they ~~had never~~ kept no record of tire serial numbers except to note them on the sales slip at the time of sale for guarantee purposes. She searched the

invoices of tires their receives from the Firestone
factory & noted that there was no serial numbers.

She was unable to state whether or not the
tire in question had ever been in their inventory.

T.F. immediately rec. the sun glass photo as subj. She said he came in one morning, she was sure in January 1968, to buy a tire. He had apparently come from General Pops, 2 doors away just previously.

Subj. had a ^{what hunting} ~~stir~~ badly road damaged & needed a replacement 7.45 x 14. As they had none he took a 7.50 x 14 but asked for a discount as it was the wrong size. ~~He~~ T.F. spoke to Mrs. Freyoso who was in the upstairs apt. A 10% discount was auth. Since the tire was slightly larger and/or because the use of tubes is always rec. due to the rocky roads, the subj. walked to the General Pops & came back with a tube he bought himself & the tire was mounted outside the store by Mrs. F.'s brother.

Having searched unsuccessfully for a sales slip, Mrs. F. suggested she may have left the carbon paper out of the receipt book. She said in any event the subj. did not give his name & since

he was not a Mex she did not bother to ask his name or note the serial # of the tire on the sales slip since this is only done for guarantee purposes.

Miss F stated she lives near the C. S. and after she sold the tire she remembered seeing the subject's white 'mustang' parked on Calle 31 de Oct around the corner from the S.S. on Matamoros. The car was parked in front of a vacant lot. She thought it strange as she saw the car there about 8⁰⁰ A on several occasions when she was walking to work. She presumed he was, therefore not staying at a hotel. On one occasion as she was on her way to lunch she saw subject park his car and ~~stand~~ walk ~~forward~~ up + turn into Matamoros St. She never saw him with any other person ~~did not~~. He was alone the day he came to the store.

One eve Elin ~~to~~ asked Perez to write a note for her in English to the subj' (whose name he could not recall) It seemed that Elin had accepted some ~~money~~ ^{\$500.00} for subj' to rent an apt for them but she had used the money to take her two of her children to Grand. The note was to explain how she had spent his money & to ask his pardon. He remembers the man subj' came in, perhaps that same night. He delivered the note to him & there was no particular reaction.

The man had a white mustang. All this occurred about 4 or 5 months ago. He never saw the man again & is not sure he could even recognize him today.

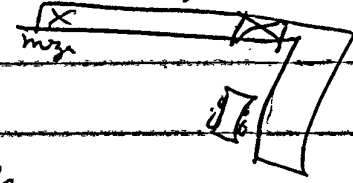

Subj. told her he had a car outside & wanted to take her to the Posada Vallarta where they would spend the night. She refused to leave Casa Susana & said he could spend the night in her room. He decided to stay & she never saw the car.

Subj. slept w/ her that night & left the following morning at 8⁰⁰ AM.

Margarita went to Guadalajara that day for about 8 days and when she came back the subj. was going with ~~Irma~~ Irma. For about 3 days running the subj. appeared at C.D. each day & spent his time w/ Irma. ~~At about 11 PM~~

Then one day the subj. came in and Irma was drunk. He asked Margarita to sleep with him but she told him to go to Irma. He replied that he was through

He does not recall that subj. smoked. Says he knows nothing about marijuana.

He & his brother Eleno "El Chino" operate a cantina & beach front setup. He recalled the American with the white Mustang who came with "Irma", a Calcutt girl, & "Rodi" a bartender from P.V. ^{several months before.} He did not get a good look at the American because he stayed on the beach with the girls & let "Rodi" take things from the cantina out to the shelter.

"Rodi" said the guy was spending a good deal of money on Irma but no figure was mentioned & Guzman did not see his money.

Guzman said the American came back two more times. ~~with American girl~~ He had a different Am. girl with him each time. He did not know the girls & presumed they were tourists. They were attended by one of the part-time waiters who appear at the beach on busy days & Guzman did not see them directly.

Guzman cannot recall ever seeing the subject or any of the Am. girls again.

All activity was w/in about a weeks time & several months ago.

 He did not leave sun glasses. He spoke little sp.

"Chino" said he was unable to recall any other
 visit by subj. to the beach & knew nothing of any

"Chino" thought he recalled seeing Jalendo,
