On 4-8-68, at approximately 9:30 p.m., WINSTON M. SCOTT, local CIA Station Chief, called the writer to advise that he had just received word that a suspect had been developed who was either already in Mexico City or would soon arrive by plane. He stated that he would be able to furnish additional details within the hour.

At approximately 10:00 p.m., same date, SCOTT advised that CLAUDE CHESTER MC LAREN, JR. was at the Mexico City International Airport, having arrived earlier from Honduras, and was scheduled to depart on Pan American Airways (PAA) for Houston at 11:00 p.m. He stated that MC LAREN was the bearer of United States passport [REDACTED], and was born 9-12-36 in Texas. He stated that his sources at the airport had advised that MC LAREN bore a striking resemblance to the sketches which had been circulated of Unsub, and that he was also behaving in a very nervous manner while waiting for his flight to depart. SCOTT was able to give no further descriptive information or details as to why MC LAREN was considered a suspect.

SA RICHARD S. CLARK determined from PAA that the only flight to Houston during the late evening on 4-8-68 was Flight No. 502 scheduled for departure at 10:20 p.m., and arrival in Houston at Midnight. All of this information was relayed to ASAC KARL V. HETHERINGTON, Houston, who stated that his office had no information to support the suggestion that MC LAREN might be a logical suspect. He stated that he would contact the Memphis Office and take whatever action thereafter seemed appropriate.

At 1:30 a.m. on 4-9-68, ASAC HETHERINGTON advised that MC LAREN had not been identified among the passengers on incoming PAA Flight 502 and that, according to the pilot, Captain WHITE, MC LAREN had not been permitted to depart from Mexico City by Mexican authorities. HETHERINGTON also quoted Captain WHITE as stating that MC LAREN had been ticketed to Honduras from New Orleans on PAA on 3-30-68. WHITE had apparently brought with him a photograph taken of MC LAREN in Mexico City which, according to HETHERINGTON, did correspond very closely to the sketches which have been circulated depicting Unsub.

ASAC HETHERINGTON stated that a teletype had just been received indicating that all domestic Offices were to institute investigations to identify and locate one HARVEY LOWMEYER or LOWMYER, who is described as about 5'8", in his early 30's, with brown hair and brown eyes. It has been determined, according to HETHERINGTON, that the murder weapon was purchased in Birmingham, Alabama, on 3-29-68 or 3-30-68. It is believed that the individual named in the teletype is the person involved in the purchase of the weapon, although HETHERINGTON did not have sufficient details in the teletype instructions to conclusively establish this.

On 4-9-68, Mr. SCOTT advised that he had checked with his sources at the airport and was told that, as far as they could determine, MC LAREN did leave Mexico City on the PAA flight and this determination, according to SCOTT, was based on the fact that his name was on the manifest and that he had been seen boarding the plane.

SA CLARK has been in contact with Lic. JORGE VAZQUEZ ROBLES of Gobernacion, who had essentially the same information furnished by SCOTT and no information to contradict the story that MC LAREN did depart as scheduled on the PAA flight.

The Noon edition of "Ultimas Noticias" carries a story indicating that a suspect named JOHN WILLIARD has been developed and that he is "suspected" of being in Mexico. The story also refers again to earlier press accounts that the Mexican Government is watching the border in an effort to bar Unsub if he should attempt to enter Mexico. Radio VIP, at

MEX 173-NEW

11:00 p.m. on 4-8-68, in connection with this story, stated that Mexican officials had explained that this action was voluntary on their part and not in response to any request from U.S. agencies.

An effort is being made through direct contact with PAA to establish whether MC LAREN did, in fact, depart Mexico on the flight in question.

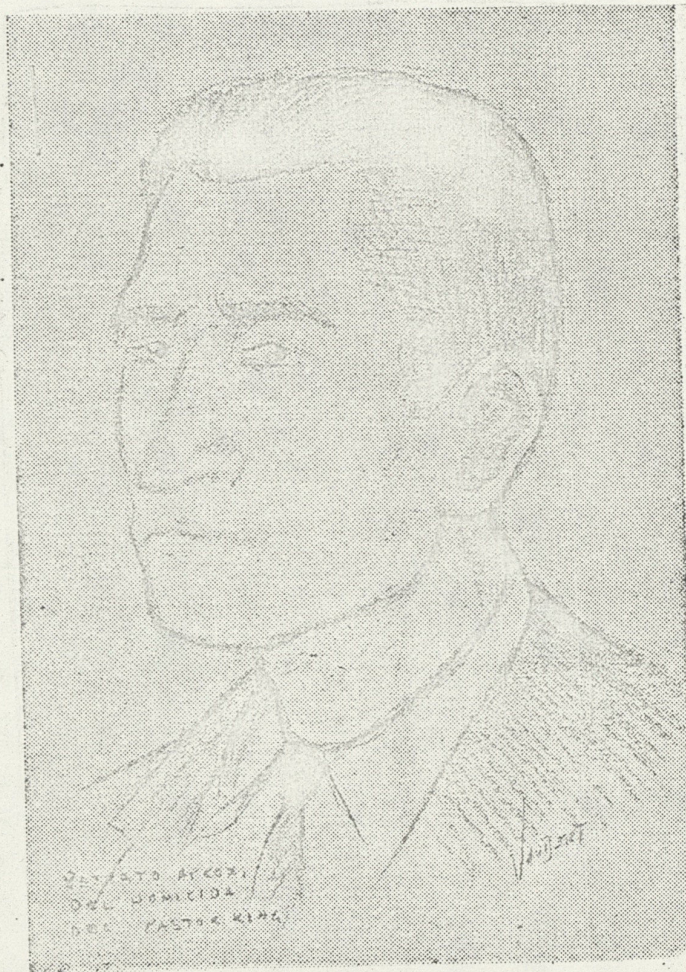

1. Subject arrived in Mexico City aboard TAN airlines from Tegucigalpa, Honduras on 8 April 1968 enroute to Houston, Texas. Since his appearance was similar to a published artist's sketch of the alleged assassin of Martin Luther King, Mexican police officials made candid photographs of subject (one copy of two poses is enclosed). They also determined that he was scheduled to depart on flight 502, Pan American Airlines for Houston, Texas, at 2215 hours on 8 April 1968. Subject departed on this flight occupying seat number 41.

2. Subject's address in the United States is 5405 Wichita Street, Fort Worth, Texas. He carried US passport [REDACTED] issued 29 January 1963. Reportedly, he works for C.A. MAQUINARIAS, Maracaibo, Venezuela. His passport contains a stamp indicating that he entered Tegucigalpa on 30 March 1968.

3. Also enclosed for your use in any investigation is a Xerox copy of the artist's sketch and newspaper article.

Enclosed, as of possible interest to the Bureau, are two copies each of two photographs taken of McLAREN at the Mexico City International Airport on 4/8/68 and two copies of the sketch by a local police artist.

ReBucab 4/10/68.

As instructed, six copies of each pose of McLAREN and six copies of the sketch were forwarded by airmail to the Birmingham and Memphis Offices before noon on 4/11/68. Since Mexican postal facilities are closing down for a holiday week end at noon, 4/11/68, identical sets are being forwarded in envelopes bearing United States AMSD postage by the pilot of Pan American Flight 502 to Houston, Texas, where he will place them in the United States mails at approximately 12:15 a.m., 4/12/68.

For the Bureau's information, the local police artist who prepared the sketch in question is SERGIO C. JAUBERT, who serves the Metropolitan Police and the Judicial Police of the District and Territories in Mexico. He has not been in direct contact with this office and has, according to police sources, relied completely on press accounts concerning the appearance of UNSUB.

For the Bureau's further information, the Mexico City press has given broad coverage to this case and, in recent editions, has given particular attention to the reported account of ROLANDO VELOZ, affiliated with the Mexican Consulate in Memphis, Tennessee, which deals with a tourist permit issued on 4/3/68 to a man giving the name JOHN SCOTT CANDRIAN, 1339 Western Avenue, Chicago, Illinois. VELOZ is quoted as saying that the man bore a "striking resemblance" to the description of UNSUB broadcast by authorities and that the man stated he would enter Mexico approximately 4/13/68 and intended to visit the Mexican seaport of Mazatlan, Sinaloa. VICTOR MANUEL GUERRO, Sinaloa State Attorney, is quoted in 4/11/68 editions as stating that he has called in some 24 investigators to look for UNSUB.

MURKIN IS THE CODE NAME FOR THE CASE INVOLVING THE MURDER OF MARTIN LUTHER KING, JR., ON APRIL 4, 1968, IN MEMPHIS, TENNESSEE. IMMEDIATELY AFTER THE SHOOTING A WHITE MALE WAS SEEN FLEEING FROM FLOPHOUSE FROM WHICH SHOT WAS FIRED AT WHICH TIME HE ABANDONED A NUMBER OF ITEMS WRAPPED IN A CLOTH APPEARING TO BE A CHEAP BEDSPREAD. THESE ITEMS WERE A REMINGTON THIRTY OUGHT SIX PUMP RIFLE, A GUN BOX IN WHICH THE RIFLE WAS CONTAINED, AND A BLUE ZIPPER OVERNIGHT BAG CONTAINING A NUMBER OF DRUG ITEMS, TOILETRIES, TEE SHIRT AND SHORTS AND OTHER ITEMS INCLUDING A PAIR OF BINOCULARS AND A BOX FOR THE BINOCULARS.

SUBJECT: MURKIN

At approximately 11:45 a.m., 4/12/68, SAC JAMES COLE, San Antonio, called to furnish information from a Bureau teletype concerning ERIC STARVO GALT. He said the teletype states that it has been established that GALT was in Memphis on 4/4/68, reportedly driving a 1966 white Mustang with Alabama license [REDACTED]. The Bureau has instructed that GALT be located and questioned in captioned matter and that San Antonio place stops at the Mexican border, which has been done.

GALT, according to his driver's license, is described as a white male, 5' 11", 175 lbs., blue eyes, brown hair, born 7/20/31. The car is described as a 1966 white hardtop Mustang, VIN 6T07C190647.

COLE stated that Inspector J. A. SULLIVAN had called him from Memphis to advise that the above car had been recovered on 4/11/68 by Agents in Atlanta and that there were two Mexican tourist stickers on it. The stickers gave the date October 1967 and folio #H294486, indicating that the car had been processed by Aduana at Nuevo Laredo, Tamaulipas. COLE stated that a check had been made at Nuevo Laredo which established that GALT, using his true name and in the above car, had crossed the border on 10/7/67. He had tourist card FM-5, [REDACTED], and listed his address as 2608 Highland, Birmingham, Alabama. He stated he was single and employed in Birmingham, Alabama, and that his destination was Mexico City.

COLE stated that Inspector SULLIVAN asked him to call this office to determine whether any information could be developed here as to where GALT went or what he did while in Mexico and when he left Mexico. COLE said Memphis has information that GALT was in Los Angeles during November 1967.

COLE was told that all possible efforts would be made to obtain this information but that experience in past cases has shown that it is extremely difficult to locate records of departures from Mexico in view of the manner in which Mexican Immigration and Customs records are filed.

On 4/11/68 at 8:13 p.m., E. J. McDONOUGH of the Civil Rights Section at the Bureau called the writer to advise that the Bureau wanted flights from Atlanta, Georgia, to Mexico City checked from 4/5/68 to date for the following names:

ERIC STARVO GALT, or GAULT;

HARVEY LOWMYER;

J. WALLIS VERNON, aka Jerome Vernon;

JOHN WILLARD.

Mr. McDONOUGH stated that all variations of these names should be checked on any passenger lists for the flights in question.

Section Chief CLEM McGOWAN then came on the line to request that one WILLARD BOYKIN, who was located at the Hilton Hotel in Guadalajara, be interviewed because he had reported to his employer in Los Angeles that a tourist guide stated to him that the individual who killed the Rev. KING was at the Four Winds Hotel in Puerto Vallarta. McGOWAN stated that this information had just been received by teletype from Los Angeles and that any logical subsequent leads should be followed.

The information received from McGOWAN was furnished to SA ROBERT J. OGLESBY, JR., at approximately 11:00 p.m., 4/11/68, and he stated that he would take immediate steps to arrange an interview with BOYKIN.

By cable, 4/11/68, the Bureau instructed that the check of passenger lists be expanded to cover all males on any flights out of Atlanta to Mexico City covering the period 4/5/68 to date.

KEY FOUND IN BIRMINGHAM

The following information was received 4/15/68 from ALEJANDRO CORTINA, Assistant Manager of the Hotel Maria Isabel, Paseo de la Reforma 325, Mexico 5, D.F., Mexico.

All their room keys have a brass tag affixed with the request in Spanish that the key should be returned to them at Paseo de la Reforma 325. In addition the keys are "ALBA" keys and all carry the number "MIR 39034". The reverse side of the brass tag carries the stylized monogram of the Hotel "MI". Therefore the key described is undoubtedly the key to room 1131 of the Hotel Maria Isabel in Mexico City.

He noted that they do not file their registration cards by room number but alphabetically. The only listing by room numbers is the daily register of arrivals and departures. Due to the large number of guests a check of these lists would take considerable time.

Nevertheless such a check has been initiated and results are expected in two or three days. This will be a list of names of persons occupying this room for the past few months. In addition the housekeeper is being contacted to determine if there is any record as to when this room key might have been missed.

The following information was received telephonically from SA RUSSELL JEAN GRAY, JR., on April 16, 1968, at about 9:30 a.m.:

It has been determined that ERIC STARVO GALT, after leaving the Rio Hotel at Puerto Vallarta, Jalisco, checked into the Tropicana Hotel on November 7, 1967, and stayed until November 13, 1967.

A bartender, LUIS GARCIA, who works at the Hotel Oceana, has stated that he was acquainted with GALT for a few days at about the time he changed hotels. GALT told him that he had been in the Army for nine years and had served as a driver or chauffeur but had never been out of the United States before. GALT had a white Mustang and complained that one tire was larger than the others and that this made the car run poorly on the highway.

GARCIA said that he became acquainted with GALT when GALT came into the bar and that they were friendly for three or four days but finally broke up when GALT indicated an interest in obtaining some marijuana. GARCIA stated that he did not want to become involved in any way with marijuana and, therefore, terminated his association with GALT.

Of those interviewed who recalled GALT, the sketch with the short hair or crew cut has been identified as a good likeness, but one or two individuals pointed out that the nose should be a little more pointed and that GALT was a little bit heavier in the cheeks. He is also described as a serious-appearing individual who walks very deliberately.

GARCIA said that GALT had a portable typewriter in his hotel room but did not know the make of the machine.

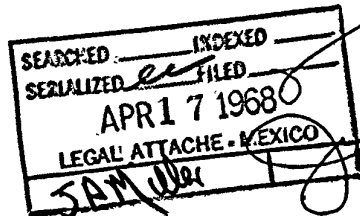
