In connection with the captioned case there has been speculation that James Earl Ray concocted the alias of Eric Starvo Galt by combining the names of characters from books by Ian Fleming and from a book "Atlas Shrugged" by Ayn Rand. This speculation is based on the fact that in the James Bond books by Ian Fleming there is a character named Ernst Stavro Blofield and in "Atlas Shrugged" there is a character named John Galt, as well as one named Eric Starnes. Ernst Stavro Blofield is a formidable person, John Galt is a "social drop out" and Eric Starnes is described in the book as a "whiner" from a low-class family.

In view of the above and in order that Agents handling this investigation can be alert to the possibility of Ray's utilizing an alias based on characters in Fleming's books, there is set out as an attachment to this airtel a list of various characters in those books for your assistance.

1. The full text of the allegation received from David G. Fox, graduate student, University of Michigan, Ann Arbor, Michigan, which was requested by Guatemalan authorities, is as follows: Fox advised April 30, 1968, that April 24, 1968, while visiting Guatemala, he was told by Paulino Jarquin, operator of Restaurant Catoc, Kilometer 87, Department of Tectan, Guatemala, that James Earl Ray reportedly in Central America and was reportedly seen in Guatemala. Fox stated he was recognized by Jarquin as an American, at which time Jarquin made the above statement. Fox did not question Jarquin about time Ray seen in Guatemala or by whom.

The following information was received 5/16/68 on a confidential basis from Attorney JORGE VAZQUEZ ROBLES, Chief of the Inspection Service of Mexican Immigration:

It is noted that this is in relation to the allegation that the assassin of Dr. MARTIN LUTHER KING was seen entering Guatemala at Tapachula, Chiapas. The Mexican Immigration Service had previously alerted the Mexican Immigration Office in Tapachula, Chiapas to be alert for the possible presence of Subject RAY in that vicinity and particularly to be alert to his attempts to travel to Guatemala.

The "El Herald", a Mexico City Spanish language newspaper, and other papers, printed a report that a taxi driver named MIGUEL ANGEL CONSTANTINO CRUZ, claimed to have transported an individual possibly identical to Subject to Guatemala on the night of 5/3/68.

The Chief of the Mexican Immigration Office in Tapachula interviewed this taxi driver and following is a summary translation of the statement:

At Tapachula, May 13, 1968
Statement of MIGUEL ANGEL CONSTANTINO CRUZ, Mexican, age 34, bachelor, occupation taxi driver, residence 2a Avenida Oriente #7, Tapachula.

He was questioned concerning an article in the papers to the effect that the assassin of Dr. MARTIN LUTHER KING had been transported to Guatemala in his taxi.

He furnished the following information under oath:

On 5/3/68, a Friday, at about 9:00 p.m., while driving on the Anillo Pereferico in Tapachula, near the Social Security building, he was stopped by an individual who wanted to travel to the border. He asked this individual if he wanted to go to Talisman or to Ciudad Hidalgo, inasmuch as cab fare to the former is 20 pesos (\$1.60 U.S.) and fare to the latter is 30 pesos (\$2.40 U.S.). The individual consulted his map and answered he desired to go to Ciudad Hidalgo. He got in the vehicle, which is a Valiant with license 33-55B, belonging to the Sitio Sarabia.

They started for the border and more or less in the vicinity of the "Caseta Fiscal" (Customs Station) known as "Faro" on the outskirts of Tapachula, this individual took out a knapsack such as that used by the U. S. Army. From the knapsack he took and drank a can of Nestles milk. While he was doing this, the driver saw through the rear view mirror that in the knapsack there was an Army type automatic pistol. When this individual saw him looking through the mirror, he changed the position of the mirror.

As it was nighttime, the driver was frightened, but nevertheless continued to Ciudad Hidalgo and once there, this individual told him to let him off at the entrance to Ciudad Hidalgo at the gasoline station.

He considered that this individual was an American because he spoke Spanish poorly and with a foreign accent.

Although it was nighttime, he could estimate that this individual was about 5' 5" tall, weighed between 150 and 160 pounds, light colored eyes, white skin, heavy build, wavy hair. He had a scar approximately 2.5 centimeters long above the right eyebrow.

When this individual got out of the car he paid with three dollars U.S. and told the driver to keep the change.

About three days thereafter, the driver read in some newspaper that the American JAMES EARL RAY, accused of the murder of Dr. MARTIN LUTHER KING, had been seen in Guatemala

in a restaurant. From this he drew the presumption this might be the same person he had transported in his car, without being sure about this. Inasmuch as he is a correspondent for the newspaper "El Herald" in Mexico City, several days thereafter when a reporter for this paper, ANGEL TORRES, called him he told the reporter that possibly the individual who had been seen in Guatemala was the person he had taken to Ciudad Hidalgo. He was certain that TORRES drew the wrong conclusion from his version of the facts and therefore, the article appeared in the form in which it did.

Independently of this translation, Immigration officers advised the driver was shown several recent photographs of the Subject and stated they were not identical to the person he had transported to Guatemala.

In connection with the possible identity of this person, the following is a list of Americans who departed Mexico for Guatemala at Ciudad Hidalgo on 5/3/68:

retained. WATSON appears to be the best bet for several reasons. In the first place he made the most direct journey from the United States to Guatemala. In addition, he is apparently the last entry for departure on 5/3/68. It is noted that the cab driver's statement does not bear out the newspaper allegation that the Subject apparently was trying to sneak into Guatemala. However, a cab driver might well not desire to go into this matter with Mexican Immigration authorities.

There was no record of any departures from Ciudad Hidalgo on 5/4/68.

A search of the long distance telephone records at Mazatlan relative to long distance calls made from Puerto Vallarta has shown the following calls made from the office of the telephone company at Puerto Vallarta:

1) A call on 11/5/67 from a Mr. RAY to Los Angeles telephone number 213-8934112 to a "Srta. SANCHEZ."

2) A telephone call on 11/5/67 from Mr. RAY to Los Angeles telephone number 213-8934112 to a "Srta. SANAY."

3) On 11/23/67 a telephone call made by a Mr. JOHN to Los Angeles telephone 6709151. Another telephone call made by the same individual as a collect call to Los Angeles which was recorded as being made to telephone 213-2208. That number is obviously incomplete but this, according to the informant, was the way it was recorded. SA OGLESBY pointed out that this call may or may not have been pertinent to this case but it was listed by the informant as a suspicious call due to the fact that it was made by a Mr. JOHN.

4) On 11/3/67 a telephone call was made by a Mr. RAY to San Francisco telephone number 415-3473027. It also appears from the telephone company records at Mazatlan that an alternate call may have been placed to San Mateo, California, W 3429464189. The informant was unable to explain the letter "W" preceding the number.

5) On 11/8/67 a collect call was made from Mr. RAY to DON LIVELY at Dallas, Texas, telephone number 214-AD95447. There were actually eight separate calls made to that Dallas number by Mr. RAY but the informant only furnished the date of one call.

The informant advised that approximately 400 long distance calls per day are made from Puerto Vallarta and he checked for the 30-day period during which RAY, under the name of GALT, was known to have resided in Puerto Vallarta. No calls were listed under the name of GALT or any of the other known aliases of RAY.

The informant while in Mazatlan also checked all of the hotels and motels but found no records of RAY under the alias of GALT or any of his other known names. Informant noted that on 12/20/67 one A. GALAT (the closest approximation of any name registered to GALT) had stayed at Los Cocos Hotel on 12/20/67. He arrived at 11:00 p.m. that date, was assigned room #6, and left the next morning. He was registered as coming from Richmond, British Columbia, Canada. His occupation was given as miner and his automobile license was 88400 (state not given). From the timing and information available, however, it does not appear that GALAT is identical with GALT.

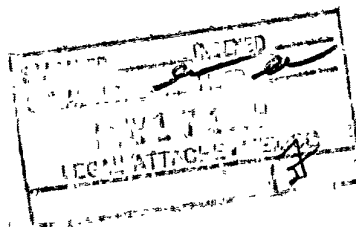

At 3:30 p.m., SAC SHANKLIN of the Dallas Office telephonically advised that a "package" was being forwarded to us on Bureau instructions and would arrive in Mexico City on Braniff flight #3 which is scheduled to arrive in Mexico City at 9:36 p.m. The package will be taken to the station manager's office to be turned over to an Agent of this office.

With regard to the telephone numbers obtained by MEX-24 at Mazatlan relative to phone calls made from Puerto Vallarta, SAC SHANKLIN advised that Mr. DON LIVELY had been interviewed in Dallas and he had stated that the only "RAY" he had met in Puerto Vallarta was RAY CARSON who had telephoned him various times regarding proposed purchase of real estate at that resort. He described CARSON as a fly-by-night real estate man who had been trying to sell him property. On two occasions LIVELY had lived in Puerto Vallarta, one time at the Casa los Rapidos and another time at Casa Amarillo. CARSON resided in a private residence, address unknown to LIVELY, but had no telephone. LIVELY believed that CARSON had been expelled from Mexico for shady dealings and may have been deported to Costa Rica.

LIVELY was shown photographs of subject RAY and was unable to identify him as any individual he had ever seen in Puerto Vallarta.

While working in Puerto Vallarta, Jal. in connection with this case, SA RUSSELL JEAN GRAY, Jr. became acquainted with Mrs. WILMA CARSON, Negro female about 23-25 years of age. She is the wife of RAY CARSON and resides next door to the Olas Altas Pharmacy, corner Olas Altas and Manuela Dieguez. Her husband, a white male, was one of about 25-40 Americans deported from the Pto. Vallarta area by Gobernación during February, 1968, in a crackdown on marijuana selling and beatnik types in general. The talk in Vallarta was that RAY CARSON was buying and selling marijuana and perhaps more potent drugs.

It will be noted that SA GRAY did not interview Mrs. CARSON concerning her husband or look further into his alleged activities. A physical description is not available.

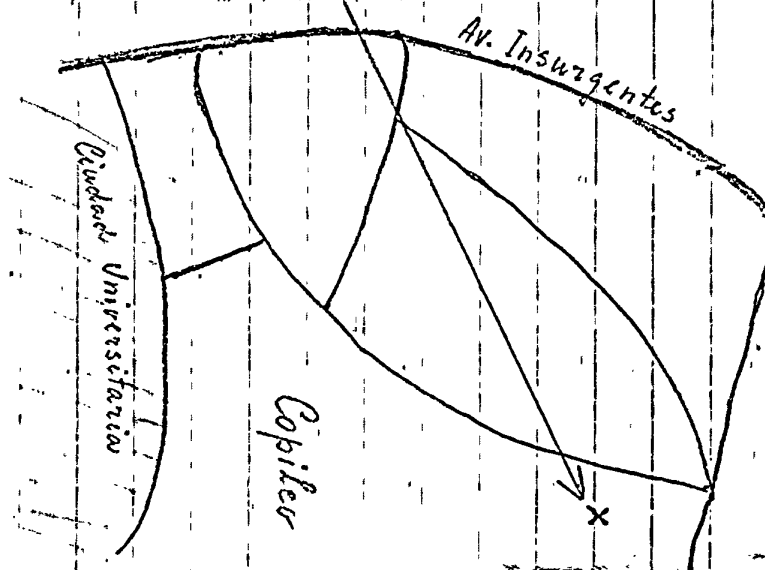

In order to cover the possibility that subject may have died since commission of the crime, the U. S. Census Bureau and Department of Health, Education and Welfare were contacted and they advised that no central records of unidentified deceased are maintained by those agencies. It was suggested that each state may maintain such a record in their Bureau of Vital Statistics or similar agency.

There is no known Federal law requiring the maintenance of such information; and it is possible that if any record of unidentified dead is maintained, it would only be maintained at local police departments, morgues, medical facilities, or the like.

Each office covering state capitals should check to ascertain if such records are maintained, and if so, should check records for the period from 4-5-68, to date, for any information which might possibly identify subject Ray with unidentified deceased person over that period.

If there is no central record repository maintained in the various states or nationally in the case of Mexico and Canada, you should, in connection with your contacts with law enforcement agencies on this case or other Bureau matters, make appropriate inquiries relative to

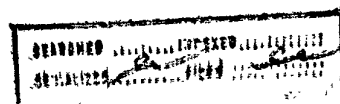

HE HAS BEEN IN HONDURAS FOR APPROXIMATELY FORTY YEARS AND HAS BEEN MARRIED TO A HONDURAN WOMAN FOR ABOUT 32 YEARS. WARE HAS THREE CHILDREN ALL OF WHOM LIVE IN HONDURAS. WARE BECAME A HONDURAN CITIZEN THIS YEAR. AS PREVIOUSLY REPORTED WARE LIVES AT PENA BLANCA NEAR LAKE YOJOA, DEPARTMENT OF CORTES, HONDURAS.

2. JAMES RANSON, AN EX-PCV AND NOW A FARMER (AND WHO PROVIDED ABOVE INFORMATION) SAW WARE APPROXIMATELY ONE MONTH AGO. AT THAT TIME WARE TOLD RANSON HE HAD HIDDEN A DEPUTY SHERIFF FROM GEORGIA OR MISSISSIPPI WHO WAS A SUSPECT IN THE MURDER OF SOME CIVIL RIGHTS WORKERS. RANSON DID NOT RPT NOT KNOW NAME OF DEPUTY SHERIFF OR TIME HE WAS ALLEGEDLY IN HIDING.

3. ON HIS LAST VISIT TO THE FARM, RANSON ASKED WHETHER THE KILLER OF MARTIN LUTHER KING HAD BEEN CAUGHT. WARE ANSWERED IN THE NEGATIVE AND ADDED THAT HE PROBABLY WOULD NOT RPT NOT BE AS HE WAS UNDOUBTEDLY DEAD BY THIS TIME.

4. DURING THIS VISIT RANSON NOTICED TWO AMERICANS STAYING AT THE WARE FARM. WARE SAID THESE MEN WERE ENGINEERS FROM TEXACO COMPANY IN SAN PEDRO SULA AND RANSON BELIEVES THIS TO BE TRUE AS HE HAD SEEN ONE OF THE MEN IN THE HOTEL BOLIVAR IN SAN PEDRO SULA.

5. WARE DID MENTION TO RANSON ON A PREVIOUS VISIT (2 MONTHS AGO) THAT HE INTENDED TO MAKE A TRIP TO GEORGIA TO SELL SOME LAND.
