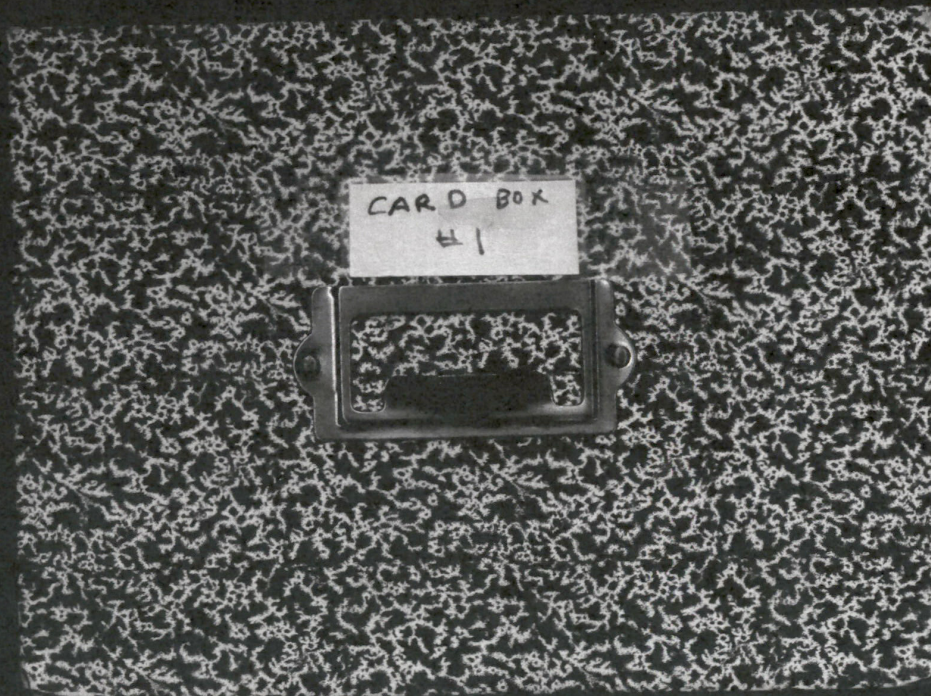

said, "Yeh, it was a shot." Shot had been fired from nearby, but Anschutz not sure where. After man had run down hall Stevens came out of his room. Anschutz went to bathroom and looked out window. Policeman in backyard said to get away from window. Anschutz reported shot to Mrs. Brewer, then resumed watching TV.

Feb. 12, 1967. Arvidson talked with Galt on
several occasions; once interviewed him for about
two hours in attempt to benefit Galt socially
through the dance lessons.

Galt said had been in Mexico, believed
to be in early 1967. Arvidson thinks Galt said he
had restaurant in Mexico. Galt always wore shirt
and tie, often wore expensive alligator shoes, be-
lieved to be loafer style. Galt said he was Mer-
chant Marine. When he quit, Galt said he wanted to
attend bartender school so he could open a restau-
rant.

ARVIDSON, Rodney (cont'd)

Galt backward socially, ill at ease, did not relax in mixed group. Galt drove white car. Galt did not smile readily, but had "crooked" smile, would not look you in eye. Never had associates. Galt always paid cash from roll of bills in trouser pocket.

Arvidson said Memphis composite very similar to Galt except hair line and chin line.
