Ray) 11/27/67; wanted to overcome shyness and self hyponosis - had appointment that afternoon 11/27/67 at 5 p.m., 9952 Santa Monica Blvd., Beverly Hills. Ray told doctor he was single, from E. St. Louis, born 3/10/28. Said cook on boat, now unemployed. Impressed doctor as being in excellent physical health, no headaches, no nervousness, no deep animosity. Told doctor he had no "deep dark secrets". Was cooperative with doctor. Doctor hypnotised him; was cooperative and it was easily done. Told doctor he was getting better.

I.D. Ray photos - 4/19/68

Ray came to 6 appointments 11/27/68, 12/4/67, 12/6/67, 12/11/67, 12/14/67 and cancelled appointment on 12/18/67. Told doctor his brother in Louisiana had found him a job in New Orleans in Merchant Marines and could not come again. Ray paid \$25 a visit in cash each time. Possibly sent one money ~~order~~ order for final payment.

All 3 went to Club Los Labos where Galt got drunk or sick. Went to sit in car. Galt then took Garcia home, saying he wanted to stay with girl.

Galt drove white mustang, red insides, automatic. Blue license plates. Galt complained one car tire was too large. Galt said plates said alabama.

Garcia went to Galt's room day after picking

Agents checked register; no Galt listed. Garner stated that a man named FNU Galt was a roomer but didn't register. Between 5 and 6 pm, April 5, 1968, Galt approached another roomer, Fred C. Jones, who was sitting in front of building. (Jones has room #1, 113 - 14th St.) and asked about a room. Garner joined them. Galt said he wanted single, quiet room. Garner said he could put him in a double room, #5, 107 14th St., and would move him to a single when available. Garner noted that Galt drove black car, probably Ford, 62 or 63, out-of-state license. Garner received \$11 (\$10.50 for room, .50 for key deposit).

Galt moved into room #5, 107 - 14th st. on April 7, he moved to room #6, 113-14th St. On same day Fred C. Jones brought

a fellow-employee, Harold G. Anderson to bldg. Anderson assigned to room #2 113 14th St.

9 p.m. , April 9, 1968, Galt and anderson together told Garner they were checking out to go to Michigan. Rooms were vacant next day.

Agents went to Galt's room. Saw package and 2 letters addressed to Galt in hall postmarked 4/1/68, 4/9/68, 4/10/68. Garner unable to explain how letter was sent to that address before April 5. Garner said Galt left nothing behind.

Description of Galt: White male, 32 -35 5' 11", 190 lbs, dark brown or black hair worn in a brush cut, blue eyes, medium "outdoor" complexion, Southern accent.

Galt rented room on March 24, 1968, late in evening. Assigned to room #2, 113 ~~11~~ 14th St. Galt paid rent on due-date, March 31, 1968, about 1 or 2:30 pm, and paid for one week in advance.

On April 5, 1968, Garner entered room to change linen. Found note on laundry's shirt-backing saying that Galt had gone to birmingham and would return in a week for his T.V. set. Garner destroyed note. Description: White male, 33-35, approx 6' slender build, black hair worn short possibly parted on side. Garner had

previously noted that Galt had light-colored, possibly white, car. (On April 15, Garner called a roomer, Harold Waters, to see if he knew make of car.)

Confessed drinking sprees lasting several days.

Began drinking in room Friday 3/22/68. On Sun. afternoon, before dark, Galt appeared and asked for single room. 113 14th St. had been closed due to hippie invasion. No single available at 107 14th , so Garner opened 113. Galt produced partly consumed bottle of vodka, and had drink in 113, room 2. Galt said room #2 was too small. Shown room #4, storage. Did not see any of Galt's possessions at that time. Garner put padlock, unlocked, back on hosp of room #4 when left. Garner returned to room at 107 and probably finished vodka Galt left. Bottle probably thrown away. Remembers no

specifics of conversation because drink.

Garner says Galt wrote name not on first meeting. but a week later 3/31/68 when paid rent for 2nd week.

Garner drank through week of 3/24 and did not start Sobenno until that weekend. Thinks he may have gone into Galt's room 3/26/68 - Tuesday - but not sure.

May have gone in Galt's mustang during first week as questioned by an acquaintance about what he was doing - no memory of ride, nor does he remember acquaintance who asked him about it.

Saw Galt 3/31/68 Sunday when saw Galt in hall of 113 and Galt paid him for another week, RR

and wrote name on envelope. Did not go into his room. Garner has been sober from 3/31 to 2nd spree starting 4/19/68. ~~Wix~~ He is sure he did not see Galt from 3/31 on. May have seen car at various times, but unsure as to where or when.

On 4/5, went to 113 around 10 am from restaurant to get linen. On bed in Galt's room found note, poss. on cardboard, that said in effect Galt had gone to B'ham and would return in about a week for his belongings. Noticed that storage room locked. At later date went in it and says Galt's possessions.

Assigned to Tactical Unit 10 (3 vehicles, 12 officers), stopped at Memphis Fire Dept. at Main and Butler, 1/2 block from Lorraine at about 6 pm, 4/4/68. Negro detective ran into firehouse and said King was shot.

Ghormley ran east on Butler to Mulberry and north on Mulberry toward Lorraine Motel, saw Negroes on balcony pointing to a building west of motel, the front of which was on S. Main.

Ghormley retraced steps around firehouse and ran north on Main.



Noticed blue suitcase, rifle box, blanket. Canipe said man dropped it and gave description. Ghormley relayed information to dispatcher by walkie-talkie. Canipe mentioned white Mustang. Relayed info to dispatcher.

Ghormley guarded the articles so no one could disturb them. Other officers arrived.
