boats."

Huie Story: Huie said Ray served 7 years  
of 20 year sentence at MSP. While there  
had 8 visitors, one of whom was brother.



While there, hid razor, green prison trousers dyed black, 12 Hershey bars before escape. Put \$300 in shoe, escaped in bread truck, walked to Chicago.

Ray read Ad for help at Indian Trail Restaurant. During employment at restaurant, recognized by an unknown who recognized Ray and threatened to reveal Ray if Ray did not work for him. Ray was given \$1200 in initial contacts and was ultimately paid \$15,000 but due to receive more. Told to investigate crossing Canadian Border and told to get names from paper for passport. Ray went to Canada 3 times.

Ray then given more money to buy a Mustang and told to drive to Acapulco for tourist sticker. Then drove through Mexico to West Coast and hid out there awaiting instructions.

Ray was flown to Atlanta from West Coast, but time not right, so sent back. King was allegedly in Holiday Inn in Atlanta when Ray flown there.

Ray was given money to obtain binoculars, and gun and was to go to Memphis to be in room 312 or 313 at 3 pm. There were allegedly other individuals who came to this room.

Huie said Ray did not actually kill King and would identify killers at trial. Ray picked up rifle, ran to car and drove to rendezvous spot in Atlanta where he waited several days to get "bundle" of money. The plan was to go to Mexico and immediately fly north, but since money did not come, went directly to Canada and got passport to England.

Believed Ray came to work with Willie Perry and  
Fred Burns, fellow employees. No racial comments.  
Said was in Germany during war.

Kyles was in room 306 with King and Abernathy while they freshened up for dinner about 5:55 pm King left room and stood, talking with associates, on balcony, Kyles left room, spoke to King, walked past King heard shot., ran back to King and saw bullet wound. Abernathy came out of room. Kyles put bedspread over King's body. Abernathy tried to speak to King. Police



arrived; ambulance arrived.

Some people pointed to empty land and bushes, indicating shot might have come from west to east.
