Slip for dry cleaning, indicates a tag with 8/755 would be stapled on dry-cleaning.

Description of clothing: black check suit coat with small check blocks, dark gray trousers, black tie with tan and brown diagonal stripes.

Description of Galt: in 30's, approx. 185 lbs, slightly more than 6' tall

Laundry and dry-cleaning picked up by same man between 9 am and 10 am (possibly closer to 9), on April 5, 1968.
