On 6/5/68, Wednesday, at 4 or 5 p.m., Sneyd asked to rent room for 3 nights, given room #2. Before went into his room, Sneyd said he was Canadian, and came from Toronto and was tired.

On 6/6/68, she brought him his breakfast at 7:45a.m. and found door locked from inside. She walked away a few paces, and he got tray. That afternoon at 4 p.m., she went in, and he was reading on his bed. She asked for the visitor's book, asked

his name, and was told Sneyd. He said he had a flight booked to Germany.

On 6/7, Friday morning, she took him his tray. At 10 am, she told him she had to move him to room 3. May have seen him that evening.

On Saturday morning at 9:30 a.m., saw him rush out into cab with an airflight bag.

He had 4 phone calls while there. Two from BEA who asked for Sneyd concerning fare and possible flights.

On 6/6 evening, a lady called with no message. She sounded American.

On Friday, 6/7, morning, a man called leaving no message. A white postcard came for him also.

call; no records kept of local calls.

Galt received one or two letters per week.  
Galt watched for letters and usually came to desk to  
ask for mail at 10 a.m.

Galt maintained irregular hours and did  
not appear to be employed. No visitors.

Could identify picture of Galt if he saw  
one. Description: white male, 35-40 yrs., 5'10",  
150 lbs., slender to medium build; dark hair, slightly  
graying at temples, combed with part on right; dark  
eyes; wore conservative suits; neat appearance; quiet,  
no accent.
