(2) Wrote letter 10/5/67 returning Crestline camera, saying he got all equipment mailed. Also said he was going to ~~xxx~~ Mexico 10/7/67. Letter received 10/12/67 with camera.

(3) On 10/18/67, company sent him Kodak camera originally requested, to B'ham address. Company advised by letter from Galt to send refund to Puerto Vallarta. Kodak camera returned 11/2/67.

- (4) Letter from Galt dated 11/20/67 asking refund be sent to Serrano, L.A. address as not received in Mexico. Said he'd be in LA for 5 months.
- (5) Company remailed refund of \$142.89 on 11/30/67 on 11/30/67 to Mexico. (canceled check not as of 3/29/68 been received).
- (6) Allegedly said by Burke to have called Burke 10/4 or ~~x~~ 10/5/67 saying he was returning camera and wanted refund - had a southern accent.
