April 11, 1968 approx. 2 p.m. Davis (Auto Theft Squad, Atlanta) received a radio message to meet someone at Connally St and Memorial Drive. These met Kenneth Jones and Iloe Powell, local ministers, who stated that a female named Lorence reported white mustang with Alabama license was parked in Capitol Home Parking lot since previous Friday.

Proceeded to lot found 1966 Ford Mustang, tow-door, white, with 1968 Alabama license 1-38993, backed into parking square. Observed 1967 Alabama license 1A-88354 lying on deck above rear seat. Car was locked. Davis unlocked left front door and determined vehicle Identification

No. 6T07C190647. Davis found a small metal key between two front seats on floor; took key and marked date and initials. Key was about 13/4" long, thin, flat, silver-colored metal.

Davis sent license-plate numbers and vehicle Identification No. to National Crime Information Center and State Police in Montgomery, Alabama. (Later discovered that one digit in a number sent to NCIC was deleted or wrong.) He received reply from Alabama State Police that NCIC had sent to them information connecting car to Eric Starvo Galt; no stolen information received.
