About 6 p.m., Canipe heard thud by
front door, looked up and saw bundle
lying in front dor way and saw a white
man walking south on sidewalk in front
of store. Canipe hesitated, then went
to sidewalk, looked in both directions.
Saw a white, small car, possibly a
compact, pull from curb on east side
of Main Street just south of store.
Only driver was in car.

Looked north, saw Deputy approaching with pistol drawn, immediately went back into store. After a number of officers arrived, their attention drawn to bundle. Bundle consisted of large rifle-size box, with top ajar and gun barrel showing, green cloth over bundle, maybe curtain. "Browning" written on box, suitcase or briefcase under cloth. Car he saw pull from curb was 2nd or 3rd from his ~~store~~ door. Canipe feels that man he saw on sidewalk is same as man in car.

Canipe started out, then backed up, and said, "Get back, there's some kind of trouble out here, and I don't want no part of it." Immediately thereafter saw Deputy who walked past. Saw Deputy again, then heard "screech" of tires and saw white Mustang speeding

north on Main St. past store.

Saw package containing pasteboard box, gun, luggage, cloth folded over these items.

Description of man: white male, 5' 8" to 5' 10", 160 lbs, average build, wearing dark suit.

Enter Canipe Amusement Co. about 5:30 pm, 4/4/68, with Finley. Graham saw man on sidewalk. Possibly he looked at the man because he heard running footsteps. Saw man drop package in front of store. Canipe leaned out front door, then stepped back in remarking about trouble outside. Immediately thereafter saw Deputy Sheriff go past. Deputy returned with other officers.

Graham saw package, including gun barrel in large box and green matting or cloth.

Before Deputy ran by, Graham heard screech of tires and saw white Mustang speed north on Main. The other car, believed to be a white Rambler, was still there and obscured view of Mustang. Positive car was Mustang. Description of man: white male, 25-30 yrs, 5' 7" to 5' 8", 165 lbs, average build, black or dark brown hair, dark clothing (either dark suit or dark dress jacket and slacks), no hat, neat appearance.
