Ray mentioned previous trips to Mexico following 2 or 3 armed robberies. Ray spoke of Campeche Bay near Yucatan Penninsula; spoke of living with peasants in 3-room shack near Campeche; spoke of Torreon or Torrejon

Ray was frugal.

Ray did not like Negroes in general.

Once referred to King as " Martin Luther Coon," but had no particular feeling toward King. Ray read enthusiastically, especially weekly news magazines, and would outspokenly react to H. Rap Brown and Stokely Carmichael, as well as to some publicity King received.

Lillibridge does not know of bounty on King. Ray may have speculated that money would be available for deaths of Brown or Carmichael. Ray told about getting into a fight with a Negro on a prison work crew.

Ray was hypochondriac, taking 6 or 7 pills/day. Ray believed to have been selling amphetamines.

Ray spoke of smuggling appliances into Mexico through Campeche Bay from Brownsville, Texas, on boats. Ray often mentioned Mateo Lopez Garcia as

Mateo Garcia Lopez as running a small smuggling operation, as living near Campeche, and as speaking English.

Ray not known to speak Spanish.

Ray mentioned a brother in St. Louis. Either the brother or a person who participated with Ray in some robberies accompanied Ray on some Mexico trips.

Ray had been to Mexico City, regarded it as tourish trap, said he could not afford to stay there.

Ray's only reference to prior jobs was as bartender, possibly in Peoria, Illinois, or some other southern Illinois town. Ray never mentioned Oregon or Canada.

Ray never mentioned escape plans.

Ray mentioned "fire dance" by Negro boys in Acapulco.

Ray once had Kenny Hurt or Hurtt send a money order in order to hide some money he had received from illegal prison activities. Sent to Stationery in St. Louis.

Sero said the conversation was pure speculation.

Sero described Ray as a "hayseed," "a born loser." Said Ray had never gotten away with a criminal offense. Seems to recall Ray disliked Negroes. Would not describe Ray as a loner but as unable to make friends or mix socially. Ray was regular user of amphetamines in prison. Said Ray had great need for recognition and idolizes notorious criminals. Sero says it is believable that Ray might have

killed King without pay.

Said Ray has no important criminal connections; Ray never spoke of family; Ray once indicated he had friends in Kansas City, Missouri.

Sero has not heard from Ray since he left MSP.

Ray operated a magazine-rental service for which he received money or cigarettes. Ray not known to be drug user or to have abnormal sex problems.

Turner does not believe, Ray would kill Negroes and does not believe he

killed King. Turner said the first published sketch of assassin looked more like Aeby than Ray.

Ray was seen associating, with Neal Aeby, a cellmate of Frank Joseph Guinan. Aeby was type to kill Negroes. Aeby had disease. Turner once recommended harsh punishment for Aeby; Ray may have resented harsh recommendation. On day of Ray's escape, J.C. Fletcher, an inmate, reported to Turner that there had been an escape.

Black Muslims is only "hate" group in prison.

Turner could not recall seeing Ray with Jimmy Carpenter, does not recall Raymond Lewis Curtis.

Jimmy Bradley may have known Ray. Bradley was successful in prison rackets.

Turner had not heard of King bounty.
