On a Sunday afternoon, 1 or 2 weeks prior to St. Patrick's Day, a small white car drove up, driven by Charles Stein and unknown w/m with dark hair. Stein had carbboard box for Marian and came in.

Unknown man did not get out; said he wanted to shower. Stein then left. Has not seen him since.

When left, met Galt who said little. Had what looked like surveyor's transit in a leather case with a zipper in back of car. Above gave them a map of directions of how to get out of N.O. Says 1960 photo of Ray did not resemble Galt. Stein formerly married to "queen of vice" of French Quarter in 1962 and 1963.

Stein told her that Marie "Minnie" Martin, a cousin in Calif., had heard a man say he was going to New Orleans on business and that Marie asked him if he would take Stein with him. Stein told her that he came with this man in his automobile but did not know or work with him.

Mrs. Olonzo did not see the man. Stein made and received no calls while at her residence since she has no phone. After 1 or 2 days, Stein, Rita Stein's 2 children, and the man left for Calif. she has not heard from Stein since.

Galt purchased a tire in El Paso. On trip Galt said he'd been in Army. Galt said Wallace didn't want to be President, just on ballot and that Stein didn't have to vote for him.

Recalls Galt spoke to man at

registration place. Galt paid most trip expenses; had 2 or 2 \$20 bills.

Saw Galt in bar at St. Francis 1 or 2 weeks after return; Galt said he was in bartending school.

Galt said he bought car second hand from friend; had Mexican insurance.

Galt mentioned names of streets and places in New Orleans.

Car went off road in snow storm on return trip.

Galt said he had to contact engineering or contracting firm in Chalmet suburb; mentioned names "Jackson Barracks."

Galt told Stein that Galt had seen Stein while Galt⁴ was in bar in New Orleans. Could only have been on Canal St.
