No. 75-1996, the ticklers of the former Civil Rights Section (CRS), GID, concerning the MURKIN investigation were to be processed for release to plaintiff. These ticklers, which were on loan at that time from CRS to the former Congressional Inquiry Unit (organized in order to respond to requests from the House Select Committee on
