ARNOLD RAY GODFREY, AKA RAY GODFREY, INTERVIEWED AND DENIED ALL KNOWLEDGE OF ANY ASSASSINATION PLOT REGARDING MARTIN LUTHER KING, JR., WAS NOT FAMILIAR WITH NAMES CLAUDE AND LEON POWELL, BUT AFTER OBSERVING THEIR PICTURES KNEW THEM TO BE FREQUENT VISITORS TO PETE'S PLACE. GODFREY ADVISED HE WAS EMPLOYED AS A BARTENDER AT PETE'S PLACE. HE DID NOT TALK WITH EITHER OF THE POWELLS REGARDING THE ASSASSINATION OF MARTIN LUTHER KING, JR., NOR DID HE INTRODUCE ANYONE TO THEM REGARDING THE ASSASSINATION OF MARTIN LUTHER KING, JR. WHEN QUESTIONED ABOUT WELL-DRESSED INDIVIDUALS FREQUENTING PETE'S PLACE, GODFREY VOLUNTEERED THAT A WHITE MALE IN HIS FORTIES, APPROXIMATELY FIVE FEET ELEVEN INCHES TALL, ONE HUNDRED SEVENTY TO ONE HUNDRED EIGHTY POUNDS WITH DARK WAVY HAIR, FURTHER DESCRIBED AS WELL-GROOMED AND WELL-SPOKEN, A SWARTHY COMPLEXION, POSSIBLY OF CUBAN DESCENT DID

WENDELL SUTTON POWELL, FOREMAN, PHARR YARNS, INTERVIEWED AT HIS HOME, 218 EWING DRIVE, BELMONT, N. C., ADVISED HIS CORRESPONDENCE WITH HIS BROTHER CLAUDE POWELL, JR., IS VERY POOR WITH ONLY AN OCCASIONAL TELEPHONE CALL. HE LAST SAW CLAUDE THREE YEARS AGO WHEN THEIR MOTHER, HEPSIE POWELL, WAS VERY ILL IN TOCCOA, GEORGIA. WENDELL RELATED HE HAD NOT HEARD OF ANYONE CONTACTING HIS BROTHERS CLAUDE AND LEON AND OFFERING THEM MONEY TO ASSASSINATE MARTIN LUTHER KING, AND ADVISED IF CLAUDE HAD SEEN \$25,000 IN ONE LUMP SUM, CLAUDE WOULD HAVE TOLD OTHERS ABOUT IT. HE SAID CLAUDE USED TO DRINK A LOT AND TALK GLIBLY WHEN IN A DRUNKEN CONDITION UNTIL A DOCTOR TOLD HIM TO RESTRICT HIS INTAKE OF ALCOHOL FOLLOWING AN ACCIDENT,

POWELL SAID HE DID NOT BELIEVE CLAUDE AND LEON HAD THE

CAPACITY TO ASSASSINATE KING. CLAUDE GOT NICKNAME "SHOTGUN" SEVERAL YEARS AGO WHEN A SHOTGUN WAS TAKEN FROM HIM BY A POLICEMAN AFTER CLAUDE WAS STOPPED FOR DRIVING WHILE INTOXICATED. WENDELL SAID NEITHER HE NOR MEMBERS OF HIS FAMILY LIKED KING. WENDELL SAID KING STIRRED UP TROUBLE WHEREVER HE WENT AND HE AND MEMBERS OF HIS FAMILY DID NOT BELIEVE IN TROUBLE. WENDELL BELIEVED KING BECAME A MARTYR TO HIS PEOPLE BY BEING ASSASSINATED WHICH MIGHT NOT HAVE OCCURRED HAD HE LIVED. WENDELL STATED IN ADDITION TO BEING INCARCERATED BY THE N. C. PRISON AUTHORITIES, HE HAD SERVED TIME AS A JUVENILE AT BOYS TOWN OF GEORGIA LOCATED BETWEEN ATHENS AND MACON, GA. WENDELL SAID NEITHER HE NOR MEMBERS OF HIS FAMILY KNOW ANYTHING ABOUT JAMES EARL RAY OTHER THAN WHAT THEY HAVE READ IN NEWSPAPERS, TO HIS KNOWLEDGE. NO MEMBERS OF HIS FAMILY ARE KNOWN TO BE PRESENT OR FORMER MEMBERS OF THE KU KLUX KLAN OR OTHER EXTREMIST ORGANIZATIONS.

WENDELL POWELL SAID HE HAS THREE BROTHERS, CLAUDE JR., LEON, AND EDWARD, WHO RESIDED IN ATLANTA, GA., HE BELIEVED, PLACE NOT KNOWN, AND ONE SISTER, FLOYCE BRYSON (WIFE OF JOHN

ERYSON), FRANKLIN, N. C., AND A MOTHER HEPSIE AND A BROTHER HUBERT, WHO LIVE SIDE BY SIDE IN TACCOA, GA.

NOTE: This case pertains to the shooting death of Dr. Martin Luther King, Jr., on 4/4/68.

Pursuant to a Departmental request, we have instituted investigation to resolve an allegation by Leon Owen Powell that he and his brother, Claude Powell, were offered payment in 1967 to murder Dr. King. Leon Owen Powell claimed Ray Godfrey initially approached him re this payment. Claude Powell has also been interviewed and also states offered to kill Dr. King made; however, Claude Powell's account differs in many respects to that of Leon Owen Powell.

On 1/9/76, Departmental Attorney Robert A. Murphy, Chief, Criminal Section, Civil Rights Division, requested the above additional investigation.

He stated no actual polygraph examination should be afforded until this matter further considered by Department; however, he desires to know whether Godfrey and Claude Powell would submit to polygraphs. (Leon Owen Powell has already indicated he will submit to a polygraph.)

ALTHOUGH MOTEL PERSONNEL AND RECORDS FAILED TO LOCATE REGISTRATION FOR CLAUDE POWELL, JR., INVESTIGATION MIDLAND, TEXAS, JANUARY 8, 1976, DETERMINED SEVERAL CONSTRUCTION WORKERS FROM GEORGIA RESIDING VARIOUS ROOMS SCOTTISH INN MOTEL. INQUIRY WITH FORMEN AND MEMBERS OF CONSTRUCTION CREW UPON THEIR RETURN TO MOTEL LATE EVENING JANUARY 8, 1976, DETERMINED POWELL RESIDING ROOM 211 SINCE JANUARY 4, 1976 WITH THREE OTHER CONSTRUCTION WORKERS.

CLAUDE POWELL, JR. INTERVIEWED EVENING JANUARY 8, 1976. AT OUTSET OF INTERVIEW POWELL DENIED HAVING CONTACT WITH ANY MEMBER OF HIS FAMILY OR IN PARTICULAR HIS BROTHER LEON POWELL SINCE DEPARTING FROM ATLANTA, GEORGIA, DECEMBER 31, 1975, WHEN

QUESTIONED IF HE HAD EVER BEEN OFFER A LARGE SUM OF MONEY TO COMMIT A MURDER HE IMMEDIATELY VOLUNTEERED THAT HE HAD IN FACT BEEN OFFERED \$25,000 SHORTLY BEFORE THE ACTUAL ASSASSINATION OF MARTIN LUTHER KING JR. TO MURDER MARTIN LUTHER KING JR.. HE RELATED THE FOLLOWING:

THREE OR FOUR WEEKS PRIOR TO THE MURDER OF MARTIN LUTHER KING HE AND HIS BROTHER LEON WERE SEATED IN A BOOTH IN PETE'S BAR ON MORELAND AVENUE, IN ATLANTA. HE RECALLED THAT A FRIEND OF HIS BROTHER, RAY GODFREY, A MUSICIAN AND AN ATLANTA CITY EMPLOYEE JOINED THEM IN THEIR BOOTH AND ENGAGED IN CONVERSATION WITH LEON. HE PAID NO PARTICULAR ATTENTION TO WHAT THEY WERE TALKING ABOUT. GODFREY LEFT THE BOOTH AND, IN APPROXIMATELY TEN TO FIFTEEN MINUTES, AN INDIVIDUAL PREVIOUSLY UNKNOWN TO HIM CAME TO THEIR BOOTH AND SEATED HIMSELF OPPOSITE FROM HE AND LEON. HE RECALLED THIS INDIVIDUAL AS BEING A WHITE MALE, APPROXIMATELY 5'8" IN HEIGHT, MEDIUM BUILD, APPROXIMATELY 150 POUNDS, EARLY 30'S, WELL DRESSED, CALM AND COLD IN MANNER AND VERY CLEAN CUT. AS THE PERSON SET DOWN HE PLACED AN EXPENSIVE LOOKING BLACK BRIEFCASE ON THE TABLE. THIS INDIVIDUAL APPEARED TO BE OUT OF PLACE IN SUCH AN ESTABLISHMENT

IN VIEW OF HIS DRESS AND HE IMPRESSED POWELL AS BEING A WELL EDUCATED PERSON WHO APPEAR TO BE A PROFESSIONAL TYPE, SUCH AS A LAWYER. HE MAY HAVE INTRODUCED HIMSELF BUT HE DOES NOT REMEMBER A NAME.

THE UNKNOWN PERSON ASKED HE AND LEON IF THEY WANTED TO PULL A JOB. HE DOES NOT REMEMBER THE EXACT CONVERSATION BUT HE QUESTIONED THE UNKNOWN PERSON CONCERNING THE NATURE OF THE JOB AND HOW MUCH MONEY IT PAID. THE UNKNOWN PERSON TOLD THEM THAT HE WANTED THEM TO DO AWAY WITH SOMEONE AND WHEN QUESTIONED FURTHER SAID IT WAS SOMEONE IMPORTANT. THE UNKNOWN PERSON THEN TOLD THEM HE WANTED THEM TO KILL MARTIN LUTHER KING AND WOULD PAY \$25,000 NOW AND \$25,000 WHEN THE JOB WAS DONE. THE UNKNOWN PERSON THEN OPENED HIS BRIEFCASE WHICH WAS FULL OF WRAPPED CURRENCY, SOME OF WHICH WERE IN \$100 DENOMINATION. HE STATED THAT HE WAS SHOCKED AND INITIALLY ASSUMED THAT IT WAS SOME SORT OF JOKE OR POSSIBLY A LAW ENFORCEMENT OFFICER TRYING TO

TRICK HIM. AFTER THE UNKNOWN PERSON MADE THE OFFER HE IGNORED ANY FURTHER CONVERSATION WHERE UPON THE UNKNOWN PERSON CLOSED HIS BRIEFCASE AND DEPARTED.

HE SAID HE FREQUENTLY LOANED HIS SHOTGUN TO THE BARTENDER AT PETE'S WHEN TROUBLE OCCURRED AT THE BAR. HE DENIED EVER RECEIVING SUCH AN OFFER PRIOR TO THIS INCIDENT AND FURTHER DENIED ANY AFFILIATION WITH A WHITE HATE GROUP. HE ADMITTED THAT HE HAD MADE STATEMENTS, WHILE DRUNK, TO THE EFFECT THAT HE HAD NO AVERSION TO KILLING BLACKS ALTHOUGH HE HAD NEVER SERIOUSLY CONSIDERED DOING SO.

HE MENTIONED THAT HE WAS SHOCKED AND DISMAYED TO LEARN APPROXIMATELY THREE TO FOUR WEEKS LATER THAT MARTIN LUTHER KING HAD BEEN MURDERED. HE SAID HE DID NOT GO TO LAW ENFORCEMENT OFFICERS AND TELL THEM OF HIS CONTACT WITH THE UNKNOWN PERSON BECAUSE HE FELT HE MIGHT BECOME A SUSPECT IN THE MURDER OF MARTIN LUTHER KING.

PURPOSE: To advise of the institution of investigation to resolve an allegation by Leon Owen Powell that he and his brother were offered payment in 1967 to murder Dr. Martin Luther King, Jr.

BACKGROUND: This case pertains to the shooting death of Dr. Martin Luther King, Jr., on 4/4/68. James Earl Ray pled guilty to this murder and presently is in local confinement.

By teletype dated 1/5/76, our Atlanta Office advised of information furnished by one Leon Owen Powell who, in essence, claims he and his brother, Claude Powell, Jr., while in an Atlanta bar in October - November, 1967, were approached by a mutual friend, Ray Godfrey, who asked the Powells if they were interested in making \$50,000. Godfrey told them he would put them in contact with an individual who would pay them to murder King. Approximately one week later at the same bar, the Powells were approached by an individual named Ralph (Last name unknown), who said "I guess you know why I'm here" and subsequently opened his briefcase displaying what he said was \$25,000. Powell said they told Ralph they needed time to think it over. Ralph replied "if your mind is not made up now, I can't do business with you." Powell said Ralph never said the money being offered was to kill King. Powell states neither he nor his brother were involved in murder of King.

Leon Owen Powell also stated that the only other individuals aware of this meeting with Ralph (LNU) were his former wife, Annie Lois Compos and Pete Davis, owner of the bar. He stated Compos had no first-hand knowledge, and she is aware of the facts as he described them to her.

Davis observed Ralph (LNU) enter and exit the bar but had not entered into the conversation. Leon Owen Powell stated the reason he believes he and his brother were contacted by Godfrey is because his brother "Shotgun" served 5 years for armed robbery and had a reputation for being an expert with a shotgun. Leon Owen Powell stated he is willing to take a polygraph in this matter.

DETAILS: On 1/6/76, this matter discussed with Mr. Robert A. Murphy, Chief, Criminal Section, Civil Rights Division (CRD), U. S. Department of Justice and he requested immediate investigation to resolve this allegation. Mr. Murphy requested the following investigation:

Interview Claude Powell, Compos and Davis for any information they have re this allegation by Leon Owen Powell; obtain artist's conception of Ralph (LNU) from Leon Owen Powell; determine present whereabouts, including residence and employment of Godfrey - CRD stated Godfrey should not be interviewed at this time; determine all places where Claude Powell incarcerated to determine if he ever was incarcerated with James Earl Ray and handle any additional obvious and logical leads developed, such as the interview of any additional witnesses developed during interview. CRD will make a determination whether Leon Owen Powell should be given a polygraph examination upon the completion of the above investigation. This request from Mr. Murphy has been confirmed in writing.

Atlanta has been advised by separate communication to conduct this investigation immediately.

ON JANUARY 4, 1976, LEON OWEN POWELL, WHITE MALE, CONTACTED ATLANTA OFFICE OF THE FBI ADVISING HE HAD INFORMATION CONCERNING THE SUBJECT MATTER.

DURING PERSONAL INTERVIEW WITH POWELL, HE ADVISED THAT DURING LATE OCTOBER OR EARLY NOVEMBER, 1967, DATE UNKNOWN, DURING THE LATER AFTERNOON HOURS, HE AND HIS BROTHER, CLAUDE POWELL, JR., AKA "SHOTGUN POWELL", A WHITE MALE, WERE HAVING A DRINK IN PETE'S BAR AT MORELAND AND CONFEDERATE AVENUES, ATLANTA, GEORGIA, WHEN THEY WERE APPROACHED BY MUTUAL FRIEND RAY GODREY, A WHITE MALE, APPROXIMATELY FORTY YEARS OF AGE, SIX FEET ONE INCH, TWO HUNDRED TWENTY POUNDS, COUNTRY AND WESTERN SINGER, EMPLOYEE OF THE ATLANTA SANITATION DEPARTMENT, WHO ASKED IF THEY WOULD BE INTERESTED IN MAKING \$50,000. DURING THE POWELL BROTHERS CONVERSATION WITH GODREY, IT WAS DETERMINED THAT GODREY WOULD PUT

APPROXIMATELY ONE WEEK AFTER THE MEETING WITH GODFREY, THE POWELL BROTHERS WERE AGAIN DRINKING IN PETE'S BAR, EXACT DATE UNKNOWN, AT APPROXIMATELY FOUR OR FIVE PM, WHEN THEY WERE APPROACHED BY AN INDIVIDUAL NAMED RALPH (LNU), WHITE MALE, HEAVY-SET, SIX FOOT ONE INCH TO TWO INCH, NO ACCENT, WELL-SHOODED, LATE FORTIES, WELL-SPOKEN, DESCRIBED AS "LAWYER-TYPE", WHO WAS IN POSSESSION OF A BRIEFCASE. RALPH (LNU) APPROACHED THE POWELL BROTHERS, PUT HIS BRIEFCASE ON THE TABLE AND SAID, "I GUESS YOU KNOW WHY I'M HERE". HE HAS NOT BEEN IN CONTACT WITH RAY GODSEY IN APPROXIMATELY SEVEN YEARS AND DOES NOT KNOW GODSEY'S LOCATION. THE ONLY OTHER INDIVIDUALS AWARE OF HE AND HIS BROTHER'S MEETINGS WITH RALPH (LNU) ARE HIS FORMER WIFE, ANNIE LOIS COMPOS, WHITE FEMALE OF ATLANTA AND PETE DAVIS, WHITE MALE, OWNER OF THE BAR WHERE HE AND HIS BROTHER TALKED WITH RALPH (LNU).

HIS WIFE HAS NO FIRST-HAND KNOWLEDGE OF THE MATTER, SHE IS AWARE OF THE FACTS AS HE DESCRIBED THEM TO HER.

PETE DAVIS ACTUALLY OBSERVED RALPH (LNU) ENTER AND EXIT HIS BAR, BUT NEVER ENTERED THE CONVERSATION BETWEEN RALPH (LNU) AND THEMSELVES.

NEITHER HE NOR HIS BROTHER WERE INVOLVED IN THE KILLING OF MARTIN LUTHER KING, JR. BECAUSE THE WHOLE SITUATION, AS DESCRIBED ABOVE, "SCARED US". HE IS WILLING TO TAKE A POLYGRAPH IN THIS

POWELL STATED HIS BROTHER, AT THAT TIME, CONSTANTLY CARRIED A SHOTGUN BECAUSE, "HE HAS AN INFERIORITY COMPLEX".
