The following action was taken by Extra-Duty Supervisor Hunter E. Helgeson on 6-2-68, regarding location by Canadian authorities of a passport issued to Ramon George Sneyd:

Legal Attache John Minnich, London, England, was telephonically contacted. He advised that there would be no record maintained on an individual entering England or any of the Commonwealth under Canadian passport. He pointed out that if a person arrived on a plane from Canada at London, he would merely present his passport to Immigration officials who would stamp the passport but no record would be made of the person's entry.

Minnich stated there were several avenues of investigation possible in London which are: (1) check of British Overseas Airlines Company (BOAC) passenger manifests to determine if a person by the name of Sneyd was on an incoming flight. In this connection, he noted that this is a holiday weekend in England and that Monday, 6-3-68, is a holiday, similar to our Labor Day, and he doubted if such a check of BOAC records could be undertaken before 6-4-68; however, he would explore the possibility on 6-3-68. (2) Circularize the name of Ramon George Sneyd through the Hotel Security Officers Association to determine if Sneyd was registered in a London hotel. He pointed out that there was no guarantee that such circularization would not be leaked to the press. (3) Circularization through the Metropolitan Police Gazette which is a periodical sent to all police agencies in the United Kingdom. Here again while the Gazette is supposedly restricted to police agencies, information contained therein very often comes to the attention of the press. (4) Arrange for widespread publicity through news media of subject's photograph and descriptive data.

Minnich was instructed that at this point all investigation should be handled in a discreet fashion and that he should take no action concerning circularization through the Hotel Security Officers Association or the Metropolitan Police Gazette and no publicity to news media unless specifically authorized by the Bureau. He was instructed to have a check of BOAC records instituted as soon as possible.

In connection with past information indicating Ray might desire to travel to Rhodesia, Minnich advised that all British are banned from travel to Rhodesia and, therefore, he would have extreme difficulty using a Canadian passport to leave London for Rhodesia but he did point out that a person could fly from London to some point on the continent and from there travel to Rhodesia.

Legal Attache Moss Innes, Ottawa, Canada, advised at 1:45 p.m., 6-2-68, that Royal Canadian Mounted Police (RCMP) had reported no new developments to him and that if he did not hear from them by 5:00 p.m., he would call them and thereafter call the Bureau bringing the Canadian investigation up to date. He pointed out that RCMP is checking regarding whether or not there was a legitimate birth certificate filed for Sneyd. In connection with the handwriting examination being done by RCMP, he said a comparison was being made with the signature on the lease executed by Galt in Montreal. RCMP is also checking to determine what records BOAC maintains in Canada concerning London passengers. Innes was advised that an FBI Identification Record was located for one Paul Osborn Bridgeman, FBI number 352 520 C, indicating Bridgeman had been finger-printed by the Department of Correction, Jefferson City, Missouri, on 4-23-65, and could very well have been confined to the Missouri State Penitentiary at the time Ray was confined there.

Innes will attempt to get passport application and photograph of Sneyd in the mail to the Bureau 6-3-68.

Innes was instructed that all investigation in Canada regarding this matter should be handled in a discreet fashion.

ASAC Cliff Halter, Memphis Office, was telephonically advised of the developments concerning the Canadian passport issued to Sneyd. SAC Robert Jensen, Memphis Office, subsequently called and suggested that Legat, Ottawa be requested to have laundries in the vicinity of the Chinese rooming house checked to determine if photographs of Ray could be identified by them. SAC Jensen also suggested that as soon as photographs of Sneyd are obtained from Legat, Ottawa, copies should be sent to St. Louis and Chicago to be shown to Ray's relatives.



Mrs. Homer Lane Bigelow has advised our Denver Office that about a year ago she fell in love with and cohabitated with one Robert Edward Byrne, a Denver oil promoter who claims to be involved in a conspiracy to kill Martin Luther King, Jr. She said she would not have furnished this information except Byrne, who is a heavy drinker, recently told her he was going to marry another woman.

In about October of 1967, Bryne began telling her he was in some type of organized crime syndicate but never was specific as to members or activities. He claimed to have killed many men, but she was never sure that the killings were while he was in the Armed Forces or in connection with a syndicate.

Byrne spent a lot of time out of town and on 5/14/68, he was at her place and was "very drunk." Before they retired for the evening, she told him she was scared and asked him if he had a hand in King's death. He replied "What do you think? Of course." . She then asked Byrne if James Earl Ray did the shooting and he replied asking her what made her think Ray did it. She indicated that Ray was probably dead and Byrne said he was not.

On 5/22/68, James Hyer, who had been representing Byrne in court matter involving the adoption of his children by Byrne's ex-wife and her present husband, telephoned Mrs. Bigelow and asked her to locate Byrne as it was an emergency. She was to tell Byrne the following message: "Emergency Tea Cup" and Byrne would know what it meant. Later on Byrne called at which time-she gave him the message and he had her repeat it three times, swore and commented "I wonder if mine will be as big as the other." This message frightened her and she has not heard or seen from him since.

Although the information as related by Mrs. Bigelow appears to be rambling and highly imaginative and she appears to be the victim of a love affair, we are attempting to locate and interview Byrne to completely determine the veracity of the facts as related.

Our Dallas Office advised that a potential criminal informant of their office had been in contact with a former gambler, whose identity the informant would not disclose, who had just returned from Monterrey, Mexico. According to the informant this gambler made the statement that James Earl Ray is currently working as a bartender in a bar located near the Chevrolet dealership near Monterrey, Mexico. Legat, Mexico City has advised that their investigative informant has checked the only bar closely fitting the description in this allegation. It is the bar known as "El Rancho" located about thirty yards from the Chevrolet dealership in Monterrey, Mexico. investigative informant completed a canvass of management personnel and employees of the bar and determined that there are no North Americans employed there in any capacity and no employee resembling description of photograph of subject. Investigation is continuing in nearby restaurants where bar service is available and this is being afforded most expeditious attention.

A person by the name of Eduardo Jose Molina contacted our Brownsville, Texas, Resident Agency and advised that he had received information that about four days ago James Earl Ray was working in a kitchen of a hotel located on Isla Mujeres, off the coast of the State of Quintana Roo, Mexico. Molina who is apparently a mature, intelligent person and who owns property in Brownsville, Texas, gave his permanent address as Yucatan, Mexico. His source of information is the son of the man who owns the hotel. This is presently being checked out.

The Taipel, Taiwan, newspaper is carrying a story of the possibility of James Earl Ray en route to Taiwan. Although there is no apparent basis for this allegation and it appears that Korea National Police, Seoul, Korea, gave a press release asking all to be alert for subject in event he travels to Korea, this matter is being checked out.

ACTION: We are affording this case top priority attention.

Although the information as related by Mrs. Bigelow appears to be rambling and highly imaginative and she appears to be the victim of a love affair, we are attempting to locate and interview Byrne to completely determine the veracity of the facts as related.

Our Dallas Office advised that a potential criminal informant of their office had been in contact with a former gambler, whose identity the informant would not disclose, who had just returned from Monterrey, Mexico. According to the informant this gambler made the statement that James Earl Ray is currently working as a bartender in a bar located near the Chevrolet dealership near Monterrey, Mexico. Legat, Mexico City has advised that their investigative informant has checked the only bar closely fitting the description in this allegation. It is the bar known as "El Rancho" located about thirty yards from the Chevrolet dealership in Monterrey, Mexico. investigative informant completed a canvass of management personnel and employees of the bar and determined that there are no North Americans employed there in any capacity and no employee resembling description of photograph of subject. Investigation is continuing in nearby restaurants where bar service is available and this is being afforded most expeditious attention.

A person by the name of Eduardo Jose Molina contacted our Brownsville, Texas, Resident Agency and advised that he had received information that about four days ago James Earl Ray was working in a kitchen of a hotel located on Isla Mujeres, off the coast of the State of Quintana Roo, Mexico. Molina who is apparently a mature, intelligent person and who owns property in Brownsville, Texas, gave his permanent address as Yucatan, Mexico. His source of information is the son of the man who owns the hotel. This is presently being checked out.

The Taipel, Taiwan, newspaper is carrying a story of the possibility of James Earl Ray en route to Taiwan. Although there is no apparent basis for this allegation and it appears that Korea National Police, Seoul, Korea, gave a press release asking all to be alert for subject in event he travels to Korea, this matter is being checked out.

ACTION: We are affording this case top priority attention.

ASAC Stefansson was instructed to ascertain specifically what type of film was used, that is make and size and also ascertain whether or not mechanical equipment could be rented locally to review such film. If such can be handled, he is to advise the Bureau of the approximate cost. If such equipment cannot be obtained locally, he is to advise the Bureau so that a check may be made nationally to determine whether or not appropriate machines are available to visually review negatives.

ASAC Karl Stefansson of the San Antonio Office telephonically advised that one Eduardo Jose Molina had contacted the Brownsville, Texas, Resident Agency today and advised that he had received information that James Ray was four days ago working in the kitchen of the Sadzil Ha Hotel, located on Isla Mujeres, off the coast of the State of Quintana Roo, Mexico.

Molina is in Brownsville, Texas, checking on some property and will be there several days. His permanent address is Avenida 505C, Merida, Yucatan, Mexico, and he will return to that address when his business in Brownsville, Texas, is completed.

Molina advised that the Sadzil Ha Hotel which is located about twenty minutes by air from Merida is owned and operated by a man named Lima, who he feels will not cooperate with the FBL. He identified Lima's son as being the source of the information regarding Ray working at the Sadzil Ha Hotel.

Stephansson described Molina as being 65 years of age, sensible and knowledgeable, and reportedly a graduate of Boston College.

SAC Gordon Shanklin of the Dalias Office also telephonically advised that a potential criminal informant of the office had been in contact with a small time gambler, whose identity the potential criminal informant would not disclose, who had just returned from Monterrey, Mexico. According to the potential criminal informant this gambler made the statement that James Ray is currently working as a bartender in a bar located near the Chevrolet dealer in Monterrey.

ACTION:

The above information was telephonically furnished to Legat Nathan Ferris at Mexico City for immediate handling. Ferris stated the leads would be afforded top priority investigative attention.

An individual by the name of Rex Basinger, Denver, Colorado, advised our Denver Office he received a telephone call on two separate occasions from a friend, Edgar Eugene Bradley. According to Basinger, he and Bradley formerly lived in Ruby, Arkansas, attended school in Alma, Arkansas, but Basinger lost track of Bradley when Bradley went into the United States Navy in 1933. He subsequently saw Bradley in Dallas, Texas, in 1963.

According to Basinger, Bradley called him on 5-17-68, from Tulsa, Oklahoma, and stated that he had Eric Galt with him. Basinger did not know who Galt was and Bradley told him he was also known as James Ray. Basinger related to Bradley that he did not know Ray and Bradley stated that Ray was the man who killed Martin Luther King, Jr. Bradley claims to have lived with Ray for about one week in Tulsa, Oklahoma.

Basinger continued to state that Bradley called him again on 5-23-68, and stated that he was at the Old South Restaurant, Fort Smith, Arkansas, and was working his way West. Bradley claimed he was eating his meals at the Old South Restaurant which is operated by Basinger's cousin, Elba Basinger Thompson. Basinger stated that Bradley was allegedly under subpoena by District Attorney James Garrison, New Orleans, Louisiana, in connection with the assassination of President Kennedy.

Mr. and Mrs. Leon Thompson, operators of the Old South Restaurant, Fort Smith, Arkansas, were interviewed and they advised that Bradley is unknown to them and they could not identify a photograph of James Earl Ray. Relatives of Basinger advised that Basinger is a mental case, tends to associate himself with criminal cases of national

prominence and he was last in Fort Smith, Arkansas, about three years ago at which time he claimed he had been in a cell with Jack Ruby in Dallas, Texas. Investigation revealed this was a false statement and a doctor at Parkland Hospital, Dallas, examined Basinger and found probable psychosis and possible brain syndrome.

Relatives of Edgar Eugene Bradley were interviewed at Fort Smith, Arkansas, and they advised that Bradley currently resides at North Hollywood, California, and is presently employed as West Coast radio representative of Carl McIntyre, an evangelist. Relatives advised that Bradley was definitely not in Tulsa, Oklahoma, or Fort Smith, Arkansas, as alleged, and an uncle of Bradley's talked to him on 5-23-68, as Bradley was calling from North Hollywood, California. The relatives also advised that Bradley has been charged by James Garrison with conspiracy in the assassination of President Kennedy and is due to have extradition hearing before Governor Reagan of California on June 5 and 6, 1968.

We are presently conducting investigation to determine the whereabouts of Bradley on 5-17-68, and 5-23-68, and we will ascertain if he has any information concerning James Earl Ray.

Circuit Judge John C. Casey, St. Louis, Missouri, previously advised our St. Louis Office he sentenced James Earl Ray to 20 years in a penitentiary for armed robbery in 1959. Ray was serving this sentence when he escaped from Missouri State Penitentiary in April, 1967. Judge Casey also previously advised a motion to set aside this conviction was filed before Ray's escape and is still pending. He believes in view of recent Supreme Court decisions, Ray would stand a good chance of reversing his conviction and he contemplated filing an order on 5-24-68, or his action will be dismissed. Judge Casey asked the FBI for advice as to whether he should delay this matter as he feels publicity of the order would cause wide-spread disorder. Judge Casey was told that the FBI cannot advise him as to what course of action to take; but that if he feels publicizing the order would cause disturbances, he should take necessary steps to alert law enforcement agencies after the order is entered and before it is publicized.

Hearing on this motion did not develop in the manner anticipated by Judge Casey. The attorney for Ray stated in open court he had been appointed subsequent to escape and has never seen or been contacted by Ray. The attorney objected to attempted state introduction of escape notation on Missouri State Penitentiary record as insufficient evidence of escape. The attorney took the position that the appearance of Ray unnecessary on motion to vacate as same based solely on record which is available. Judge Casey has taken this matter under advisement and no publicity developed.

ACTION: The investigation is being afforded top priority.

On May 8, 1968, the body of an unknown deceased was found partially buried in a grave near Mahanoy City, Pennsylvania. A powder believed to be lime was also in the grave. The body was clothed only in shorts and an undershirt. The examining pathologist found three bullet holes in the chest cavity, body was in advanced state of decay, and pathologist stated in his opinion the body had been in the grave for six months.

On May 17, 1968, Dr. Wilton M. Krogman archeologist, University of Pennsylvania, examined the body and stated that in his opinion the body had been in the grave only from four to six weeks and is of the opinion that the body is that of a middle-aged white male, five feet nine inches to six feet one inch in height, muscular build, weighing about 200 pounds, and descendant of Northern Italy or Central Europe.

According to the examination, there is no possibility of fingerprints being obtained, teeth in the upper jaw are missing or dislodged, but teeth in the lower jaw are intact and contain several fillings. Certain remains of the body are presently in possession of Pennsylvania State Police, Reading, Pennsylvania.

Although there is no indication that this unknown body is that of subject James Earl Ray, a comparison of the dental charts of Ray with the remains of the deceased is presently being conducted by the Pennsylvania State authorities.

NOTE:

On 5-8-68, a body of an unknown deceased clothed only in shorts and an undershirt was found partially buried in a grave near Mahanoy City, Pennsylvania. A powder believed to be lime was also found in the grave. The examining pathologist found three bullet holes in chest cavity and body in advanced state of decay. No possibility of fingerprints being obtained and pathologist stated he is of opinion body had been in grave for six months.

On 5-17-68. Dr. Wilton M. Krogman, archeologist, University of Pennsylvania, examined the body and stated he is of the opinion body in grave only four to six weeks and is also of the opinion the body is that of a middleaged white male. five feet nine inches to six feet one inches in height, muscular build, 200 pounds, descendant of Northern Italy or Central Europe. The teeth in upper jaw missing or dislodged but teeth in lower jaw intact and contain several fillings. The lower jaw is in possession of Pennsylvania State Police who are retaining. Our Philadelphia Office suggested that the teeth of this unknown deceased be compared with dental record of James Earl Ray, the subject in the King assassination. Dental records as well as photographs of cavities of the skull concerning James Earl Ray, were obtained from the Missouri State Penitentiary and have been forwarded to our Philadelphia Office. Philadelphia has turned these records over to the Pennsylvania State Police and they are in the process of comparing these records with the remains of the unknown deceased. It is anticipated that it will take several days to complete the examination.

This letter is prepared in accordance with instructions of Mr. DeLoach, Assistant to the Director, as a result of his conference with the Attorney General on May 24, 1968. The Attorney General made inquiry concerning the unknown body recently recovered in Pennsylvania, and he was advised that the information would be forwarded to him.

Lester Packett's wife, Odela Packett, was interviewed in the Los Angeles County Jail and she stated that she filed for divorce from Packett two months ago on grounds of descrition, cruelty and nonsupport. She stated her legal fees were being paid by her relatives and she added that she was so mad at Packett at the time of the filing of the divorce that she tore up all of the photographs she had of him. She described him as a shiftless drifter who never held a job during their five years of marriage. She stated she does not know his present whereabouts.

Background information on Lester Fackett and interview with Odela Fackett indicates he has spent time in Belle Glade, Florida; Reno, Nevada; various locations in Tennessee; Chicago, Illinois; and Kansas City. These areas were mentioned in connection with the story furnished the Los Angeles "Times" by "Bob." Leamont Anderson White believes Fackett is the individual who took his two gens and is the only individual outside of Frank Brickley and a person whom he knew as Brickley's cousin whose name he could not recall that would have known he even possessed the guns.

John Eugene Gawron, the old man who lived with Ray's mother from 1954 until her death in 1961, previously advised he taught Fay to be a burglar. He previously stated that he and Ray cased a bank in 1958 or 1959 but did not rob it because Gawron injured his leg. Gawron furnished varying information regarding subject's alleged involvement in a bank robbery following his escape from the Missouri State Penitentiary on 4/23/67. After numerous efforts to elicit the truth from Cawron, he has now revealed that the bank allegedly robbed by Ray and an accomplice is located in Alton, Illinois. Gawron stated that Ray's accomplice in the bank robbery told him, Gawron, that his name was "Jimmy," last name unknown. Gawron stated that the last time he saw "Jimmy," last name unknown, and they visited him on the nights of 5/13 and 14/56. Ex-convicts John Faul Valenti and James H. Carpenter are known to have visited Gawron on those dates.

Eureau files show that at approximately 1p.m., 7/13/67, two unknown subjects wearing stocking masks entered the side door and robbed the Bank of Alton in Alton, Illinois. One subject proceeded directly

to the tellers' area, walked behind the counter, emptied cash from two tellers' cages and left the bank by the same route. Unknown subject number two stood outside the side door flourishing a sawed-off shotgun and covered the customers and employees until unknown subject number one left. Then he backed out of the bank. The robbers obtained \$27,230 in loot.

St. Louis City Jail records establish that James E. Carpenter was in City Jail, St. Louis, from 8/8/67 to 3/1/68 and could not, therefore, have participated in the bank robbery or have contacted Cawron as Cawron had claimed in 1967. Carpenter's description does not fit either of the unknown subjects; although Eay's description could approximate that of unknown subject number two.

Gawron led Agents to the above bank and identified it as the one he and Ray had cased in 1959. The modus operandi planned was substantially the same as that used in the actual bank robbery. Gawron stated that he had deliberately misled Agents as to the amount involved and the location of the bank to gain time to be sure he would be in the clear. Investigation of the bank robbery mentioned above is being intensified to ascertain whether Ray could have possibly been involved, thereby accounting for his source of funds.

ACTION:

Vigorous investigation is continuing in order to bring this matter to a prompt conclusion.

Leamont Anderson White believes Fackett is the individual who took his two guns and is the only individual outside of Frank Brickley and a person whom he know as Brickley's cousin whose name he could not recall that would have known he even possessed the guns.

John Eugene Gawron, the old man who lived with Eay's mother from 1954 until her death in 1961, previously advised he taught Eay to be a burglar. He previously stated that he and Eay cased a bank in 1968 or 1969 but did not rob it because Gawron injured his leg. Gawron furnished varying information regarding subject's alleged involvement in a bank vobbery following his escape from the Missouri State Penitentiary on 4/23/67. After numerous efforts to elicit the truth from Gawron, he has now revealed that the bank allegedly robbed by Eay and an accomplice is located in Alton, Illinois. Gawron stated that Bay's accomplice in the bank robbery told him, Gawron, that his name was "Jimmy," last name unknown. Gawron stated that the last time he saw "Jimmy" he was with a man previously unknown to him who was named "Johnny," last name unknown, and they visited him on the nights of 5/13 and 14/68. Ex-convicts John Paul Valenti and James E. Carpenter are known to have visited Gawron on those dates.

Bureau files show that at approximately 1:p.m.,7/13/67, two unknown subjects wearing stocking masks entered the side door and robbed the Bank of Alton in Alton, Illinois. One subject proceeded directly

to the tellers' area, walked behind the counter, emptied cash from two tellers' cages and left the bank by the same route. Unknown subject number two stood outside the side door flourishing a sawed-off shotgun and covered the customers and employees until unknown subject number one left. Then he backed out of the bank. The robbers obtained \$27,230 in loot.

St. Louis City Jail records establish that James E. Carpenter was in City Jail, St. Louis, from \$/5/67 to 3/1/68 and could not, therefore, have participated in the bank robbery or have contacted Gawron as Gawron had claimed in 1967. Carpenter's description does not fit either of the unknown subjects; although Ray's description could approximate that of unknown subject number two.

Gawron led Agents to the above bank and identified it as the one he and Ray had cased in 1989. The modus operandi planned was substantially the same as that used in the actual bank robbery. Gawron stated that he had deliberately misled Agents as to the amount involved and the location of the bank to gain time to be sure he would be in the clear. Investigation of the bank robbery mentioned above is being intensified to ascertain whether Ray could have possibly been involved, thereby accounting for his source of funds.

ACTION:

Vigorous investigation is continuing in order to bring this matter to a prompt conclusion.

Cecil Clayton Lillibridge, Cole County (Missouri) Jail, was a cellmate of May's at Missouri State Penitentiary and has previously furnished background information regarding May. Lillibridge has been reinterviewed and has advised as follows.

When they were cellmates, Lillibridge and Ray discussed a newspaper article concerning the escape of an Italian criminal from the United States to Italy through the use of a Canadian passport. Ray was aware that a Canadian passport may be readily obtained under a false identity. (This appears to be true and the Royal Canadian Mounted Police are checking all passports issued since Ray's escape from prison.)

Ray expressed more interest in hiding in Mexico than in Canada and did not seem impressed when Lillibridge suggested it would be easier for an American to blend into the scene in Canada. Ray said he had once considered Australia as a place to hide and sometime prior to 1962 had written to Queensland inquiring about employment opportunities but had lost interest in Australia because it is sparsely populated and there are few tourists.

Ray spoke to Lillibridge about changing the color of his eyes by wearing colored contact lenses. He also said he had experimented on darkening his skin with a walnut dye that had to wear off.

Lillibridge described hay as too tight to play poker but said he loaned money to poker players and required repayment of \$3 for every \$2 loaned.
